A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE AGREEMENT WITH SENATOR ANA RODRIGUEZ FOR THE LEASE OF OFFICE SPACE AT THE CITY OF KEY WEST CITY HALL LOCATED AT 1300 WHITE STREET, KEY WEST, FLORIDA, 33040; TO OPERATE AND MAINTAIN A DISTRICT OFFICE; WITH SAID LEASE HAVING A TERM OF THIRTY-SEVEN MONTHS COMMENCING ON OCTOBER 1, 2023 EXPIRING ON NOVEMBER 3, 2026; AUTHORIZING THE CITY MANAGER TO EXECUTE THE LEASE AGREEMENT ON BEHALF OF THE CITY WITH THE ADVICE AND CONSENT THE CITY ATTORNEY; **PROVIDING** IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On November 8, 2022, Ana Maria Rodriguez was elected by the voters to represent District 40 in the Florida State Senate, and her current term ends on November 3, 2026; and

WHEREAS, the members of the Florida Legislature are each provided with a small budget to operate an office in the district that they represent; and

WHEREAS, the City Commission finds that pursuant to Sec. 2-941(c), the best use of the vacant office on the first floor of City Hall would be utilized as a District Office for Senator Rodriguez and that the bidding process should be waived; and

WHEREAS, the City Manager finds that the lease is in the best interest of the City, residents and business owners to have Page 1 of 3

a District Office in City Hall and recommends waiver of the bidding process since this is a sole source use; and

WHEREAS, the City Commission finds that pursuant to Sec. 2-941(c), it is in the best financial interest of the residents and business owners to have a District Office in City Hall for convenience and accessibility; and

WHEREAS, the proposed lease is for a term of thirty-seven months, commencing on October  $1^{\rm st}$ , 2023, and expiring on November 3. 2027; and

WHEREAS, Authorizing the City Manager to execute the lease agreement for a dollar a year, with the advice and consent of the City Attorney.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Lease Agreement between the City and the Florida State Senator Ana Maria Rodriguez, attached as Exhibit "A", for the office space not to exceed amount of \$1 per year is hereby approved. The Resolution is approved by a supermajority vote of the City Commission.

Section 3. Authorization. The City Manager is authorized to execute the Lease Agreement on behalf of the City, with the advice Page 2 of 3
