A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING CHANGE ORDER NO. 1 FROM PEDRO FALCON ELECTRICAL CONTRACTORS, INC. FOR THE ITB 18-027 EDWARD B. KNIGHT PIER LIGHTING PROJECT, IN AN AMOUNT NOT TO EXCEED \$10,472.00, ALONG WITH A 120-DAY EXTENSION FOR CONTRACT COMPLETION; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Hurricane Irma made landfall in Key West on September 10, 2017, causing significant damage to the lighting on E B Knight Pier; and

WHEREAS, in Resolution 18-188, the City Commission awarded the bid of Pedro Falcone in response to ITB #18-027 for construction of Edward B. Knight Pier Lighting; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Change Order No. 1 from Pedro Falcon Electrical Contractors, Inc. for the Edward B Knight Pier Lighting Project (ITB 18-027), including an adjustment not to exceed \$10,472.00, and a 120-day extension for contract completion is hereby approved.

Section 2: That funds are budgeted for this project in General Fund/Disaster Recovery account 001-1910-519-6500 (Project HU 1701 G07), and a budget transfer/amendment is hereby authorized in the amount of \$10,472.00. (This project will be submitted upon completion to FEMA for possible Federal and State reimbursement.)

Section 3: That the City Manager is authorized to execute any necessary documents related to this Change Order, upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
