

RESOLUTION NO. 23-330

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A CHANGE ORDER FROM CHARLEY TOPPINO AND SONS, INC. IN THE AMOUNT OF \$27,822.75 FOR THE PEARL STREET PAVING PROJECT TASK ORDER; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 22-289, the City Commission awarded ITB #22-010 for Right of Way Improvements Contract, to provide paving services and sidewalk improvements, along City rights-of-way to Charley Toppino & Sons, Inc.; and

WHEREAS, in Resolution No. 23-189, the City Commission approved a Task Order not to exceed \$248,207.30 for Pearl Street/HOB Paving project to improve safety, drainage and appearance; and

WHEREAS, during construction of Pearl Street, the high groundwater table in the area made it necessary to add trench restoration for City stormwater drainage structures and piping to maintain the integrity of the road base; and

WHEREAS, City staff recommends approval of a Change Order in the amount of \$27,822.75 to install trench restoration on Pearl Street from Virginia Street to Catherine Street as part of the Pearl Street HOB Paving Project; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Change Order in an amount of \$27,822.75 be added to the City Commission approved Task Order for Pearl Street/HOB Paving; and

Section 2: That this Change Order for the installation of trench restoration will be funded from Account II41022302.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
