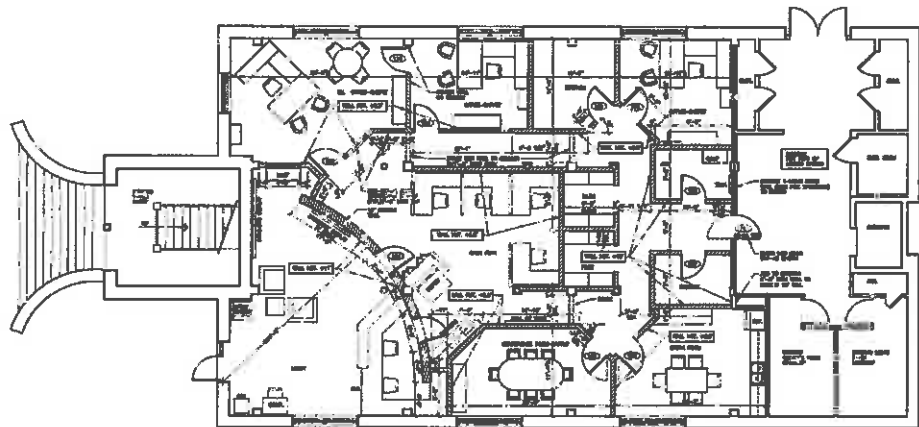

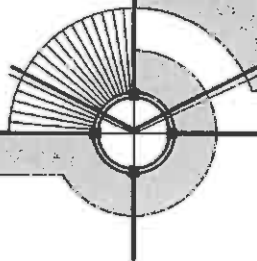

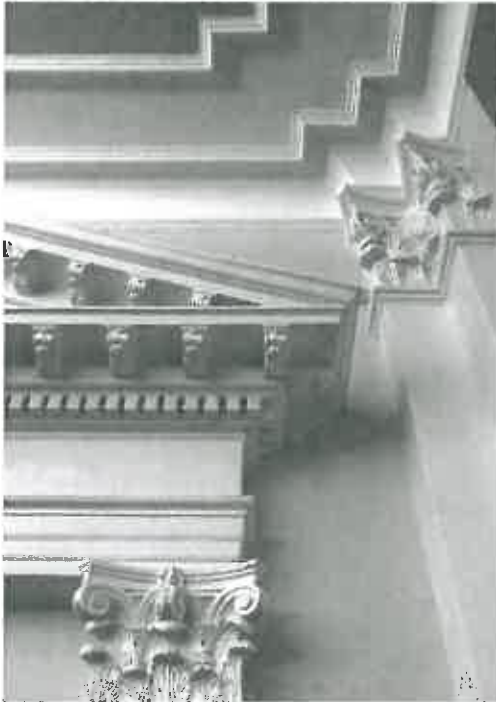

The Courthouse, built in 1926, served as the seat of County Government until new facilities completed in the 2005 made the building obsolete. Several additions and interior remodels projects during its history had significantly altered the building's historical character-defining features. The Courthouse was rehabilitated for use as county offices and restored to its original 1926 appearance. The non-historic 1980's additions and non-historic interior modifications were removed. New mechanical, plumbing, fire protection and electrical systems, and an elevator were added.

The historic second floor courtroom was restored for use as the County Commission Chambers and a ceremonial courtroom. The other interior spaces were rehabilitated into office space for the County Commissioners, County Administration and the Supervisor of Elections. The rehabilitation was designed to comply with the Secretary of the Interior's Standards for the Rehabilitation of Historic Building which will allow the building to be listed on the National Register of Historic Places.

The Weimer Hall Expansion was designed to be a "Game Changer" for the College of Journalism and Communications at the University of Florida. The existing facility, originally built in 1980 with significant additions completed in 1990 and 2001, houses the second largest undergraduate journalism program in the nation, with departments in Advertising, Public Relations, Journalism and Telecommunications. Weimer Hall is also home to the University Athletic Association's GatorVision, the Radio Reading Service, and includes control and service spaces for four radio stations and two television stations which are operated by the college and give the students unparalleled opportunities for real-world experience.

The Weimer Hall Expansion brings the entire building to approximately 150,000 square feet and also included renovation of existing spaces to better facilitate interaction between formerly segregated departments. An automatic sprinkler system was added to the rest of the existing facility and life safety improvements were made to existing egress stairs, all within the renovation project's limited budget. All renovation and addition work was designed and constructed to LEED standards, facilitating the building's certification as an Existing Building in the future.

All of the work had to be carefully coordinated by the entire design and construction team in order to minimize disruption to the existing spaces, many of which are sound-sensitive and some of which operate 24/7. Broadcast interruptions were not an option.

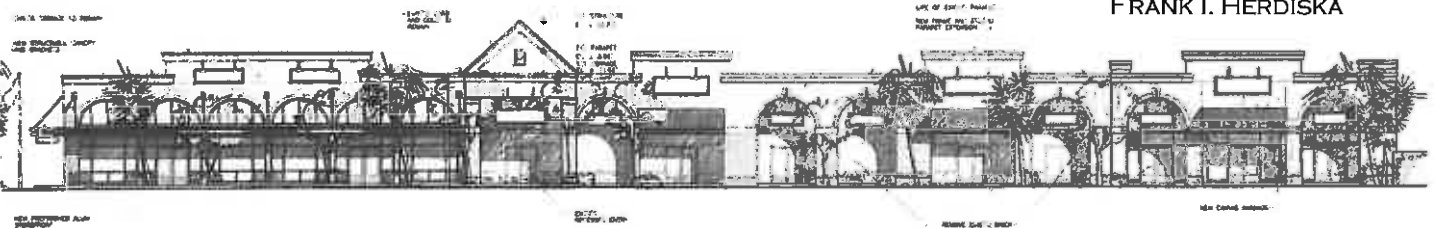

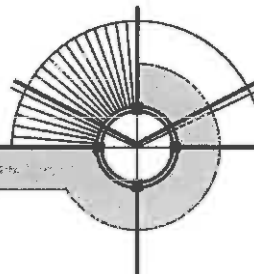

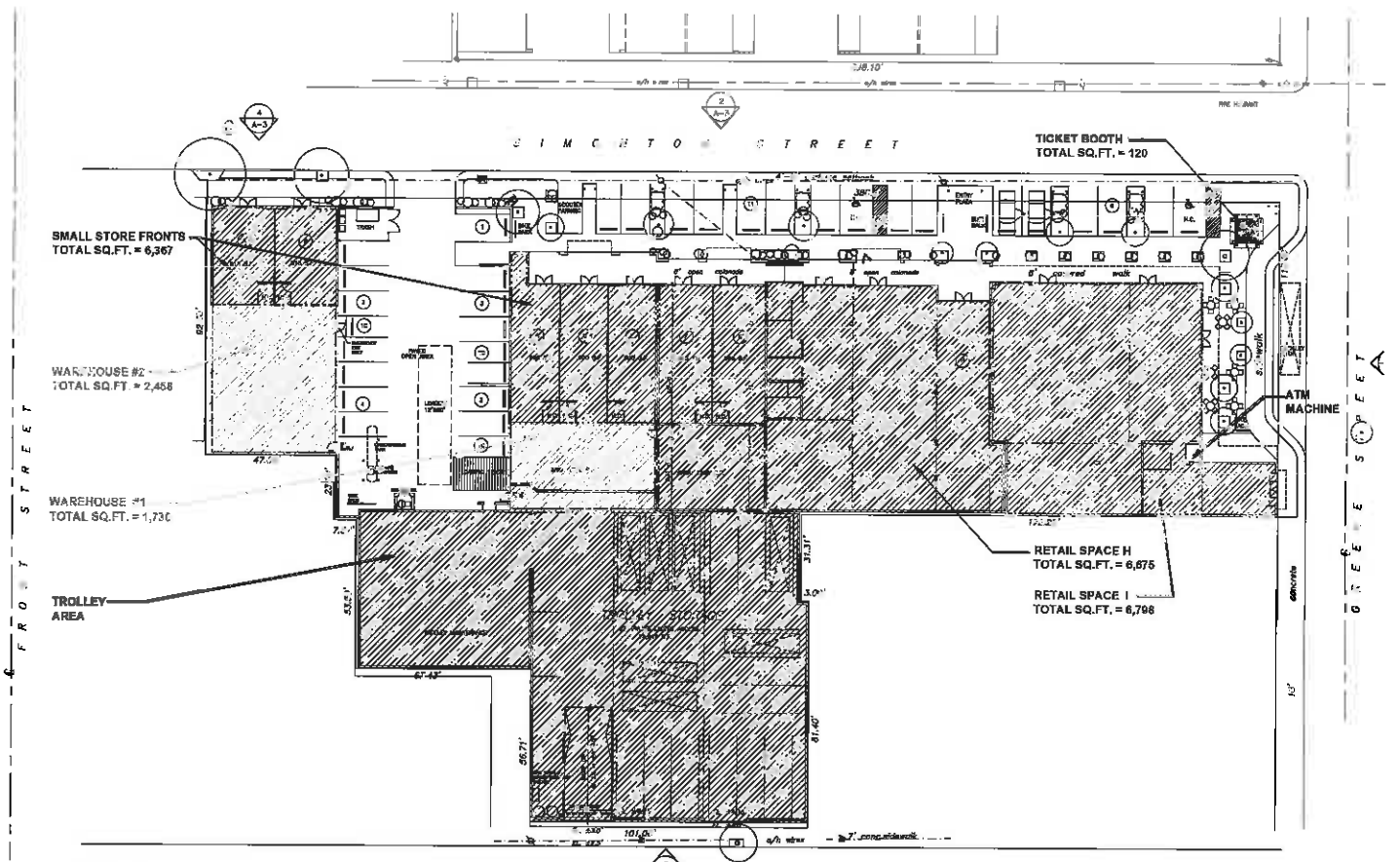


NEW FACADE

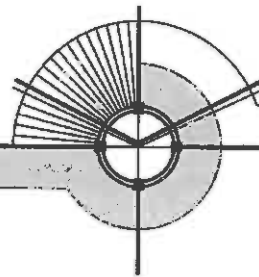
PREVIOUS FACADE
