A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING OCTAGON TO CONDUCT "MINI TAKES THE STATES" AT THE TRUMAN WATERFRONT MAJOR FIELD, QUAY WALL, 103 FIELD, PLAYGROUND SIDE OF BOAT RAMP AND THE GRAVEL LOT IF NEEDED ON SUNDAY, NOVEMBER 15, 2026, FROM 7:00 A.M. TO 10:00 A.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Octagon has applied to the city for a Special Event Permit for "MINI Takes the States" at the Key West Truman Waterfront Park Major Field, Quay Wall, 103 Field, playground side of the boat ramp and the gravel lot, if needed, for a 'Rise & Rally', Sunday, November 15, 2026, from 7:00 a.m. to 10:00 a.m.; and

WHEREAS, Section 6-86 of the Key West Code of Ordinances requires a Special Event permit to depart from the requirements of the City's Noise Control Ordinance; and

WHEREAS, amplified music will be played during the event from 7:00 a.m. to 10:00 a.m.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary

vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That Octagon is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Octagon is hereby granted permission for the use of Truman Waterfront Park Major Field, Quay Wall, 103 Field, the playground side of the boat ramp and the gravel lot, if needed.

SECTION 5. Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of

the City's Noise Control Ordinance.

SECTION 6. There will be amplified music during the event from 7:00 a.m. to 10:00 a.m.

SECTION 7. That Octagon will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 8. That Octagon acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
