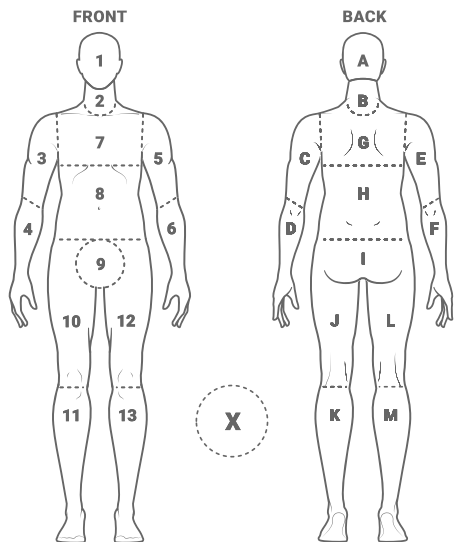

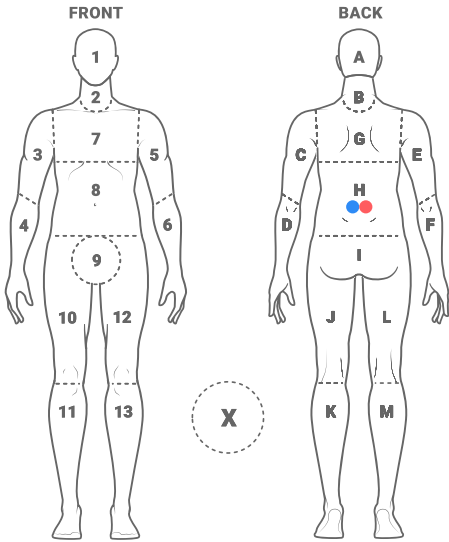

Officers responded to a trespasser at McDonalds. Call came from the manager of McDonalds. Arrestee appeared to be living out of a rental van in the parking lot. When asked to leave she refused. Officers attempted to place her in custody and she actively resisted their efforts. She did so by pulling away, tensing, and twisting. Ofc. Haynie drive stunned her once in her lower back. They were able to handcuff her and transport her to the ER and the MCDC.
