# Original Narrative By Corey Vanderhoof, 06/16/25 20:20

On Monday 06/16/2025 at approximately 1750 hours, I (Ofc. Vanderhoof) responded to 245 Front St as a back up unit in reference to an active physical altercation taking place on the cruise ship.

Ofc. Arguello was already on scene. Ofc. Arguello had drive stunned one of the parties involved prior to my arrival. See Ofc. Arguello's supplemental report for further information.

When I arrived Ofc. Arguello already had Jaylen Robinson (Arrestee) in handcuffs. Ofc. Arguello and I picked up Robinson off of the floor and stood him up. Robinson was belligerent and combative throughout our brief interaction. I began to search Robinson. As I was searching him Robinson began resisting and refusing to allow me to search him. Ofc. Arguello and I placed Robinson back on the ground to gain better control of Robinson to allow us to complete the search.

After the search was completed Ofc. Arguello and I began to escort Robinson to my patrol vehicle. Robinson was refusing to walk. Ofc. Adorno arrived on scene and began to help walk Robinson to my vehicle. Robinson was placed in the back of my patrol car.

Ofc. Arguello stated the following to me in summary about the original incident:
Robinson was walking into the cruise ship and had CBD vapes on him. When security attempted to take the vapes away, he became aggressive and belligerent. Security was able to confiscate the vapes. Robinson then attempted to grab the vapes back from security and pushed one of the security guards, Romulo Corpuz (Victim). Corpuz fell backwards and hit the wall. Robinson was then taken down by the ship security. This is when he (Ofc. Arguello) arrived and began giving Robinson orders to put his

hands behind his back. Robinson refused to do so. He gave more commands to place his hands behind his back or he would be tased. Robinson refused to do so and was drive stunned in the lower back.

Corpuz had visible injuries on his right arm. He had scrapes near his right elbow. Corpuz declined medical help. I took pictures of the injuries and uploaded them to Evidence.com.

Robinson was transported to the Lower Keys Medical Center for a medical clearance. Once Robinson was medically cleared, he was transferred to the Monroe County Detention Center where he was turned over to the detention center staff.

Based on the facts and the evidence I have probable cause to believe that on 06/16/2025 Jaylen Robinson violated F.S.S. 784.03-1(A) Battery- by purposefully pushing Romulo Corpuz causing him to fall backwards into the wall, causing scrapes to his right elbow.

Based on the facts and the evidence, I believe there is probable cause that on 06/16/2025 Jaylen Robinson did knowingly and intentionally violate F.S.S. 843.02 Resisting W/O Violence, by actually and purposefully refusing to allow Ofc. Arguello to handcuff him by refusing to put his hands behind his back, despite being told to do so multiple times, while he was engaged in his legal, lawful duties as a uniformed law enforcement officer. Robinson also refused to allow Ofc. Arguello and I to search him, causing us to have to place him back on the floor to regain control of him, due to his resistance. Robinson then refused to walk off the ship to my patrol car, and I had to wait for the help of additional officers to walk him to my patrol car.

Based on the facts and evidence, I believe there is probable cause that on 06/16/2025, Jaylen Robinson did knowingly and intentionally violate F.S.S. 877.03 Disorderly Conduct, by actually and intentionally pushing and fighting with the Carnival Cruise Ship staff inside the boat, causing the staff to have to stop what they were doing and focus on Robinson. Robinson's actions also caused other passengers on the ship to have to stop what they were doing, and passengers were unable to go in the area and board the boat.

My BWC was active for my involvement in the incident. My AXON in car camera was active for the transport of Robinson. I uploaded my BWC footage to Evidence.com.

At this time, no further information.

## Supplemental Narrative By Victor Arguello, 06/16/25 20:22

On Monday, June 16, 2025, at approximately 1800 hours, I (Ofc. Arguello) was working an off-duty detail at Pier B, when the Carnival security staff urgently flagged me down to come inside the ship.

Upon arrival, I entered the ship, and I noticed that several Carnival security guards had a man (later identified as Jaylen Robinson) pinned down on the floor. Robinson was actively trying to pull away from the security guards. I ordered Robinson to place his hands behind his back, and he refused. I grabbed Robinson by his arm, and he aggressively pulled away and ordered us to let him go. I ordered Robinson several times to place his hands behind his back and he refused stating he was not going to place his hands behind his back. I told Robinson if he continued to resist, he would be tased, he stated, "I don't give a fuck, I've been tased before". I drive stunned Robinson (5 seconds cycle) on his lower back for compliance. Robinson placed his hands behind his back after being tased, and I was able to handcuff him.

Robinson continued to pull away after being handcuffed. I told Robinson he was under arrest for resisting and probably for battering the security guards. Robinson would not allow me to search his pockets and threw himself on the floor stating he was not going to walk.

I spoke to the security guard (later identified as Romulo Corpuz) that allegedly was battered. Corpuz stated he noticed that Robinson was trying to enter with a CBD pen, which Carnival does not allow. Corpuz took the CBD pen from Robinson, and he became argumentative. Corpuz stated that at the second security checkpoint Robinson tried taking the CBD pen from him. Corpuz told him he could not have it, so Robinson pushed him against a metal pole. Corpuz and other security guards took Robinson down to the floor. Corpuz stated that I arrived on scene thereafter. Corpuz stated he would like to press charges.

I provided Corpuz with a Victim's rights brochure with a case number. This incident was recorded on my BWC.
