A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, [APPROVING/DISAPPROVING] A LOTTERY-WINNING ENTERTAINMENT VEHICLE LICENSE TO JOSE GRATEROL/PEDICAB KW [WITH/WITHOUT CONDITIONS]; [APPROVING/DISAPPROVING] A LOTTERY-WINNING ENTERTAINMENT VEHICLE LICENSE TO ADRIAN LAZA/NOVA DRIFT, LLC [WITH/WITHOUT CONDITIONS]; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 6-152 of the Code of ordinances provides that if the number of entertainment vehicle licenses falls below 20, there shall be a lottery to ensure the total number of entertainment vehicles permitted equals 20; and

WHEREAS, on October 29, 2024, the Licensing Department received notice that a license holder was not renewing his entertainment vehicle license for two pedicabs, and accordingly the Licensing Department provided public notice of a lottery and application process for the two licenses; and

WHEREAS, Section 1-147 of the Code of Ordinances proscribes a process of review and approval of applications for operating an entertainment vehicle, which requires the licensing office to provide copies of each completed application to the police department and planning department for review and written

evaluation of the application within 30 days, including recommended conditions of approval, and then the staff evaluations are provided to the City Manager to present to the City Commission; and

WHEREAS, pursuant to Section 6-147 of the Code of Ordinances, the City Commission shall either:

- (1) Disapprove the application;
- (2) Approve the application unconditionally; or
- (3) Approve the application subject to compliance with stated conditions. Such conditions may include but are not limited to a restriction on the hours or days of operation or any other condition which is consistent with protection of the public health, safety and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the lottery-winning entertainment vehicle license application of *Jose Graterol/Pedicab KW* is hereby [approved/denied] for a pedicab to be operated in conformance with City ordinances, and upon [no additional conditions/ additional conditions as follows: ______].

Section 2: That the lottery-winning entertainment vehicle license application of Adrian Laza/Nova Drift, LLC is hereby [approved/denied] for a pedicab to be operated in conformance with City ordinances, and upon [no additional conditions/additional conditions as follows:

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
