A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT AND INSTALLATION FROM PLAYCORE WISCONSIN, INC. OF PLAYGROUND EQUIPMENT AT BAYVIEW PARK IN AN AMOUNT NOT TO EXCEED \$63,878.00; AUTHORIZING A PURCHASING EXEMPTION UNDER SECTION 2-797(3), PURCHASES AND ACQUISITIONS UNDER GOVERNMENT CONTRACTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, hazards were recently identified related to Bayview Park playground equipment, which present potential threats to public safety; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize an emergency procurement in the amount of \$63,878.00 to ensure that the playground equipment is promptly replaced; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting; and

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to State government contracts;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies an emergency procurement in the total amount of \$63,878.00 to Playcore Wisconsin, Inc. for the purchase and installation of playground equipment at Bayview Park.

Section 2: That this purchase is additionally authorized pursuant to section 2-797(3), purchases under government contract.

Section 3: That adequate funds are budgeted for this equipment in FY 15/16 account 001-7201-572-604.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
