

- **Event coordinator is responsible for scheduling the inspection with this office.**

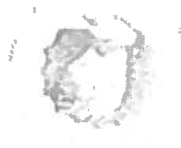

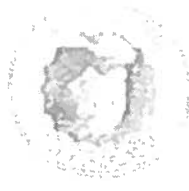
