The Contractors Examining Board shall have the power to determine if a license or certificate of competency of any contractor should be suspended for any violation of chapter 14, article III of chapter 18 and article II of chapter 34 and fix the length of time for such suspension.

YOU ARE HEREBY NOTIFIED of your alleged violation of the City of Key West Code of Ordinances.

Factual basis for the charge:

Count 1: Sec. 14-37 -Building without a permit

On 09/24/2021 Building Inspector Leggett, emailed The Ocean Key Resort regarding Mechnical units that appeard to have been installed at 0 Duval St. without the benefit of the required permits. On 10/01/2021 The City of Key West Code Compliance Officer Paul Navaro spoke with the General Manager (Johan Amneus) of the subject property and was told that Elite Devolopment and Mechanical installed the HVAC units and that he would provide the invoices and contracts.

YOU ARE REQUESTED TO APPEAR before the Contractors Examining Board on December 8 th , 2021 at 3:00p.m. at 1300 White Street to show cause why your permit privileges should not be suspended or revoked and / or show cause why Department of Business and Professional Regulations (DBPR) should not receive a recommendation for disciplinary action.

YOUR RIGHTS, POSSIBLE BOARD DECISIONS, AND THE APPEAL PROCESS are all detailed in Section 2-324 of the City of Key West Code of Ordinances (attached). Be advised that if you decided to appeal any decision of the Board, you shall be responsible to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

I appreciate you taking my phone call today regarding the mechanical units which appear to have been installed at Zero Duval without the benefit of the required permits. We would appreciate your assistance with pointing us in the direction of the responsible party for the installation. As you are aware this type of work requires the benefit of building permits and inspections required to ensure safety, public health and general welfare. The correction for this is a simple process for the qualifier to come into the city of key west and apply for after the fact permit, upon issuance of a permit an inspection will be performed to ensure the installation meets the minimum Florida Building Code requirements. Again, your assistance and cooperation is greatly appreciated in resolving this matter.


