A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER BETWEEN THE CITY AND KCI TECHNOLOGIES, INC. IN THE AMOUNT OF \$128,560.00 FOR DESIGN SERVICES OF THE CAROLINE STREET (SIMONTON TO WHITEHEAD) IMPROVEMENTS PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS ; AUTHORIZING THE CITY MANAGER то EXECUTE ANY NECESSARY UPON CONSENT DOCUMENTS OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 17-207, the City Commission approved a three-year contract with Keith & Schnars for General Engineering Services. In Resolution 19-111, the name Keith and Schnars was changed to KCI Technologies, Inc., and in Resolution No. 20-142, the City Commission renewed the contract with KCI Technologies, Inc. for two years; and

WHEREAS, Caroline Street from Simonton Street to Whitehead Street requires resurfacing and improvement tasks including sidewalks, ADA curbs ramps, signage and pavement marking as set forth in the attached Scope of Services; and WHEREAS, KCI Technologies has satisfactorily completed several task orders for the City, and City staff recommends authorization of this Task Order as set forth in the attached Scope of Services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a Task Order for KCI Technologies, Inc. for design services for the 2022 Caroline Street Improvements project (Simonton to Whitehead) in an amount not to exceed \$128,560.00 is hereby approved.

Section 2: That this Task Order will be funded from the Internal Improvement/Streets Budget Account No. 102-4102-541-63.00, Project Code II41022002, and any necessary budget transfers or adjustments are hereby approved.

<u>Section 3</u>: That the City Manager is authorized to execute any necessary documents related to this Task Order upon consent of the City Attorney. Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
