WHEREAS, in Resolution No. 17-207, the City Commission approved a contract with Perez Engineering and Development, Inc. for General Engineering Services and in Resolution 2-142 the contract was extended; and

WHEREAS, the City Commission accepted an FDOT grant in the amount of \$100,000.00 to beautify the intersection of US-1 and A1A (the "Triangle"); and

WHEREAS, this task order, which is for design of the Triangle area, and for Conceptual Signage Design Studies for a new entrance sign to the City of Key West, will support the Key West Forward goal for Community Action (Beautification Committee) and Cleanliness. NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That a Task Order for Triangle Beautification Design and Conceptual Signage Design (Project IS19002202) is hereby approved in an amount not to exceed \$57,020.00.00.

Section 2: This Task Order will be paid from account 101-1900-519-6300 (Project IS19002202). A portion of this project may be reimbursed or paid through donations or grant funding from the Chamber of Commerce, and any necessary budget transfers or adjustments are hereby authorized.

<u>Section 3</u>: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney. Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
