

### Section 5

# Methodology and Approach / Approach and Understanding of Project

HDR's detailed review of the Request for Qualifications, analysis of Contract Plans, extensive site visits, and experience on similar projects have enabled us to gain a thorough understanding of the project scope. In this Section, we will demonstrate our proactive approach in addressing the key construction challenges and providing solutions to these challenges. Such an approach is extremely important on this project because of its relatively short duration. The HDR Team has the know-how to plan critical CEI administrative requirements prior to the start of construction – this approach is critical to managing the project and setting a proactive tone. We fully understand that a smooth construction project can minimize adverse impacts to the residents, business owners, and patrons on this busy Southard Street corridor.

### Prequalification and D.B.E Participation

HDR and our subconsultants H-ROD and CTI are prequalified in the proposed work categories in accordance with Rule 14-75, F.A.C. Our FDOT-issued prequalified letter is attached in Section 10 of this proposal.

HDR has strong partnerships with many firms and is committed to sharing the work with other firms. We understand that DBE participation is not required for this project. However, we are committed to the City of Key West's objective that DBE's are given the opportunity to participate in the performance of work under this contract in a nondiscriminatory environment. The HDR Team includes H-ROD a DBE firm and pledges to exceed FDOT's current 10.65% DBE goal.

### **Understanding of General Scope of Work**

HDRunderstands that the City of Key West and the Florida Department of Transportation (FDOT) District 6 have authorized a Local Agency Program (LAP) Agreement in the amount of \$999,409.00 for the Southard Street Improvement project between Duval Street and Thomas Street under FM Project No. 435497-2 and Federal Aid Project No. D620-038-B.

We understand that the road and sidewalk refurbishment project on Southard Street, generally consists of sidewalks (915 SY), driveway turnouts (11 EA), curb, gutter (1,356 LF), establishing crowns (PGL), milling (2,008 SY), paving (350 Tons), minor excavation (189 CY) and embankment (11 CY), utility valve and meter adjustments (35 EA), signing



(11 EA), and thermoplastic markings. A unique project feature includes thickened edge sidewalks and extra depth curb and gutter at the perimeter of tree planters to improve sidewalk durability. This operation will entail careful root pruning under the supervision of an ISA Certified Arborist and the City's Urban Forestry Manager. Incidental to the construction work is the maintenance of traffic (MOT), existing tree and trunk protective measures, as well as communicating and coordinating upcoming construction operations with adjacent property owners and businesses.

Generally, the CEI Consultant will be responsible for administering, monitoring, and inspecting the construction contract such that the project is constructed in reasonable conformity with the plans, specifications, and special provisions. HDR will exercise our independent professional judgment in performing our obligations and responsibilities under this contract. All services provided will comply with FDOT manuals, procedures, and memorandums in effect as of the date of execution of the agreement unless otherwise directed in writing by the City.

We will observe the Contractor's work to determine the progress and quality of work, identify discrepancies, report significant discrepancies to the City, and direct the Contractor to correct such observed discrepancies. HDR will advise the City's Project Manager of any significant omissions, substitutions, defects, and deficiencies noted in the work of the Contractor and the corrective action that has been directed to be performed by the Contractor. We will keep detailed accurate records of the Contractor's daily operations and significant events that affect the work.





### City of Key West Downtown Historic District

HDR is aware that this project is located entirely within the Key West Downtown Historic District and is on the National Register of Historic Places (NRHP). The NRHP is the official list of our country's historic buildings, districts, sites, structures, and objects worthy of preservation, established as part of the National Historical Preservation Act of 1966. There are fourteen (14) contributing resources that adjoin this corridor and as such, HDR will be proactive in managing this project and the avoidance of impacts to these resources. All construction activities must be constrained to within the Right of Way; containment and protection measure must always be planned and carried out by the Contractor to avoid adverse effects within the Historic District.

### Maintenance of Traffic

HDR will monitor and inspect the Contractor's Work Zone traffic control plan and review of modifications to the Work Zone Traffic Control Plan, including alternate Work Zone Traffic Control Plan, in accordance with FDOT procedures. Lane closure requests must be submitted for advance approval. Business and residential driveways and entrances must be maintained throughout construction and advance coordination of sidewalk and driveway connections will be a high priority for this project.

Various options for sidewalk closures and sidewalk detours are shown on sheet nos. 19-21. HDR is aware that the Contractor must submit a signed and sealed detailed MOT Plan two weeks prior to the start of construction

to the City for approval. It is important that this plan provide the intended scheme or sequencing for removal and replacement of sidewalk and curb in sufficient detail. This sequencing will govern which type of pedestrian detours will be required and should also be reflected in the Contractor's construction schedule. This will also be the baseline for coordination with businesses and residents so that access can be maintained and planned in advance.

### Contractor's Work Schedule

The HDR Team is aware that as per subarticle 8-3.2 of the FDOT specifications, the Contractor must submit a Contract Schedule within 21 calendar days after Contract award or at the preconstruction conference, whichever is earlier and that the Engineer will review and respond to the Contractor within 15 calendar days of receipt. This specification requires the Schedule to show the various activities of work in sufficient detail to demonstrate a reasonable and workable plan to complete the project within the allowable contract time, the order and interdependence of activities, and the sequence for accomplishing the work. As previously mentioned, we expect that the proposed sequencing for removal and replacement of sidewalk and curb is of sufficient detail and is reasonable.

The Schedule must also provide sufficient information to indicate coordination activities with utility owners that have facilities within the limits of construction have been resolved. HDR will use the accepted schedule as the baseline against which to measure the progress.



### LAP Project Administration (LAP) Experience

The HDR Team provides the unique benefit of having exceptional LAP knowledge with the FDOT on countless municipal and City projects that entail LAP Agreements. Having conducted LAP audits for FDOT, District 6, we know the key components in maintaining compliance with the Local Agency Program requirements. Specifically, Chapter 23 of the LAP Manual,

23 CFR, Construction Project Administration Manual, FHWA 1273, and LAP Bulletins are various documents used to administer LAP projects. Some of the most frequent issues found are EEO Compliance, payroll violations, and Buy America compliance. From the pre-construction phase through final project close-out, the HDR Team will confirm that proper documentation is in-place.

### **Public Information Services**


Led by Anthony Sabbag and Maria Gloria, HDR will provide Public Information services as required to manage inquiries from the public, public officials, and the news media. HDR will take a proactive approach prior to and during all construction phases so that the local community businesses, traveling public and other stakeholders are timely informed of all upcoming scheduled operations and project activities. We are aware that public satisfaction is a vital goal for the City of Key West, and only through Communication is Key; the HDR Team will keep open and constant communication with the City's Project Manager and Public Involvement Officer, Alyson Crean, keeping all stakeholders informed of all public involvement issues

including anticipated notices of lane closures. Our Team will schedule separate meetings with the Designer/EOR and the Contractor prior to the preconstruction conference, and begin setting up an environment of cooperation, trust, and commitment to the project. The Partnering approach enhances the effectiveness of the team, establishes common expectations and the means of communicating effectively, accurately, and resolving issues as they arise.

HDR's approach is rooted in understanding the Key West community and special events that will be considered while administering this project. Some of the City special events are listed below. However, based on the Preliminary Construction shown in the section below, we only anticipate that Fantasy Fest in October of this year and the Annual World Championship Boat Races in November of this year will impact this project. During these events no lane closures or sidewalk detours should be planned, and full vehicular and pedestrian access must be maintained.

### Review and Approval of Contractor Payment Applications

Gary Miller will serve as Contract Support Specialist and will work with the Senior Inspector and Project Engineer to perform the initial review of Contractor Payment Applications. Site source records, measurements, daily reports of construction, and testing results are all integral parts of this review process. Anthony Sabbag will perform the final review of all documentation, and "sign-off" on all payment applications before transmitting to the City's Project Manager.



### Material Testing and Acceptance

The HDR Team will review the Contractor's Quality Control Plan prior to project commencement for adequacy and suitability. We will inspect the materials delivered to the work site for conformance with the plans, specifications, and construction contract. Contractor sampling and testing must be performed by an accredited laboratory, as part of the Contractor's quality control program. Our team will oversee and monitor test results and discuss materials issues at weekly progress meetings. Asphalt, concrete, and other material tickets will be verified for product approvals. Material shipments to the site should also be accompanied by certified material tickets. The HDR Team will perform verification sampling of materials on site and any physical/laboratory testing of materials will be performed by our subconsultant CTI. CTI is pre-qualified in Work Groups 10 and 10.3 and has performed materials testing for FDOT Districts 1, 4, 6, and Turnpike and is an approved Materials Testing and Research Laboratory.

### Understanding of the Scope of Work / Engineering Services

The HDR Team understands the various tasks and requirements listed in the Scope of Work and has administered hundreds of CEI service projects utilizing very similar scopes. HDR will provide the level of surveillance of all construction activities and all related operations needed to accurately inspect and document the work. We will interpret plans, specifications, and special provisions for the construction contract, maintaining complete and accurate records of all activities and events relating to the project and will properly document significant project changes. As part our engineering services we will:

- Schedule, attend, and administer a preconstruction conference for the project within ten days after the Notice to Proceed. We will maintain a complete and accurate record of the proceedings of the pre-construction conference and distribute minutes to the participants and other interested parties within seven days following the conference.
- 2. Analyze the Contractor's initial baseline schedule, revised baseline (if requested), monthly schedule updates, as-built schedule, etc. for compliance with the contract documents. Our schedule reviews will focus on completeness, logic, durations, activity, flow, milestone dates, concurrency, resource allotment, and delays will be reviewed. We will verify that the schedule conforms with the construction phasing and MOT sequences, including all contract modifications, and will provide a written review of the schedule identifying significant omissions, improbable or unreasonable activity durations, errors in logic, and any other concerns as detailed in CPAM



- 3. Verify that the Contractor is conducting inspections, preparing reports, and monitoring all storm water pollution prevention measures associated with the project. Some of the erosion control measures outlined in the General Notes, note no. 29 include silt fence along any soil disturbing activities, inlet protection, and sodding for permanent erosion control.
- 4. Analyze problems and issues that arise on the project and various correspondence and proposals submitted by the Contractor. We endeavor to document and resolve such issues in a timely manner to avoid delays and to keep the work progressing. We will provide solutions and recommendations to the City's Project Manager.
- Verify quantities of all work performed, field measure work items for payment purposes as needed to prevent delays in Contractor operations and ensure prompt processing of such information for the City to make timely payment to the Contractor.



- 6. Provide Public Information services as required to manage inquiries from the public, public officials, and the news media. We will prepare newsletters for distribution to adjacent property owners. We are aware that the City's Project Manager shall approve all notices, brochures, responses to news media, etc., prior to release.
- 7. Prepare and submit to the Construction Project Manager weekly, a Construction Status Reporting System (CSRS) report.
- 8. Schedule and conduct a meeting with the City Engineering Office at least 45 calendar days prior to project final acceptance. The purpose of this meeting will be to discuss the required documentation, including as-builts, necessary to close out the project and applicable permits.
- Perform videorecording of the pre-construction conditions throughout the project limits and provide a digital photo log or video of project activities, with an emphasis on potential claim items and on areas of


- potential public controversy. This will include detail pictures of all "areas of potential effects" listed on roadway plan sheet no. 2A.
- 10. Utilize a digital camera for photographic documentation of noteworthy incidents or events such as Pre-construction conditions, normal and exceptional progress of work, critical path activities, accidents showing damage, potential unsafe working conditions, unique construction techniques, damaged equipment or materials, activities which may result in claims, damage to areas of potential effect, and private property damage. This documentation will be electronically transferred to the City at an interval determined by the City.
- 11. Monitor each Contractor and Subcontractor's compliance with all construction contract documents (special provisions, plans, and specifications).
- 12. Prepare and make presentation before the Key West City Commission and/or City staff in connection with the project on an as-needed basis.

### Approach to Southard Street Construction Issues and Challenges

ISSUE 1

During our site visits we have found that there are several items within the City Right of Way (ROW) that were installed by adjacent property owners. One example is the bicycle rack installed by the business owner at 435 Southard St. (sta. 108+90, Lt.).

**APPROACH #1:** As required by the project plans (sheet no. 2, note no. 14), "the Contractor shall provide 30-day written notice to adjacent property owners prior to removal...". Our solution includes conducting our own pre-construction inventory of such private property not identified in the plans and requiring the Contractor to copy us on the 30-day written notices so that we can track this effort and assist as needed.





The project Maintenance of Traffic plans (sheet nos. 19-21) provide Standard Plans schemes for pedestrian control and work within the sidewalk but does not provide non-peak lane closure hours, restrictions on sidewalk replacement lengths, phasing of the work, property access requirements, or milling and paving detours.

APPROACH #2: We understand that as per project plans (sheet no. 2, general note no. 15) "the Contractor shall submit signed and sealed detailed MOT plans two weeks prior to the start of construction to the City for approval." HDR will review this with this important submittal in conjunction with the City's review to verify that proposed non-peak work hours, restrictions on sidewalk replacement lengths, phasing, property access measures, milling and paving detours, and appropriate sidewalk detours are appropriate to minimize public inconvenience. The requirements of general note nos. 36 and 37 highlight the importance of pedestrian MOT and the requirement for safe movement of pedestrians through the work zone at all times.

We understand that all water and sewer meters and valve boxes are to be replaced with new boxes in accordance with the roadway plans (sheet no. 2, general note no. 32) and the cost of such replacement is included in the relocation/adjustment unit price.

APPROACH #3: It is of the utmost importance that the Contractor perform an inventory of all utility boxes to be replaced within the corridor and pre-order these items, so they are available to not delay sidewalk replacements. We would suggest that the Contractor submit a comprehensive list of all sizes along with manufacturer information for City review prior to such order to avoid construction delays.

As this project entails significant sidewalk removal and replacements in this two-block section, dust, debris, and concrete splatter has the potential to affect adjacent businesses and private property.

**APPROACH #4:** Although the roadway plans (sheet no. 2, general note no. 41) require due care when placing concrete, HDR will place an emphasis on the use of masking, tarps, and water usage during saw-cutting and jack-hammering to control dust and debris during concrete removal operations.

We anticipate that the Contractor will have a combination, skid-steer, and air compressor on site for much of the construction duration for concrete curb and sidewalk demolition. The potential need to stage equipment within the corridor will be an item of discussion early in the project.

**APPROACH #5:** Although the roadway plans (sheet no. 2, general note nos. 25 and 35) prohibit staging on private property without property owner agreement and prohibits staging within the National Register Listed Key West Historic District, we will discuss with the City if approval can be considered for minimal short-term equipment storage at alternate parking areas within City ROW. HDR fully understands and is sensitive to National Registerlisted or-eligible requirements on federal transportation projects as these are considered Section 4(f) resources. The lengthy process to coordinate an exception with the State Historic Preservation Officer (SHPO) to process a Section 4(f) form for temporary occupancy would be time prohibitive for this project. One potential solution is a nearby area that is outside of the Key West Historic District. It is on the NW corner of Fleming and Whitehead St. The First State Bank and US Post Office frontage parcels




are outside of the Key West Historic District and perhaps these parking spaces can be used for minimal staging of equipment during construction.

The information provided on the roadway plans at sta. 103+19 Rt. (312-314 Southard St.) does not provide the proposed sidewalk widths along the tree planter. See photo to the right. The tree roots are so significant at this area that asphalt has been placed here in lieu of concrete over the years. In summary, the proposed planter dimension and sidewalk width is undeterminable from the plans as well as from a review of existing conditions.

APPROACH #6: In accordance with roadway typical section sheet no. 5, note no. 1, we will consult with the City Project Manager and Engineer of Record prior to construction and obtain the proposed sidewalk width at this location. We are aware that this location is Area of Potential Effect #3 and we will fully discuss the care and caution that must be exercised by the Contractor when performing work adjacent to this property.

Area of Potential Effect #4 at sta. 103+80 Rt. (316 Southard St.) is a character defining low-rise brick wall, metal gate, and tile walkway that adjoin the existing sidewalk. See photo to the right.

APPROACH #7: During our field visit we identified separation cracks in the lower portion of the wall. Our approach entails performing preconstruction documentation with pictures and videorecording of the wall, all cracks, approx. crack widths. We will discuss with the Contractor, his/her approach to sidewalk removal adjacent to this wall. We anticipate a full depth saw-cut away from this wall and smaller sized jack hammers to avoid undue vibration to this character-defining brick wall. The HDR Team will fully discuss the care and caution that must be exercised by the Contractor when performing work adjacent to this property.





Along Southard St. Lt. roadway, sta. 103+36 to sta. 105+02 Lt. there are four large Mahogany trees where 5.7' wide sidewalk is proposed with thickened edge sidewalk and curb and gutter along these tree planters as shown on sheet nos. 9 and 11A of the roadway plans. Also, the low retaining wall is referenced as the Area of Potential Effect #1 at same location at 530 Whitehead St. Note that the proposed 24" thickened edge depth within inches horizontally from the Mahogany tree trunks will be a challenge to excavate as there are very large roots just beneath the sidewalk surface as shown in photo at right at sta. 104+68 Lt.

APPROACH #8: Root pruning at these and other Mahogany tree roots must be performed under the supervision of an ISA Certified Arborist. Close coordination with the City's Urban Forestry Manager will be required (sheet no. 2B) and a tree permit must be applied for as per Pay Item Note for pay item no. 580-336-2 on sheet no. 3. Our experience on projects involving thickened edge sections along trees is that the most common method used for necessary root removal is stump grinding. Such equipment will also prove beneficial to limiting adverse impacts to other structures affected by this same root system, namely the low retaining wall at the back of sidewalk. Full depth saw-cut along this wall will also be necessary.

At 322 Southard St., sta. 104+30 Rt. there is a slightly raised concrete border and grass strip prior to the character defining picket fence along this property as shown in the photo to the right. This location is referred to as Area of Potential Effect #5.

**APPROACH #9:** As noted in the plans, the Contractor must take avoidance measures to eliminate adverse effects on the sod strip, concrete border, and fence. As this property has a front walk-way entrance and a driveway entrance, advance coordination of concrete removal is extremely important.

At 324 Southard St., sta. 104+58 Rt. there is a block foundation and front step that adjoins the existing sidewalk that is possibly within the ROW. This is a character defining feature of this property and this location is referred to as Area of Potential Effect #6. Two thickened edge planters are proposed as well. See photo to the right.

**APPROACH #10:** As noted in the plans, the Contractor must take avoidance measures to eliminate adverse effects on these items and possibly saw-cut around these elements. HDR will discuss with the City and EOR that







construction can be expedited, and impacts minimized at this location if the thickened edge planter is eliminated at the planter furthest west. The rationale for constructing normal depth curb and sidewalk at this planter is that only a Christmas Palm is located at this planter location. This Palm has a fibrous root system that is not detrimental to the proposed new sidewalk.







At 417 Southard St., sta. 107+80 Lt. the facades adjoin and awnings overhang over the ROW as well as the 2nd story overhang. These items are a character defining feature of this property and is referred to as Area of Potential Effect #7. See photo to the left. Excavation machinery should avoid contact with the overhangs.

APPROACH #11: As noted in the plans, the Contractor must take avoidance measures to eliminate adverse effects on these items. We anticipate a full depth saw-cut along the building facades, the use of small jack hammers, and significant hand removal of debris beneath the awning areas to avoid damage. It would be beneficial to use temporary plywood masking along these store fronts to avoid concrete chips and equipment from impacting the facades.

A significant safety improvement on this project is the relocation of the existing sidewalk from its current location adjacent to the travel lane to along the ROW line behind the existing Mahogany tree. to create a linear sidewalk connection from sta. at approx. sta. 107+13 to sta. 107+45 Lt.

**APPROACH #12:** The pavement design for the pavement widening is 14" of cemented coquina (LBR 100), 6" of asphalt SP-12.5, and 1" of SP 9.5. It will be suggested to the Contractor, prior to construction, that the new sidewalk be constructed prior to the pavement widening to allow for continuous pedestrian traffic through this area.

As noted in the previous issue and approach #12, the proposed project pavement widening design includes 14" of cemented coquina (LBR 100) from sta. at approx. sta. 107+13 to sta. 107+45 Lt. This is noted on roadway plan sheet no. 10.

APPROACH 13: HDR is aware that cemented coquina is not available and is not being mined currently under the FDOT's Approved Aggregate Products list published by the State Materials Office. Procuring this material from an approved source is a FDOT requirement. HDR suggests that the City and Engineer of Record consider allowing the Contractor to use 14" of Limerock (LBR 100) that has an equivalent structural value. This optional base group type is widely used in the Florida Keys and is abundantly available throughout the State of Florida. Having this option would benefit the Contractor and the City to help keep project on schedule.

At sta. 106+60 Lt. two thickened edge planters are proposed in front of this property as shown on roadway plan sheet no. 10. See photo to


at these planters. The rationale for constructing normal depth curb and sidewalk at this planter is that these Sabal Palms have fibrous roots that are not detrimental to the existing sidewalk.


At 419 Southard St., sta. 108+60 Lt. there are street protection measures in place that is located within the ROW. There are character defining features on this property, and it is referred to as Area of Potential Effect #8. See photo below. Avoidance measure are needed at this location to avoid damage.

**APPROACH #15:** As noted in the plans, the Contractor must take avoidance measures to eliminate adverse effects on these items. We anticipate a full depth saw-cut along the building facades, the use of small jack hammers, and significant hand removal of debris beneath the awning areas to avoid damage. In advance of construction, we will inquire as to the completion schedule of this renovation to avoid construction impacts.

At 419 Southard St., sta. 108+60 Lt. there is segment of historic slate curb that is integrated with existing curb that is proposed to be replaced as shown on roadway plan sheet no. 10. This is referred to as Area of Potential Effect #12. See photo below.

APPROACH #16: As noted in the plans, the Contractor must use caution to carefully remove and safely stack and secure the approx. 20 LF of slate curb. We will provide to the Contractor the City of Key West contact at the preconstruction conference and will be proactive in verifying safe means of removal and storage to avoid damage to this historic slate curb





At 534 Duval St., sta. 109+50 Lt. this property is now under construction and has street protection measures in place that encroaches on the ROW. There are also character defining features on the Southard St. elevation of this property (siding, foundation, corner boards, porch stoop, etc.) and it is referred to as Area of Potential Effect #10. See photo to the right. Avoidance measures are needed at this location to prevent damage.

**APPROACH #17:** As noted in the plans, the Contractor must take avoidance measures to eliminate adverse effects on these items. We anticipate a full depth saw-cut along the building facades, the use of small jack hammers, and significant hand removal of debris to avoid damage. In advance of construction, we will inquire as to the completion schedule of this renovation to avoid construction impacts.

HDR is committed to an effective Quality Assurance Plan and will use a QA Audit developed for this Contract that involves five categories: CEI administration/records, LAP Checklists, documentation/daily work reports, asphalt, and concrete. These categories were chosen because they represent the most important metrics for overall project success.

For each QA Audit conducted, if the rating for any category falls below a certain grade, suggested corrective measures



are discussed with the CEI staff and such measures will be documented in the QA Audit. Another function of our QA Program is to identify opportunities for improvement. The audit findings will be transmitted to the City's Project Manager. Quality Assurance Audits will be conducted on a bi-monthly basis to monitor the performance of all assigned CEI staff.

### **Certification of Final Estimates**

HDR's Final Estimate and As-Built Plans Submittal will involve the preparation of documentation and records in compliance with the Agreement, Consultant's approved QC Plan and the City's Procedures. We will submit the Final Estimate and three sets of final as built plans documenting Contractor's work (one record set with two copies) within thirty calendar days of final acceptance or as the City may deem necessary. ## Sec. 2-773. Cone of Silence.

- (a) *Definitions*. For purposes of this section, reference to one gender shall include the other, use of the plural shall include the singular, and use of the singular shall include the plural. The following definitions apply unless the context in which the word or phrase is used requires a different definition:
  - (1) Competitive solicitation means a formal process by the City of Key West relating to the acquisition of goods or services, which process is intended to provide an equal and open opportunity to qualified persons and entities to be selected to provide the goods or services. Completive solicitation shall include request for proposals ("RFP"), request for qualifications ("RFQ"), request for letters of interest ("RFLI"), invitation to bid ("ITB") or any other advertised solicitation.
  - (2) Cone of silence means a period of time during which there is a prohibition on communication regarding a particular competitive solicitation.
  - (3) Evaluation or selection committee means a group of persons appointed or designated by the city to evaluate, rank, select, or make a recommendation regarding a vendor or the vendor's response to the competitive solicitation.

    A member of such a committee shall be deemed a city official for the purposes of subsection (c) below.
  - (4) Vendor means a person or entity that has entered into or that desires to enter into a contract with the City of Key West or that seeks an award from the city to provide goods, perform a service, render an opinion or advice, or make a recommendation related to a competitive solicitation for compensation or other consideration.
  - (5) Vendor's representative means an owner, individual, employee, partner, officer, or member of the board of directors of a vendor, or a consultant, lobbyist, or actual or potential subcontractor or sub-consultant who acts at the behest of a vendor in communicating regarding a competitive solicitation.
- (b) *Prohibited communications*. A cone of silence shall be in effect during the course of a competitive solicitation and prohibit:
  - (1) Any communication regarding a particular competitive solicitation between a potential vendor or vendor's representative and the city's administrative staff including, but not limited to, the city manager and his or her staff;
  - (2) Any communication regarding a particular competitive solicitation between a potential vendor or vendor's representative and the mayor, city commissioners, or their respective staff;
  - (3) Any communication regarding a particular competitive solicitation between a potential vendor or vendor's representative and any member of a city evaluation and/or selection committee therefore; and



- (4) Any communication regarding a particular competitive solicitation between the mayor, city commissioners, or their respective staff, and a member of a city evaluation and/or selection committee therefore.
- (c) *Permitted communications*. Notwithstanding the foregoing, nothing contained herein shall prohibit:
  - (1) Communication between members of the public who are not vendors or a vendor's representative and any city employee, official or member of the city commission;
  - (2) Communications in writing at any time with any city employee, official or member of the city commission, unless specifically prohibited by the applicable competitive solicitation.
    - (A) However, any written communication must be filed with the city clerk. Any city employee, official or member of the city commission receiving or making any written communication must immediately file it with the city clerk.
    - (B) The city clerk shall include all written communication as part of the agenda item when publishing information related to a particular competitive solicitation;
  - (3) Oral communications at duly noticed pre-bid conferences;
  - (4) Oral presentations before publicly noticed evaluation and/or selection committees:
  - (5) Contract discussions during any duly noticed public meeting;
  - (6) Public presentations made to the city commission or advisory body thereof during any duly noticed public meeting;
  - (7) Contract negotiations with city staff following the award of a competitive solicitation by the city commission; or
  - (8) Purchases exempt from the competitive process pursuant to <u>section 2-797</u> of these Code of Ordinances;
- (d) *Procedure*.
  - (1) The cone of silence shall be imposed upon each competitive solicitation at the time of public notice of such solicitation as provided by section 2-826 of this Code. Public notice of the cone of silence shall be included in the notice of the competitive solicitation. The city manager shall issue a written notice of the release of each competitive solicitation to the affected departments, with a copy thereof to each commission member, and shall include in any public solicitation for goods and services a statement disclosing the requirements of this ordinance.
  - (2) The cone of silence shall terminate at the time the city commission or other authorized body makes final award or gives final approval of a contract, rejects all bids or responses to the competitive solicitation, or takes other action which ends the competitive solicitation.
  - (3) Any city employee, official or member of the city commission that is



approached concerning a competitive solicitation while the cone of silence is in effect shall notify such individual of the prohibitions contained in this section. While the cone of silence is in effect, any city employee, official or member of the city commission who is the recipient of any oral communication by a potential vendor or vendor's representative in violation of this section shall create a written record of the event. The record shall indicate the date of such communication, the persons with whom such communication occurred, and a general summation of the communication.

- (e) Violations/penalties and procedures.
  - (1) A sworn complaint alleging a violation of this ordinance may be filed with the city attorney's office. In each such instance, an initial investigation shall be performed to determine the existence of a violation. If a violation is found to exist, the penalties and process shall be as provided in <u>section</u> 1-15 of this Code.
  - (2) In addition to the penalties described herein and otherwise provided by law, a violation of this ordinance shall render the competitive solicitation void at the discretion of the city commission.
  - (3) Any person who violates a provision of this section shall be prohibited from serving on a City of Key West advisory board, evaluation and/or selection committee.
  - (4) In addition to any other penalty provided by law, violation of any provision of this ordinance by a City of Key West employee shall subject said employee to disciplinary action up to and including dismissal.
  - (5) If a vendor is determined to have violated the provisions of this section on two more occasions it shall constitute evidence under City Code section 2-834 that the vendor is not properly qualified to carry out the obligations or to complete the work contemplated by any new competitive solicitation. The city's purchasing agent shall also commence any available debarment from city work proceeding that may be available upon a finding of two or more violations by a vendor of this section. (Ord.
