A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MORO MANGEMENT, INC. DBA THE "HALF SHELL RAW BAR" TO CONDUCT A "50<sup>TH</sup> ANNIVERSARY SEAFOOD FESTIVAL" AT THE PARKING LOT ON 231 MARGARET STREET ON SATURDAY, AUGUST 27, 2022 FROM NOON TO 10:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM NOON TO 10:00 P.M; AUTHORIZING THE SALE AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Moro Management, Inc. DBA the "Half Shell Raw Bar" has applied to the city for a Special Event Permit for a "50<sup>th</sup> Anniversary Seafood Festival" at the Half Shell Raw Bar on Saturday, August 27, 2022.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city

Manager to "develop language that restricts the use of polystyrene by individuals on public

property, temporary vendors on public property, or entities engaged in a contractual relationship

with the local government for the local government for the provision of good or services, unless
such use is otherwise preempted by law"

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City"

**SECTION 3.** That Moro Management, Inc. DBA the "Half Shell Raw Bar" is hereby granted permission to conduct a "50<sup>th</sup> Anniversary Seafood Festival" on the day and during the hours stated above.

PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinance the Moro Management, Inc. DBA the "Half Shell Raw Bar" is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 5.** That the Moro Management, Inc DBA the "Half Shell Raw Bar" must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

**SECTION 6.** That the Moro Management, Inc. DBA the "Half Shell Raw Bar" is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 7.** That Moro Management, Inc. DBA the "Half Shell Raw Bar" will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 8. That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and
