On April 29, 2022, at approximately 2235 hours, I (Ofc. Adorno) responded to 208 Duval St reference a theft that had occurred.

Upon arrival, I observed Ofc. Howell with one detained male on the side of Red Garter Saloon located at 208 Duval St. The male was later identified as Mihalakle Florin. Ofc. Howell stated he was doing a routine foot patrol of the 200 Block of Duval St and speaking with a nearby bouncer when he observed Florin reach into a nearby Hot Dog stand and take a hotdog. Ofc. Howell was advised Florin was kicked out of Ricks, Tree Bar and Red Garter earlier that day. Florin proceeded to eat the hot dog while walking South on Duval St. Ofc. Howell followed Florin and announced himself as a Key West Police Officer and told him to stop. Florin continued to walk. Ofc. Howell told Florin to stop walking and sit down 5 times before Ofc. Howell grabbed his arm to perform a leg sweep. Ofc. Howell failed in the leg sleep but was able to bring Florin to a nearby wall utilizing pain compliance. Ofc. Howell was only able to place one hand into handcuffs as Florin kept pulling away his free hand. Through pain compliance, Ofc. Howell was able to grab the other hand, and handcuff properly checking for proper fitting. Florin had minor scratches toward his right elbow and right eyebrow.

Sgt. J.T Conaty arrived on scene and checked Florin's injuries. Florin denied all medical treatment.

Shortly after, the owner of the hot dog stand returned and was told that Florin grabbed a hotdog without paying. The owner was later identified as Joshua Furman. Joshua stated he must have taken more than one Hotdog due to how many he had left in the stand. Joshua estimated a total of 6 hotdogs were taken. Joshua added he would like to press charges for the incident. The total amount of hotdogs taken were approximately \$60.00.

Florin was searched incident to arrest and placed in the rear of my patrol vehicle. Florin was then transported to Monroe County Detention Center without incident and handed over to Deputies for processing.

Photos were taken of the minor injuries Florin sustained during this incident and will be uploaded on Evidence.Com.

My BWC was activated during the call.

Based on the facts and evidence, I believe there is probable cause that Mihalakle Florin did knowingly and intentionally violate F.S.S. 812.014-3A Petit Theft Under \$100, by intentionally and unlawfully depriving Joshua Furman and his property, whether temporary or permanent, while not being entitled to it by eating several hotdogs, totaling to \$60.00.

Based on the facts and evidence, I believe there is probable cause that Mihalakle Florin resisted and obstructed Ofc. Howell by actively walking away while being told to stop and avoiding coming in contact with Ofc. Howell as he tried to handcuff his free arm Contrary to F.S.S 843.02 - Resisting Officer without Violence to his or her person.

On Saturday, 04/29/2022 at approximately 2207 hours; I (Ofc. Howell) was completing an area check of the 200 Block of Duval Street and I witnessed an unknown white male subject reach into the hot dog cart near the entrance of 208-C Duval Street (Red Garter Saloon) and remove a hot dog, without paying for it.

I approached the unknown white male subject and instructed him to return the hot dog, however he shoved the hot dog in his mouth. I instructed the unknown white male subject to move away from the hot dog cart and sit down on the curb at the corner of Charles Street and Duval Street. The unknown white male subject initially refused to comply stating, "No." The unknown white male subject continued to consume the stolen hot dog. I asked the unknown white male subject for a form of identification, and he continued to ignore me, again shaking his head "no." The unknown white male subject attempted to walk backward away from me. I grabbed the unknown white male subject by his left wrist and instructed him to stop. The unknown white male subject immediately became aggressive and suddenly and swiftly began attempting to pull away from me and refused to comply with my legal, lawful orders to "stop resisting." Due to the unknown white male subject's actions and level of resistance rising, I placed Florin in an arm bar and attempted to leg sweep the unknown white male subject. Due to his intoxication level, the unknown white male subject stumbled over my attempted leg sweep. At this point, I regained control of the subject, grabbing the top of his shoulder while pushing him down into a seated position, placing the unknown white male subject on the ground in a controlled manner.

The unknown white male subject appeared to calm down momentarily. I again attempted to ask the unknown white male subject for a form of identification, he again refused, shaking his head "no." The unknown white male subject then attempted to stand up several times. I instructed him to stop and stay seated. Due the unknown white male subject's continuous actions, including attempting to leave, I decided to place him in handcuffs. I grabbed the unknown white male subject is right arm and placed it in a handcuff. The unknown white male subject immediately became aggressive and suddenly and swiftly began attempting to pull away from me and refused to comply with my legal, lawful orders to "stop resisting." I rolled the unknown white male subject over, laying him down in a controlled manner. The unknown white male subject continued to attempt to struggle with me, while refusing to place his left arm behind his back. I eventually regained control of the unknown white male subject's left arm and placed it in a handcuff. I returned the unknown white male subject to a seated position and placed him against the wall of the business.

Shortly afterward, Ofc. Adorno arrived on scene. After continuously speaking with the unknown white male subject, Ofc. Adorno was able retrieve a name from the subject, Mihalakle Florin (DOB: 02/27/1987, Arrestee). Florin continued to speak with Ofc. Adorno in English and Spanish.

Florin sustained minor abrasions on his right arm, near his elbow, as well on the front side of his head, near his right

temple, due to his resistance. Florin had a small amount of blood dripping from the small abrasion on his temple. Florin refused medical attention on scene.

Florin appeared to be under the influence of alcohol. Florin's speech was slurred, and his eyes were glassy and bloodshot. Florin's breath had the odor of alcoholic intoxicants. Florin appeared to be under the influence of narcotics. Florin's speech was incoherent and unintelligible at times. Florin's pupils were contracted, and his eyes were bloodshot. Florin's balance was impaired to the point that he occasionally stumbled while walking.

Managers of Rick's Bar provided me with a security footage DVD that captured the theft and limited angles of Florin resisting while attempting to struggle with me as I handcuffed him. I submitted the copy of the Rick's Bar security footage DVD to the Key West Police Department Property and Evidence.

My BWC was activated for the encounter, theft, takedown, arrest, and subsequent search of Florin. I uploaded the videos to Evidence.com.

At this time, no further information.
