On Saturday May 28, 2022, at about 0343 hours, I, (Ofc. L. Hernandez), Ofc. W. Howell and Ofc. S. Adorno were dispatched to 1012 Fleming Street Apt. 5, in reference to an intoxicated male waving a loaded firearm around.

Upon arrival, Sgt. J. Hammers, Ofc. R. Ham, K9 Ofc. T. Anglin, Ofc. E. Andrade, Ofc. A. Litton tactically approached the residence and stood on both east and west sides of the building. Ofc. Andrade and I met with Alexandra Lynn Ramberg (DOB 09/22/1996) on the second story porch next to unit # 5. Ramberg told us that her boyfriend Kevin Michael Donnelly (DOB 05/27/1983) was handling and waving a loaded firearm that she later took possession of and took it apart. The handgun was later identified as a Glock 19 Gen 4, 9mm serial # WTD779 and it was loaded with 15 rounds at the time Kevin was waving it. Let it be known Kevin was under the influence of alcoholic intoxicants per his own admission, strong odor of alcoholic intoxicant emanating from his breath and person, bloodshot eyes, and flushed face.

Ofc. Andrade and I asked Ramberg if we can come inside to talk to Kevin, and she allowed us in. As soon as we walked inside the unit, Kevin was coming downstairs and immediately began to scream at Ramberg asking her why we were there. I told Kevin to calm down and come downstairs to talk to me. Kevin began to walk back upstairs. Due to the nature of the call and for everyone's safety I grabbed Kevin by his right arm wrist, and I asked him multiple times to come down to talk to me, but he kept pulling away. Even though Ramberg had told us she removed the Glock from Kevin and took it apart, I did not know if he had any other weapons on his person at this point. Ofc. Andrade and Ofc. Litton assisted me in detaining Kevin.

As we were trying to place Kevin in handcuffs he kept actively resisting, tensing up and pressing his arms under his abdomen to try to defeat our lawful attempts to place him in custody. Kevin was ordered multiple times to stop resisting and he did not comply. I told Kevin I was going to have to use my taser to gain his compliance and he ignored my lawful commands. I used my taser in drive stun mode on time on the left side of his abdomen. We were then finally able to place him in custody.

Kevin was still actively resisting while in handcuffs, he dropped himself on the ground and would not get up. A hobble had to be placed on Kevin as he tried to raise his legs and kick assisting officers. Kevin was asked multiple times to walk downstairs with our assistance, but he would not comply. Kevin would use his body as dead weight. Kevin tried several times to bang his head against the floor and tried to use the railing of the staircase to choke himself.

Once we got Kevin downstairs he was still screaming and tensing up not wanting to sit up. Kevin tried to slam his head against the sidewalk. I requested Key West Fire Rescue to respond to check on Kevin's vitals. Key West Fire Rescue 2 arrived on scene, but Kevin would not allow them to assist. Kevin was advised several times EMS was there to provide medical assistance, but he refused their assistance. Ofc. Ham, Ofc. Howell and I had to carry Kevin to my patrol vehicle.

Sgt. J. Hammers met with the reporting party later identified as Clarice Johanna Scarbrough (DOB 03/06/1993). Clarice said Ramberg had told her Kevin suffers from depression. Clarice showed text messages she recieved from Ramberg where Ramberg is telling her she took the gun apart. Sgt. J. Hammers uploaded the text message to Evidence.com.

Ramberg told me Kevin acted in a similar fashion a little over a year ago in New Jersey, where he was depressed and was waving a gun around. Ramberg went on to say that Kevin removed the magazine from the firearm and

handed it to her before she took it apart.

I transported Kevin to Lower Keys Medical Center Emergency Room where he was turned over to medical staff and doctor on duty. I completed the required Baker Act form and handed it to the doctor on duty.

I strongly believe Kevin was unable to determine for himself that the baker act examination was necessary. I believe that, without care or treatment, Kevin is likely to suffer from neglect or refuse to care for himself and such neglect or refusal poses an imminent threat of substantial harm to his wellbeing and others. Also, Ramberg's decision to contact law enforcement goes beyond good faith to making sure Kevin gets the help he needs.

On Saturday May 28, 2022, at about 1920 hours, I, (Ofc. L. Hernandez), and Ofc. A. Litton went to 1012 Fleming Street, reference a follow up investigation on this case.

We located Donnelly's vehicle, a 2016 Subaru Outback, blue in color, bearing Florida tag # IJUJ56. The vehicle was parked in front of 525 Grinnell Street. Inside the vehicle there was a metal safe, dark brown in color, with a numbered keypad, with multiple stickers on it. The safe is about 4 feet in length and it is believed it has multiple firearms in it.

Ramberg said there are more weapons in the safe. Earlier today I went to the County Courthouse and had the Honorable Judge Mark Jones review and sign the Risk Protection Order to seize Donnelly's weapons. Judge Jones approved and signed the order at about 1215 hours today.

Donnelly is currently at the DePoo Hospital. I contacted the hospital and spoke with nurse in charge named Angela. I advised Angela to contact Key West Police Dispatch when they are about to release Donnelly so we can meet with him and serve him with the RPO paperwork.

I called Ramberg to see if we can meet today to serve her with the RPO required documentation and gain access to the residence to retrieve the other weapons. Ramberg told me she is working and not getting home until late tonight around 11pm. I told Ramberg to let me know when she arrives her residence so we may meet. Ramberg told me she was in fear that the weapons were at the residence and mentioned several times that she wanted the weapons removed.

At about 2235 hours, Ofc. W. Howell and I, (Ofc. L. Hernandez), requested the towing of Donnelly's vehicle which was parked in front of 504 Grinnell Street. The vehicle was a 2016 Subaru Outback, grey in color, bearing Florida tag IJUJ56. The registration has been expired since 05/27/2021. The safe was secured inside the locked vehicle and evidence tape was wrapped around all the door crevices and edges of the vehicle. An inventory of valuables was also completed from the items inside the vehicle.

On Sunday May 29th, 2022, Ofc. T. Haynee and Ofc. N. Revoredo met with Ramberg and served her with the required paperwork reference the search and removal of firearms and ammunition. Multiple rifles, handguns and ammunition were collected and removed and placed in property and evidence for safe keeping. Refer to Ofc. Revoredo supplemental report for further information.

I sent out a department wide email containing a officer's safety and information BOLO reference Donnelly, briefly elaborating on this case and providing instructions on Donnelly's RPO. I also sent another email letting all officers

On 28MAY22 at 0343, I (Ofc. T. ANGLIN) responded to 1012 #5 Fleming Street regarding a depressed male, later identified as KEVIN M DONNELLY with a firearm in his hand inside the apartment. After arriving to the area, I affixed a six-foot nylon lead to K-9 JIGSAW'S one inch nylon collar and retrieved him from the rear of my patrol vehicle. While we were approaching the property, KWPD Dispatch advised that the DONNELLY'S girlfriend was able to take possession of the handgun and render it safe.

I approached the property and staged at the base of the staircase as Officers spoke with the DONNELLY'S girlfriend on the porch, which was on the second story of the structure. While I was staged at the base of the stairs, several Officers on scene entered the apartment and after several brief moments, I could hear a loud commotion from inside the apartment. I proceeded up the stairs and maintained an overwatch with K-9 JIGSAW at the doorway to the apartment as Officers handcuffed DONNELLY. Once Officers advised the subject was secured, I proceeded back to my patrol vehicle and secured K-9 JIGSAW inside. (See Axon body worn camera footage for details)

As I returned to the apartment, I once again could hear a commotion coming from inside. DONNELLY was on the floor yelling and thrashing about. I could hear Officers trying to calm DONNELLY down as he continued kicking his legs, banging his head and thrashing his body in an apparent attempt to free himself from Officer's physical control. (See Axon body worn camera footage for details)

I assisted Officers in attempting to escort DONNELLY out of the apartment. DONNELLY continued to kick and scream as well as brace his legs against the door frame and base of the staircase as his girlfriend was screaming for him to just comply. Officers finally managed to escort DONNELLY out onto the porch. DONNELLY continued to thrash his body about and began smashing Officers into items on the deck as well as the top of the railings to the stairs. (See Axon body worn camera footage for details)

Officers managed to redirect DONNELLY to a semi seated position and begin slowly guiding him down the narrow staircase. As Officers were guiding DONNELLY down the staircase, DONNELLY attempted to purposely roll his body off the side of the staircase. After Officers were able to prevent DONNELLY from purposely falling off the staircase, DONNELLY intentionally braced his head, (Under chin/neck area) on one of the banister supports in an obvious attempt to prevent himself from being guided down the stairs. Officers were able to safely guide DONNELLY away from his hold of the banister support and guide him down to the sidewalk. (See Axon body worn camera footage for details)

Once on the sidewalk, DONNELLY was laying on his left side and began purposely banging his head on the pavement and kicking his legs. Officers were able to prevent DONNELLY from banging his head on the pavement as I utilized a hobble restraint device to limit the movement of DONNELLY'S legs. Once I was able to place the hobble restraint on

DONNLEY`S crossed ankles, Officers were able to safely control DONNELLY`S legs and keep him in the recovery position in the anticipation of the arrival of Key West Fire Department personnel. (See Axon body worn camera footage for details)

Key West Fire Department personnel arrived on scene to medically evaluate DONNELLY. DONNELLY refused treatment from Fire Department personnel. Officers attempted to escort DONNELLY to the rear of Ofc. L. HERNANDEZ` patrol vehicle, which was parked directly in front of the property. DONNELLY continued thrashing his body about and yelling as Officers were forced to carry DONNELLY to the passenger`s side rear door of Ofc. L. HERNANDEZ` patrol vehicle. Once at the passenger`s side rear door, DONNELLY refused to enter the patrol vehicle and Officers had to safely lift DONNELLY inside as he continued to resist their efforts. Officers were able to secure DONNELLY in the rear of Ofc. L. HERNANDEZ` patrol vehicle without further incident. (See Axon body worn camera footage for details)

I gathered information for my report and departed the scene.

At no time did I conduct an interview of DONNELLY or his girlfriend.

My Axon body worn camera was active during this incident and uploaded into the server.

On May 28, 2022, at approximately 0346 hours, I, Ofc. S. Ham arrived at 1012 Fleming St., as a backup unit.

Upon arrival, I stood by downstairs at the north-west corner of the apartment with Ofc. S. Adorno. Ofc. Adorno and I made our approach to the steps on the north-east corner. I heard what sounded like a disturbance going on up the stairs inside the apartment. Upon entering the front door, I saw Ofc. Hernandez straddling the male's (Kevin Donnelly) right leg, attempting to handcuff him. Kevin was laying down on the couch. Kevin was not complying with Ofc. Hernandez's verbal commands. Kevin's legs were flailing beneath Ofc. Hernandez. I secured Kevin's right leg to prevent him from kicking anyone. Kevin was escorted to the ground inside the living room, and he continued kicking his legs.

I retrieved the hobble from the back of my patrol vehicle. Upon carrying the hobble upstairs, it was determined that Kevin was going to attempt to walk down the stairs on his own. We attempted to get Kevin to stand but he refused. I controlled Kevin's legs as we attempted to carry him through the front door. Kevin stuck his right leg out to the side and placed it on the wall to prevent us from carrying him outside. I readjusted Kevin's right leg to fit him through the door. Once on the balcony, Kevin refused to cooperate and continued to resist.

I had control of Kevin's right leg and assisted in trying to carry Kevin down the stairs. Kevin continued to pull and attempt to get loose from our grasp. I was walking down the stairs backwards while Ofc. Hernandez was in between Kevin and I, also walking backwards. Once we reached the bottom of the staircase, we laid Kevin down on the sidewalk on his side in the recovery position. Kevin lifted his head and struck it against the concrete approximately twice. Kevin then began flailing his legs again and tried rolling himself on his stomach. K9 Ofc. T. Anglin and I applied the hobble to Kevin's ankles to control his legs. I controlled Kevin's feet by placing downward pressure on his ankles. Kevin continued to try and push myself and Ofc. N. Howell off and roll over on his stomach. We maintained control of Kevin while we awaited Key West Rescue to respond and evaluate Kevin.

Upon arrival of Key West Rescue personnel, Kevin was being uncooperative towards rescue personnel and would not allow them to evaluate him.

I assisted in carrying Kevin to Ofc. Hernandez's patrol vehicle. Kevin would not get inside the backseat of the patrol vehicle freely. I maintained control of Kevin's legs and placed them inside the backseat of the patrol vehicle first. Kevin pressed his feet against the back of the front seat and straightened his legs to prevent us from getting him inside the car. I struck the sciatic nerve on the backside of Kevin's thigh with a hammer fist in an attempt to bend his knee. Kevin immediately locked his knees back out. I reached into the backseat and shifted Kevin's feet to the floor of the patrol car. Ofc. Howell and Ofc. Hernandez assisted me in getting the rest of Kevin's body inside the vehicle.

On 05/28/2022 at approximately 0400 hours, I (Ofc. A. Litton) responded to 1012 Fleming Street, apartment 5, in reference to an armed suicidal subject.

When we arrived, Alexandra Ramberg was standing on the balcony in front of her apartment. Officer E. Andrade and Officer L. Hernandez made first contact with Ramberg who allowed them into the apartment to meet with her boyfriend, Kevin Donnelly. When I went to the top of the stairs as Donnelly spoke with Officer L. Hernandez and Officer E. Andrade, he was standing partially up a set of stairs which led to Donnelly's bedroom loft, where the supposedly disarmed pistol was located. Donnelly was backing away from officers, moving up the stairs. Donnelly was defying orders to come down the stairs as he attempted to move further up them.

I walked into the apartment and grabbed Donnelly's left arm and walked him down the stairs. Donnelly attempted to pull away from Officer L. Hernandez, Officer E. Andrade and I, so we directed him face down onto the couch, which was located behind us. Officer E. Andrade and I helped control Donnelly's arms as Officer L. Hernandez placed him in handcuffs. Donnelly was subsequently drive-stunned by Officer L. Hernandez as he refused to cooperate or comply with any commands given. For the remainder of the incident, Donnelly remained extremely defiant, difficult, and in no way cooperated with law enforcement.

Once Donnelly was eventually moved out of the apartment and downstairs, I spoke with Ramberg who explained in more detail why we were called. Ramberg explained she was out drinking alcohol with Donnelly for his birthday when they came home together. Ramberg said when she came out of the bathroom, from upstairs in the bedroom area she heard, what she believed was, the slide action of Donnelly's pistol as he chambered a round. Ramberg said she went upstairs and saw Donnelly visibly upset with the pistol in his hand on his lap. Ramberg stated she did not know why Donnelly would be upset at this moment but stated he suffers from depression from losing a parent while he was in his 20's. Ramberg also stated this was similar to an incident that occurred about a year prior when she removed a pistol from Donnelly as he pointed it at his own head. Ramberg stated no words were exchanged between Donnelly and her. Ramberg stated Donnelly looked at her, removed the magazine from the pistol, and handed the magazine and pistol to her. Ramberg then called a friend to call the police, so she was not seen by Donnelly.

Ramberg allowed me to go upstairs to her and Donnelly's bedroom area where I saw a large rifle case, eight ammo boxes, and another plastic bucket with a lid all gathered in a corner of the bedroom. Ramberg stated they contain numerous antique guns that were gifted to Donnelly, since he is considered a gun fanatic. Ramberg also stated Donnelly has a large safe in his car that contains approximately a dozen firearms. Ramberg informed Officer J. Lopez and I that only Donnelly knows the combination to the safe.

With the help of the panic button on the key fob, Ramberg eventually showed Officer J. Lopez and me to Donnelly's

On Saturday, 05/28/2022 at approximately 0341 hours; K-9 Ofc. Anglin, Ofc. Litton, Ofc. Hernandez, Ofc. Ham, Ofc. Andrade, Ofc. Adorno and I (Ofc. Howell) were dispatched to 1012-5 Fleming Street regarding an unknown male subject possibly attempting to harm himself and his girlfriend with a firearm.

Ofc. Litton, Ofc. Hernandez, Ofc. Ham, Ofc. Andrade, Ofc. Adorno, and I encountered Alexandra L. Ramberg (DOB: 09/22/1996, Involved Other) who stated her boyfriend was really upset and waving a gun around. Ramberg stated she was able to "get the weapon away from her boyfriend" and that it was "in pieces." At this point, Sgt. Hammers also arrived on scene. Ofc. Litton, Ofc. Hernandez, Ofc. Andrade and Ofc. Adorno immediately entered the residence and encountered Kevin M. Donnelly (05/27/1983, Involved Other) on the staircase leading up to a loft bedroom. Sgt. Hammers and I covered the doorway until Donnelly became aggressive and noncompliant. Donnelly immediately became aggressive and suddenly and swiftly began attempting to pull away from Ofc. Litton, Ofc. Hernandez, Ofc. Andrade, and Ofc. Adorno. Donnelly refused to comply with their legal, lawful orders to "stop resisting." At one point, Donnelly attempted to climb up the stairs, toward the firearm. Due to Donnelly's actions, continuous threats, and level of resistance rising Ofc. Litton, Ofc. Hernandez, Ofc. Andrade, and Ofc. Adorno removed Donnelly from the staircase and place him on the couch in a controlled manner. Sgt. Hammers and I continued up the staircase to clear the upstairs loft bedroom. Donnelly continuously struggled with Ofc. Litton, Ofc. Hernandez, Ofc. Andrade, Ofc. Adorno. Donnelly refused to be placed in handcuffs. Due to Donnelly's actions and level of resistance rising while refusing to be placed in handcuffs, Ofc. Hernandez drive stunned Donnelly on the left side of his torso. Ofc. Litton, Ofc. Hernandez, Ofc. Andrade, and Ofc. Adorno were eventually able to gain control to Donnelly and place him in handcuffs.

Sgt. Hammers and I discovered the firearm at the top of the staircase, on a shelf to the left as you entered the loft bedroom. I took photographs of the firearm and the immediate area. I secured the firearm. I uploaded the photographs to Evidence.com.

Donnelly remained argumentative and noncompliant, refusing to walk down the stairs that exit the residence. Ofc. Litton, Ofc. Hernandez, Ofc. Ham, Ofc. Andrade, Ofc. Adorno, and I had to pick up Donnelly and carry him down the stairs. Donnelly remained combative throughout the incident, attempting to drag his head and face on the railing of the stairs at one point. As we were able to return to the ground level, we placed Donnelly in the recovery position. Donnelly continuously attempted to sit up, kick his legs and feet, and pull away from Ofc. Ham, Ofc. Andrade, Ofc. Adorno and me. Due to Donnelly's actions and level of resistance rising, Donnelly was placed in a hobble to prevent him from kicking and for officer safety. Donnelly continuously attempted to roll over on his stomach and strike his head on the concrete sidewalk until Key West Fire/Rescue arrived to medically evaluate Donnelly. Donnelly again became aggressive and refused to be treated by Key West Fire/Rescue.

As we arrived at Lower Keys Medical Center and attempted to remove Donnelly from Ofc. Hernandez's patrol vehicle, Donnelly again became aggressive and combative while we place him in a wheelchair. Donnelly remained aggressive and combative until medical staff medicated Donnelly.

My BWC was activated for the encounter, use of force concerning Donnelly, and Donnelly's aggressive/combative behavior. I uploaded the videos to Evidence.com.

The male was combative, and he was actively resisting the Officers. I placed my knees on top of the male's legs to stop him from trying to kick myself and the other Officers.

The female in this residence was later identified with her Florida driver's license as Alexandra Ramberg, 09/22/1996). The male in this residence was later identified with his Florida driver's license as Kevin Donnelly, (dob:05/27/1983).

I spoke with Alexandra, and she told me she has been dating Kevin for approximately three years. Alexandra said they went Downtown to celebrate Kevin's birthday. Alexandra said they have been drinking since 1100 hours this morning. Alexandra told me they went to several bars today and Kevin was fine. Alexandra told me they went to Mr. Z's to get pizza and then they walked home. Alexandra said she heard a sound as if someone was racking a firearm. Alexandra said she was in the kitchen, (Downstairs) and she heard the sound emanating from the room, (Upstairs). Alexandra said Kevin was the only person upstairs. Alexandra said she walked upstairs, and she saw Kevin seated on the bed holding a gun with his hand. Alexandra said she asked Kevin why he is doing this, and Kevin could not answer her. Alexandra said Kevin did not treat her with the gun. Alexandra told me she tried to talk to him out of it and then Kevin disarmed the gun and Kevin handed it to her. Alexandra said she called her coworker because she did not what to do. Alexandra told me she then put the gun away.

I asked Alexandra if Kevin said anything tonight or something that made him feel depressed and Alexandra said, "No". I asked Alexandra if Kevin is currently taking any medication and Alexandra said, "No". I asked Alexandra if Kevin has a Doctor and Alexandra said, "No".

Alexandra said she has not seen Kevin act this way before. Alexandra said she did not recognize Kevin tonight by the way Kevin was resisting the Officers on scene.

Alexandra told me approximately a year ago Kevin held a gun to his head. Alexandra said Kevin locked himself in a room in New Jersey. Alexandra said she had to break the door to get to Kevin. Alexandra said Kevin did not follow through with his plan and she was able to talk Kevin out of it. Alexandra said Kevin suffers from depression due to several family members passing away. However, Kevin does not share much with Alexandra about his emotions.

On May 29, 2022, at approximately 0345 hours, I (Ofc. Adorno) responded to 1012 Fleming St in reference to a male that was carelessly waving his firearm around inside his house while arguing with his girlfriend.

Upon arrival, Key West Police Officers entered the house after being invited inside by the reporting person, identified as Alexandra Ramberg. At this time, Key West Police Communications Channel 1 advised the reporting person had disassembled the weapon and made it safe.

As I entered the residence, I noticed multiple officers attempting to calm down an adult male, later identified as Kevin Donnelly. Donnelly continued to resist as 4 officers advised him to place his hands behind his back. Using pain compliance, the officers were able handcuff Donnelly. After Donnelly was handcuffed, multiple officers attempted to talk to him to try to get him to calm down. While speaking with Donnelly, he continued to be uncooperative and began to extend his lower half and attempt to kick the officers on scene. At this time, I joined the group of officers and held down his left leg, with another officer holding his right leg. As minutes went by, Donnelly continued to move agitatedly trying to free himself from the handcuffs. During this time, Donnelly began to slam the right side of his head onto the floor. An officer on scene secured his head so Donnelly can no longer injure himself. Donnelly was advised rescue was on the way to check for any injuries and that we would need his help to walk down the stairs. As we lifted Donnelly, Donnelly decided to not use his lower limbs and continued resisting as the officers held him. Donnelly was carried outside to the stairs shortly after. Donnelly was advised once again we needed his help to get him downstairs so that he does not get injured. Donnelly continued to yell at the officers on scene and verbally assault them. As the other officers on scene and I carried Donnelly down the stairs, Donnelly pressed his right leg against the railing of the stairs to stop himself from being carried downstairs. At this time, we sat Donnelly on the stair steps and proceeded to guide him down. After a few more steps, Donnelly continued to actively resist by trying to lean over the side of the stairs. After pulling Donnelly back onto the steps, we were able to lower him down to the last step. At the bottom of the steps, officers on scene placed him in recovery position until Key West Rescue arrived on scene. While placing him into position, Donnelly continued to frail his lower half attempting to kick other officers. Ofc. Howell and I once again held down Donnelly's legs so that a hobble could be placed on him. During this time, Donnelly once again began to slam his head onto the concrete. Ofc. Andrade placed his boot under his head to protect Donnelly from any other injuries.

Donnelly was placed into Ofc. Hernandez patrol vehicle and transported to Lower Key Medical Center.

I packaged the firearm and ran the serial number through Key West Police Communications Channel 1 with negative wants. The firearm and rounds were submitted into property and evidence.

The firearm was a Black Glock 19 Gen 4 .9mm with 15 rounds inside the magazine. The firearm had a serial number of WTD779.

On Wednesday, May 28, 2022, at approximately 0346 hours, I (Ofc Andrade) responded to 1012 Fleming St Apt 5, reference an armed subject.

On arrival, myself and Ofc Hernandez met with Alexandra L. Ramberg who stated the following:

The gun was upstairs "taken apart" and her boyfriend was in the apartment (later identified as Kevin M. Donnelly) and was very upset. Ramberg said she did not know what was going on or why Donnelly was so upset, only that he was in a "dark place." Ramberg added that Donnelly did not at all point the gun at her but did at himself. Ramberg then invited us in to speak with Donnelly.

Ofc Hernandez and I entered the apartment where we found Donnelly partially up the staircase that was to the left immediately as you walk in. Ofc Hernandez identified himself and asked Donnelly to please come down the stairs so we could talk. Donnelly then began to go up the stairs and Ofc Hernandez grabbed Donnelly's left arm and Donnelly stopped and held the railing with his left hand. Ofc Hernandez informed Donnelly that he was not in trouble and asked him to relax, again telling him we just wanted to talk. Donnelly began to pull away from Ofc Hernandez in an attempt to go up the stairs. I immediately grabbed a hold of Donnelly's left arm. Ofc Litton, who was also on scene also grabbed a hold of Donnelly's left arm with me. Ofc Hernandez, Ofc Litton, and I began to walk Donnelly to a nearby couch as we placed his hands behind his back. Donnelly was resisting the entire time by trying to pull his arms away. We placed Donnelly face down into the couch. Ofc Hernandez repeatedly asked Donnelly to stop resisting and relax.

Ofc Hernandez was able to apply a handcuff to Donnelly's right wrist. Ofc Litton and I maintained control of Donnelly's left arm. Donnelly then began to bring his right arm towards the front of his body pulling it away from Ofc Hernandez. I released Donnelly's left arm and assisted Ofc Hernandez in regaining control of Donnelly's right arm, bringing his right hand behind his back. Donnelly then grabbed a hold of the handcuff that was not yet on his left wrist, with his left hand preventing its use. Ofc Hernandez asked Donnelly to let go of the handcuff several times; Donnelly did not comply. Ofc Hernandez had to drive stun Donnelly in order to have him release the handcuff, which he did. I was then able to apply that handcuff to his left wrist.

Ofc Litton and Ofc Hernandez then assisted Donnelly from the couch to floor, sitting him down. Donnelly then abruptly pulled away from Ofc Litton who was standing behind him with his hands on Donnelly's shoulders, yelling "Don't touch me." Ofc Lopez knelt and attempted to speak with Donnelly while holding Donnelly's right leg down. Donnelly began to pull his leg away at which point Ofc Lopez gained control of both of his legs with the assistance of other officers on scene. Donnelly tensed his body and tried to sit up. I used head control and was able to lay Donnelly's torso down on his right side. Donnelly kept trying to kick his legs, tense his body, and pull away from our control. Donnelly then began to bang his head on the floor, saying that I was banging his head. I held Donnelly's head

against the floor to prevent him from banging it until he calmed down.

I asked Donnelly to please stand up and come downstairs with us and informed him we were going to stand him up. Donnelly fought against our efforts to get him to his feet, pushing and pulling away from us, tensing his body, and making himself "dead weight." In order to get Donnelly outside the apartment, he had to be carried. While attempting to carry Donnelly outside, he placed his right foot against the wall next to the door, preventing his exit. I had to pull Donnelly's leg away from the wall causing my body camera to fall off. Once outside on the front porch Donnelly remained uncooperative and actively resisted our efforts to go downstairs and was applied a hobble around both ankles. Donnelly had to be carried down the stairs feet first. I held Donnelly from the shoulders as we went down the staircase. Donnelly continued to pull away from me, twisting his body, as we went down the stairs.

Once on the sidewalk we placed Donnelly into the recovery position, on his left side. Donnelly then began to bang his head on the ground. I held Donnelly's head down until he calmed down. I then slipped my right foot between the ground and his head, preventing the possibility of him banging it against the ground.

Key West Rescue arrived on scene and Donnelly refused treatment. We then carried Donnelly to Ofc Hernandez's patrol car and placed him into the back seat. Donnelly resisted our efforts of placing him in the back seat by tensing his body, attempting to stay erect.

Ofc Hernandez transported Donnelly to Lower Keys Medical Center. Ofc Howell and I rendezvoused with Ofc Hernandez at Lower Keys Medical Center. We attempted to escort Donnelly from the backseat, but Donnelly refused to comply causing us to carry Donnelly out of the backseat and into a wheelchair. We then wheeled Donnelly into the building to be evaluated by medical personnel. Donnelly remained aggressive, argumentative, and noncompliant the entire time I was at the medical center with him. Medical staff had to sedate Donnelly twice before they could render treatment.
