A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "STATE FLORIDA DEPARTMENT OF ECONOMIC FEDERALLY OPPORTUNITY FUNDED COMMUNITY DEVELOPMENT BLOCK GRANT MITIGATION **PROGRAM** SUBRECIPIENT AGREEMENT" (CDBG-MIT) MT010 FOR CITY OF KEY WEST COMPREHENSIVE ADAPTATION AND RESILIENCE **IMPLEMENTATION** PLAN, IN A TOTAL AMOUNT UP TO \$500,000.00 FEDERAL/\$394,438.00 CITY MATCH (\$894,438.00 TOTAL ESTIMATED PROJECT COST); AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT, AND TO APPROVE AND EXECUTE ANY SUBSEQUENT AMENDMENTS THAT MAY ADJUST THE GRANT FUNDING ALLOCATIONS TO THE CITY OR MODIFY THE PROJECT SCOPE, UPON CONSENT CITY ATTORNEY; AUTHORIZING NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS TO ACCEPT THE FUNDING; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 18-205, the City Commission authorized applications for FEMA Hazard Mitigation Grant Program (HMGP) and Community Development Block Grant (CDBG) funds for certain essential City infrastructure projects, including long-term planning included in certain sections of the City of Key West Comprehensive Adaptation and Resilience Implementation Plan; and

WHEREAS, the Florida Department of Economic Opportunity (DEO) is administering CDBG-MIT funds, which are federally awarded by the United States Department of Housing and Urban Development (HUD), to support long-term mitigation efforts following declared disasters in 2016 and 2017 through HUD's Community Development

Block Grant (CDBG) Disaster Recovery Program; and

WHEREAS, the City of Key West was awarded funds for the following sections of the 10-year plan: Environmental Restoration, Economic Redevelopment, Housing and Shelter, Land Use and Codes, Power and Water, Health and Equity; and

WHEREAS, Agreement No. MT010 CDBG-MIT funds will reimburse up to \$500,000.00 (36%) for the Adaptation and Resilience Implementation Plan, which will be matched with City funds in the budgeted for the Stormwater Master Plan (\$200,000.00), in-kind staff time (\$194,438.00), and funding through FDEP's Coastal Resilience Program (\$905,000.00) will complete the balance (4%) of the Plan funding; and

WHEREAS, local legislative approval is necessary to allow City staff to accept such funding; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "State of Florida Department of Economic Opportunity Federally Funded Community Development Block Grant Mitigation Program (CDBG-MIT) Subrecipient Agreement" Number MT010 for the City of Key West Comprehensive Adaptation and Resilience Implementation Plan is hereby approved in an amount of up to \$500,000.00, plus City matching funds of up to \$394,438.00 (budgeted and in-kind staff hours).

Section 2: That the Mayor is authorized to execute the Agreement and related documents, and any subsequent amendments that may adjust funding or the project scope, upon the advice and consent of the City Attorney.

Section 3: That necessary budget transfers or adjustments to accept the grant funding are hereby authorized. This project is budgeted to a maximum reimbursement amount of \$500,000.00 in grant revenue to account 108-0000-331-9000 (Adaptation and Sustainability/Revenue/Other Federal Grants), and expense account 108-3806-538-3100 (Adaptation and Sustainability/Adaptation/Professional Services).
