A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING DAILY PLAN-IT TO CONDUCT A FANTASY MARKET AT THE TRUMAN WATERFRONT GREEN FIELDS NEXT TO SPLASH PAD ON FRIDAY, OCTOBER 28, 2022 FROM 10:00 A.M. TO 5:00 P.M. AND SATURDAY, OCTOBER 29, 2022 FROM 2:00 P.M. TO 7:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS the Daily Plan-it has applied to the city for a Special Event Permit for a Fantasy Market at the Key West Truman Waterfront Green Fields next to the Splash Pad on Friday, October 28, 2022, and Saturday, October 29, 2022.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law”

SECTION 2. “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “To go” packages for food or products sold on any property leased from the City”

SECTION 3. That Daily Plan-it is hereby granted permission to conduct a “Fantasy Market” on the day and during the hours stated above.

PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinance the Daily Plan-it is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That Daily Plan-it must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least ten (10) days in advance.

SECTION 6. That Daily Plan-it will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 7. That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
