On Saturday 06/18/2022 at approximately 2151 hrs. I (Ofc. E. Roberts) observed William Parlaman sitting on the sidewalk next to the Publix Liquor Store at Key Plaza (2900 N. Roosevelt Blvd) while on routine patrol.

Parlaman was known to me from previous encounters, the most recent being on the previous evening of Friday 06/17/2022 where I issued Parlaman a trespass warning for the property at Key Plaza.

When I approached Parlaman there was a partially empty 1.75-liter bottle of Calypso Silver Rum sitting next to him. When I asked what he was doing there, Parlaman replied "Having some drinks." Parlaman displayed symptoms of severe intoxication from alcoholic beverages. His speech was heavily slurred, his eyes were very glassy, watery and blood-shot as well as a strong odor of alcoholic beverages emanating from his person.

I ordered Parlaman to stand and he began to fall against the wall as he stood. I searched Parlaman's person while he held himself up on the wall. I then ordered Parlaman to place his hands behind his back. Parlaman attempted to pull his right arm away from my custodial grasp. He continued this resistance momentarily and then submitted to hand restraints. I double locked the handcuffs and began to escort Parlaman to my patrol car. Parlamn braced his body and refused to walk. He then began to attempt to pull away from my custodial hold. After failing to release himself from my grasp, Parlaman attempted to fall to the ground. I persisted my control of his body in order to prevent any injury and slowly lowered him to the ground.

Ofc. J. Torrecillas arrived on scene as I assisted Parlaman from a lying position and into a seated position. Ofc. Torrecillas and I assisted Parlaman to his feet and continued the escort to my patrol car. Once we reached the rear passenger door of my patrol car Parlaman continued his resistance and refused to enter the vehicle. I lifted Parlaman into the seat of the patrol car. Once in the vehicle Parlaman refused to sit back so that I could secure his seat belt by leaning forward in his seat. I attempted to use pain compliance techniques by applying pressure to the hollow under his ear as well as the hollow under his neck at his collar bone. The pressure points were unsuccessful. I then used my left forearm to push his chest back in the seat and secured his seatbelt.

It should be noted that Parlaman was verbally aggressive throughout the encounter after he was placed in handcuffs. He repeatedly used profanities as well as misplaced racial slurs and insults such as "Cock sucker", "Bitch-ass" and "Fucking nigger". He continued this behavior with Detention Staff at MCDC.

I transported Parlaman to the Monroe County Detention Center.

Due to the above stated facts, I find probable cause that William Parlaman did willingly and knowingly commit the following:

Defies an order to leave, personally communicated to the offender by the owner of the premises or by an authorized person, or trespasses on property other than a structure or conveyance contrary to FS 810.09 (2) b,

and

Resist, obstruct, or oppose any officer or other person legally authorized to execute process in the execution of legal process or in the lawful execution of any legal duty, without offering or doing violence to the person of the officer contrary to FS 843.02,

and

Drink from an open container of an alcoholic beverage and be under the influence of said beverage while upon a
