A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING ATTACHED "STATE OF FLORIDA DEPARTMENT ECONOMIC OPPORTUNITY FEDERALLY **FUNDED** COMMUNITY DEVELOPMENT BLOCK GRANT MITIGATION PROGRAM SUBRECIPIENT AGREEMENT" (CDBG-MIT) NUMBER IR043 FOR THE 10<sup>th</sup> CONSTRUCTION OF HARRIS AND STREETS STORMWATER IMPROVEMENTS PROJECT, IN A TOTAL AMOUNT UP TO \$1,376,270.00; AUTHORIZING THE TO EXECUTE THE AGREEMENT, MAYOR AND APPROVE AND EXECUTE ANY SUBSEQUENT AMENDMENTS THAT MAY ADJUST THE GRANT FUNDING ALLOCATIONS TO THE CITY OR MODIFY THE PROJECT SCOPE, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS TO ACCEPT THE FUNDING; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 18-205, the City Commission authorized applications for FEMA Hazard Mitigation Grant Program (HMGP) and Community Development Block Grant (CDBG) funds for certain essential City infrastructure projects, including the stormwater improvements project at Harris and 10<sup>th</sup> Streets; and

WHEREAS, the Florida Department of Economic Opportunity (DEO) is administering CDBG-MIT funds, which are federally awarded by the United States Department of Housing and Urban Development (HUD), to support long-term mitigation efforts following declared disasters in 2016 and 2017 through HUD's Community Development Block Grant (CDBG) Disaster Recovery Program; and

WHEREAS, the City of Key West was awarded funds for construction activities related to stormwater improvements at Harris and 10th Streets, to protect residential properties from future storm and flood damage in that low-lying area of approximately 28.69 acres that collects significant runoff from higher ground; and

WHEREAS, Agreement No. IR043 CDBG-MIT funds will provide reimbursement up to \$1,376,270.00 of construction costs. Pending FEMA approval of design, additional Hazard Mitigation Grant Program (HMGP) funds may also be awarded to cover a portion of construction costs for this project; and

WHEREAS, local legislative approval is necessary to allow City staff to accept such funding; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "State of Florida Department of Economic Opportunity Federally Funded Community Development

Block Grant Mitigation Program (CDBG-MIT) Subrecipient Agreement"

Number IR043 for the construction of Harris and 10<sup>th</sup> Street

Stormwater Improvements Project is hereby approved in an amount of up to \$1,376,270.00.

Section 2: That the Mayor is authorized to execute the Agreement and related documents, and any subsequent amendments that may adjust funding or the project scope, upon the advice and consent of the City Attorney.

Section 3: That necessary budget transfers or adjustments to accept the grant funding are hereby authorized. This project is budgeted to a maximum reimbursement amount of \$1,376,270.00 in grant revenue to account 402-0000-331-3602 (Stormwater Utility/Revenue/FEMA Grant), and expense account 402-3802-538-6500 (Stormwater Utility/Construction/Construction in Progress), Project ST38022102.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
