An Ordinance of the City of Key West, Florida, adopting an Ad Valorem Tax General Municipal Millage Rate for FY 2022-2023; Providing for severability; Providing for repeal of inconsistent provisions; Providing for an effective date.

A motion was made by Commissioner Davila, seconded by Commissioner Hoover, that the final adopted ad valorem tax general municipal millage rate for FY 2022-2023 is hereby set at (2.0822 mills \$2.0822 per thousand dollars of assessed property value). The 2022-2023 final adopted millage rate is equal to 10.0 percent more than the rolled back rate of 1.8929 mills (\$1.8929 per thousand dollars of assessed proerty value) and that the Ordinance be passed to Second Reading .
