On August 15, 2022, at approximately 1600 hours, Ofc. Johnson and I (Ofc. Stutz) were dispatched to 1016 Varela St. Rear for a report of a suicidal subject. While en route, Key West Police Dispatch advised Carla Fry, the mother of the suicidal person, had contacted the police after her daughter, Olivia Fry, made several threats to kill herself via text. Carla also advised that Olivia had a lengthy history of suicidal ideations and that she threatened to jump into traffic if she saw police coming to the residence.

Ofc. Johnson and I arrived on scene and began to approach the residence. Carla approached in her vehicle and relayed further information about Olivia's past mental health history. Carla also warned that Olivia may refuse to answer the door, but she had a key if needed. Carla requested we not make Olivia aware that she was in the area as Olivia has been violent toward her in the past.

Ofc. Johnson and I then made contact with Olivia in an upstairs apartment at the rear of the property. Initially, Olivia refused to identify herself, refused to exit the apartment, and stated she did not want to talk to police. I spoke to Olivia briefly and was able to get her to exit the residence voluntarily. Upon talking to Olivia outside the residence, she told me of her long history with the mental health system. I asked Olivia if she was thinking about hurting herself. Olivia stated she has been having suicidal ideations since the time she was 7 years old, Olivia is currently 20 years old. As I continued to speak to Olivia, I discussed with her the need for mental health evaluation. Olivia stated she understood her need for evaluation but was reluctant to go voluntarily for treatment.

Ofc. Johnson stood by with Olivia while I met with Carla to determine what Olivia had stated to her. Carla then showed me multiple text messages from Olivia, which were sent over the course of several hours. Olivia sent 9 separate text messages stating "I'm going to kill myself." Olivia's last text message was giving her mother her funeral and organ donation preferences. Carla stated Olivia then stopped responding via text or telephone calls and she contacted the police department and the Guidance Care Center.

I was the approached by Guidance Care Center Counselor Kelly Bedard. Kelly advised that he had been contacted earlier in the day in reference to Olivia being confrontational with Carla and using suicidal language. Kelly advised he came to the residence and conducted an evaluation and spoke to Olivia. Kelly stated that at that time Olivia had calmed down and did not appear to be a threat to herself or others. Kelly stated that since that time Olivia continued to make suicidal comments to Carla and there was a fear she may become harmful to herself or Carla.

After meeting with Carla and Kelly, I returned to speak to Olivia. I again addressed her need for care and asked her if she wanted to go to DePoo Hospital for a voluntary examination by a mental health counselor. Olivia stated she understood her need to go, but advised that if she went voluntarily and told them the truth about her suicidal ideations then she knew the Doctors would Baker Act her. Olivia's boyfriend, later identified as Jordan Boerger, arrived on scene and also tried to request Olivia seek immediate treatment. I later spoke to Jordan who advised that Olivia had sent him messages that she was going to kill herself and to not come to the residence because she didn't want him to find her body.

At that time, since Olivia would not go voluntarily, after being advised of her need for treatment, and her comments about self harm I attempted to take her into custody as a Baker Act. Upon taking her arm, Olivia began tensing and pulling away. Olivia pulled her arms into her chest in an attempt to keep from being taken into custody. Ofc. Johnson and I made multiple attempts to place her hands behind her back while giving her loud verbal commands to stop resisting. Olivia continued to resist and went to her knees. As she offered continuous resistance she was placed on her stomach and ultimately handcuffed, double locked. As Olivia was struggling, both Jordan and Carla

told Olivia to stop resisting and to go with us to be evaluated.

Olivia had a small abrasion on her right shoulder and was treated on scene by Key West Rescue. Sgt. Siracuse also responded to the scene and I briefed him about the response to resistance incident.

I placed Olivia into my patrol car and transported her to Depoo Hospital for evaluation. While en route, Olivia made multiple further statements that she was going to kill herself.

While being evaluated for in-take at DePoo Hospital, Olivia tested positive for COVID and was ultimately denied entry and was referred to Lower Keys Medical Center. I contacted Key West Rescue to assist with transport due to Olivia's new found medical condition. Olivia was transported to the Emergency Department at Lower Keys Medical Center for both COVID treatment and the Baker Act.

I completed the Baker Act forms and Olivia was left at the Lower Keys Medical Center for further treatment and evaluation.

My Body Worn Camera and Fleet Camera were activated for this incident and later entered into Key West Police Department Property and Evidence Section.

On August 15, 2022, at approximately 1543 hours, I (Officer Johnson) was dispatched as a back up unit to 1016 Varela St in reference to a person making threats of suicide.

Upon arrival, I was flagged down by a woman claiming to be the mother of the person making threats of suicide (later identified as Olivia). The mother provided directions to Olivia's room. Officer Stutz attempted to contact Olivia by knocking on her door. Olivia was reluctant to open the door. Oliva refused at first, but Officer Stutz managed to convince her to come out on the conditions that I walk down the alley way and stayed out of her sight. I moved down the alley maintain visual of Officer Stutz. I observed Officer Stutz talking to Olivia, but I could not hear most of the conversation.

Once Officer Stutz finished his conversation he left and asked me to talk to Olivia about our mounted patrol program. I asked Olivia if she was going to be ok for the rest of today. Olivia stated, "I mean I am not going to tell you no; you know." and nervously laughed after that statement. I advised Olivia that we could find her help and she stated, "I just don't want to get baker acted or put in outpatient again."

Officer Stutz returned and attempted to convince Olivia to voluntarily get treatment. Olivia refused to get treatment. Olivia was advised that she must go get treatment. Olivia refused and tried to walk away. Officer Stutz and I then began to physically detain her. Olivia attempted to pull away multiple times and stated "no" multiple times. Olivia dropped to the ground to avoid being arrested. Olivia Pulled and twisted her arms to evade arrest. Officer Stutz and I repositioned her to her stomach for better control to make the arrest. Olivia continued to pull away and tense to avoid arrest. I told Olivia to put her hands behind her back. My body camera was knocked off and fell to the ground during the resistance. Olivia was able to grab ahold of the handcuffs and would not let them go. I told Olivia to let go of the handcuffs. Eventually we were able to free the handcuffs from her grip and place them on her wrists. Olivia tried to tighten the handcuffs around her wrist. I told Olivia to stop tightening the handcuffs. I told Olivia to stop so I could double lock the handcuffs to keep them from tightening.

Olivia continued to resist while walking to the police car. Olivia pulled away and tried to turn around multiple times. Olivia was placed in the back of the patrol car but refused to put her feet in. Olivia Complained about her handcuffs causing her pain and were adjusted several times. A supervisor was requested and responded to the scene. Rescue responded to the scene. While Olivia was being looked at by rescue, she pulled the handcuffs from behind her back under her legs and brought them up in front of her body.

Olivia had several minor injuries after the arrest. Olivia had scrapes to the left shoulder, back and some impression marks on her wrists from the handcuffs. Olivia also had several preexisting injuries over her body including knees, back and arms. The preexisting injuries appeared to be mostly bruising and old abrasions. Olivia stated that some of the injuries she had were preexisting.

The handcuffs were repositioned behind her back, and she was taken to Depoo hospital. Incident was recorded by body worn camera.
