# Sand Key, Rock Key, and Eastern Dry Rocks Sanctuary Preservation Areas, and Sand Key Nursery Restoration Area

**Eastern Dry Rocks SPA:** Protects spur and groove as well as deeper bank reef habitats that historically supported thickets of ESA-listed elkhorn coral. Currently contains remnant populations of ESA-listed star corals and a diverse assemblage of other boulder and plating coral species. Important site for ongoing restoration of ESA-listed elkhorn and staghorn corals. This is one of the 7 Mission:Iconic Reef sites. This zone was originally designed to limit consumptive activities and separate users engaged in different activities.

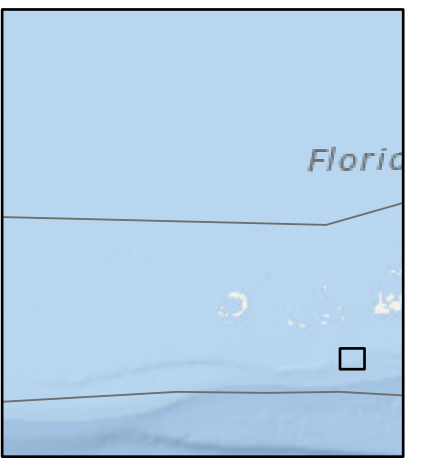
**Sand Key SPA:** Protects spur and groove as well as deeper bank reef habitats that historically supported thickets of ESA-listed elkhorn coral. Currently contains a high abundance of large ESA-listed star corals, a single remaining ESA-listed pillar coral and a diverse assemblage of other boulder and plating coral species. Important site for ongoing restoration of ESA-listed elkhorn and staghorn corals. This zone was originally designed to limit consumptive activities and separate users engaged in different activities.

**Sand Key RA:** Provide additional protections to an existing, permitted coral nursery site.

Existing zone proposed to be eliminated as this zone no longer contains reproductively viable populations of ESA listed coral reef.

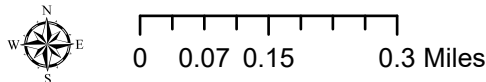
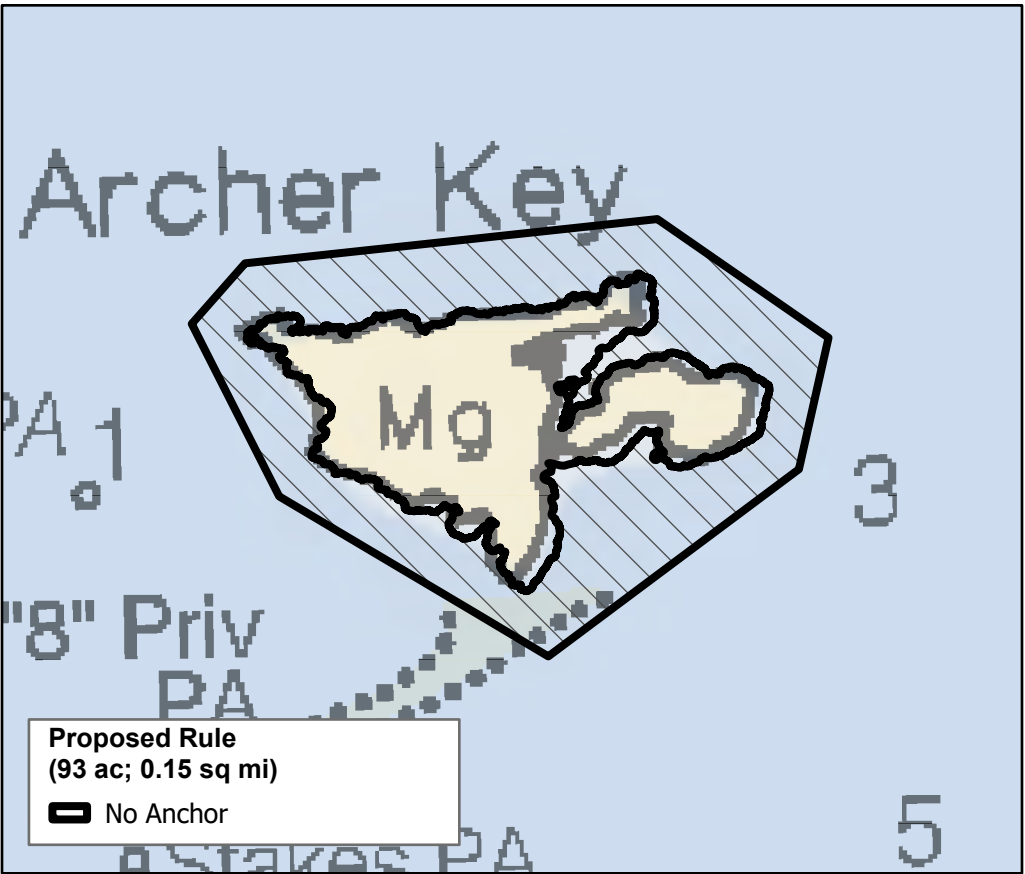
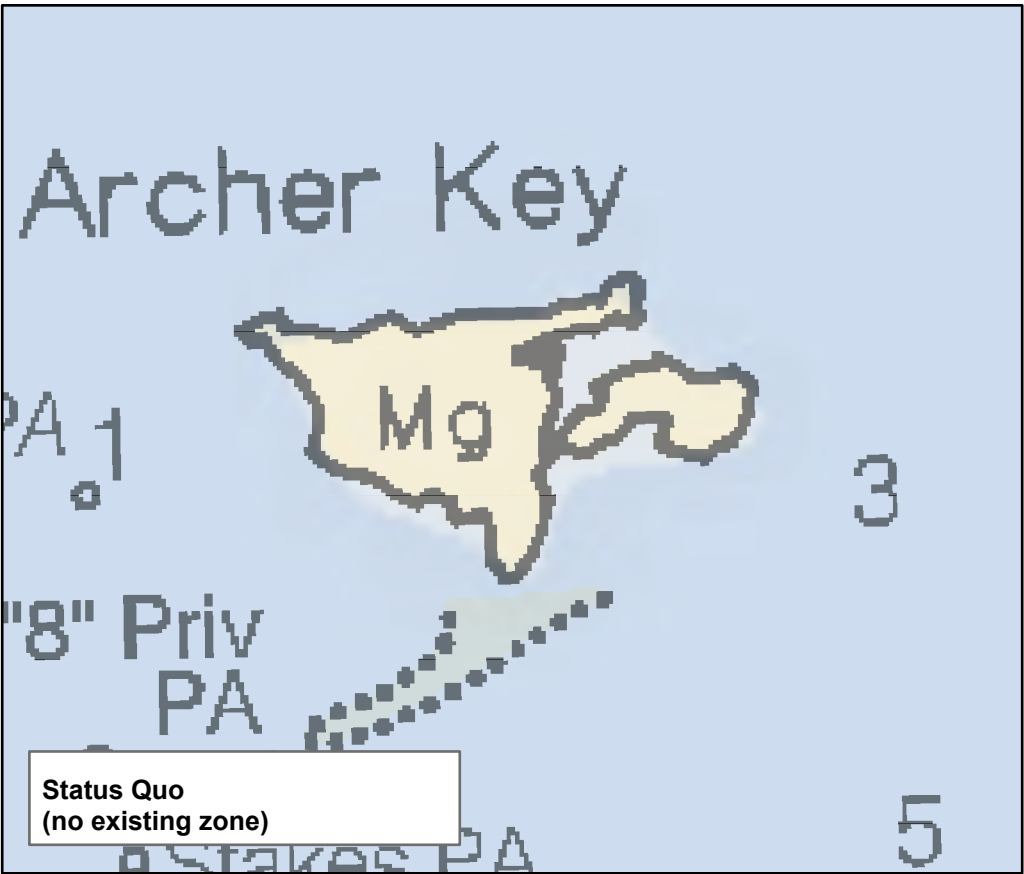

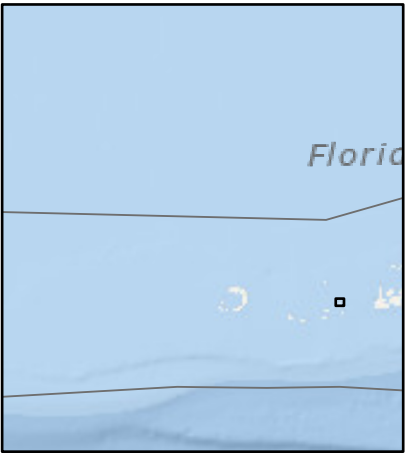




## Archer Key Wildlife Management Area

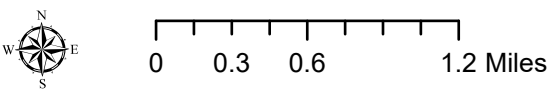
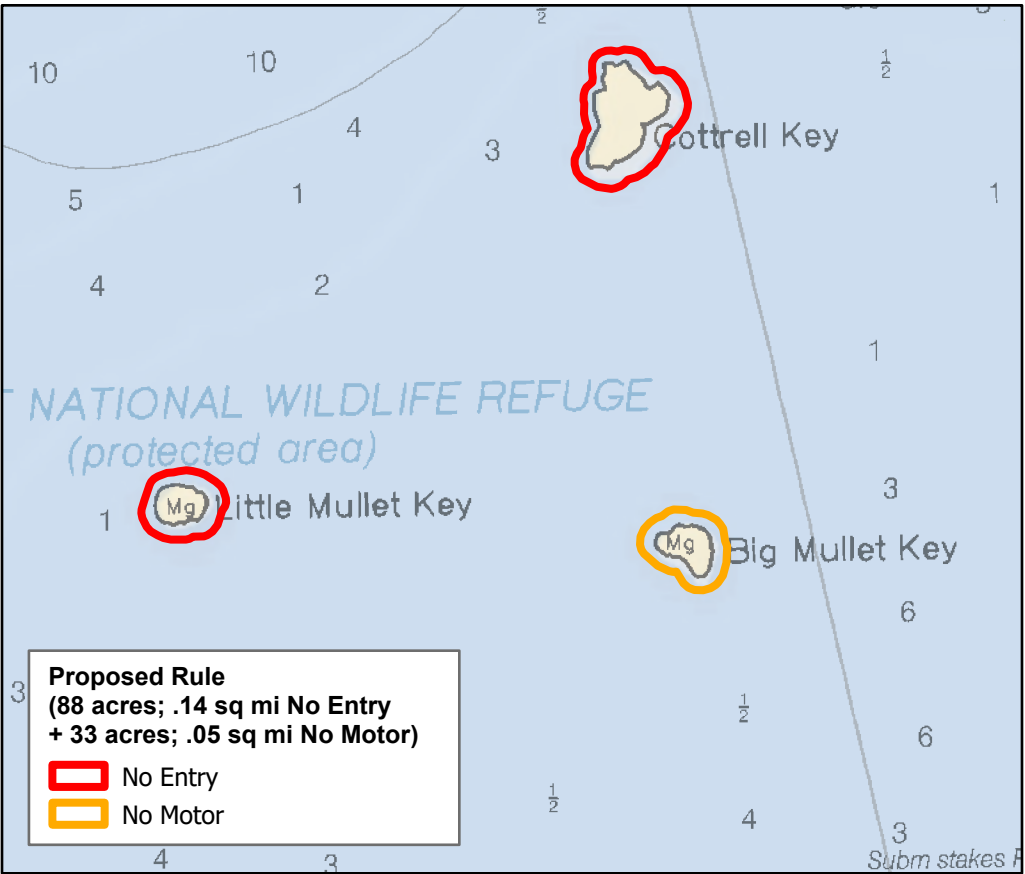
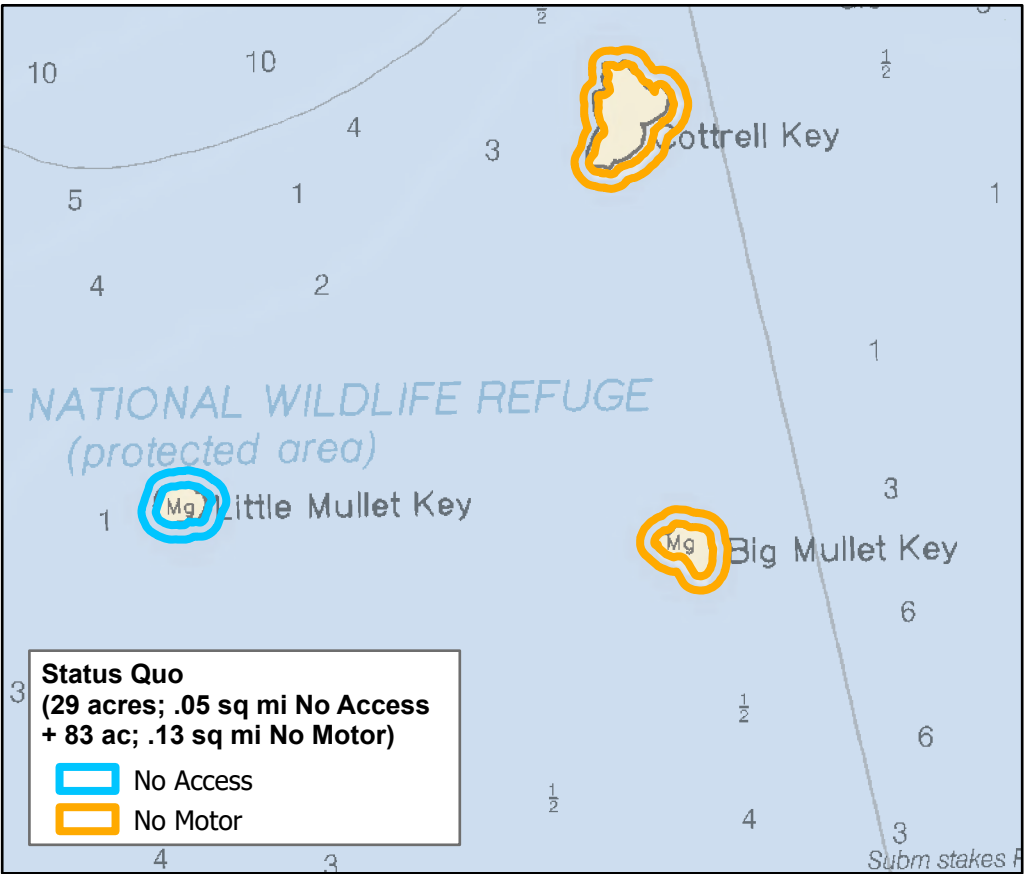

# Big Mullet Key, Little Mullet Key, and Cottrell Key Wildlife Management Areas

Little Mullet Key WMA: Decrease disturbance of nesting, roosting, and foraging birds. Shallow seagrass flats around the island exhibit light-to-severe prop scarring.

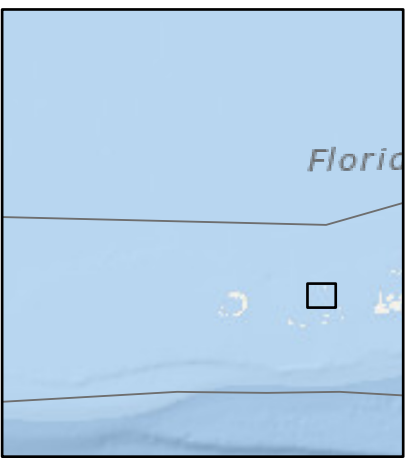
Big Mullet Key WMA: Decrease disturbance of nesting birds, a variety of wading birds, and mangrove terrapins. Some of the shallow seagrass flats around the island exhibit light prop scarring.

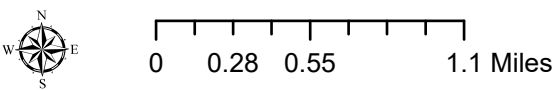
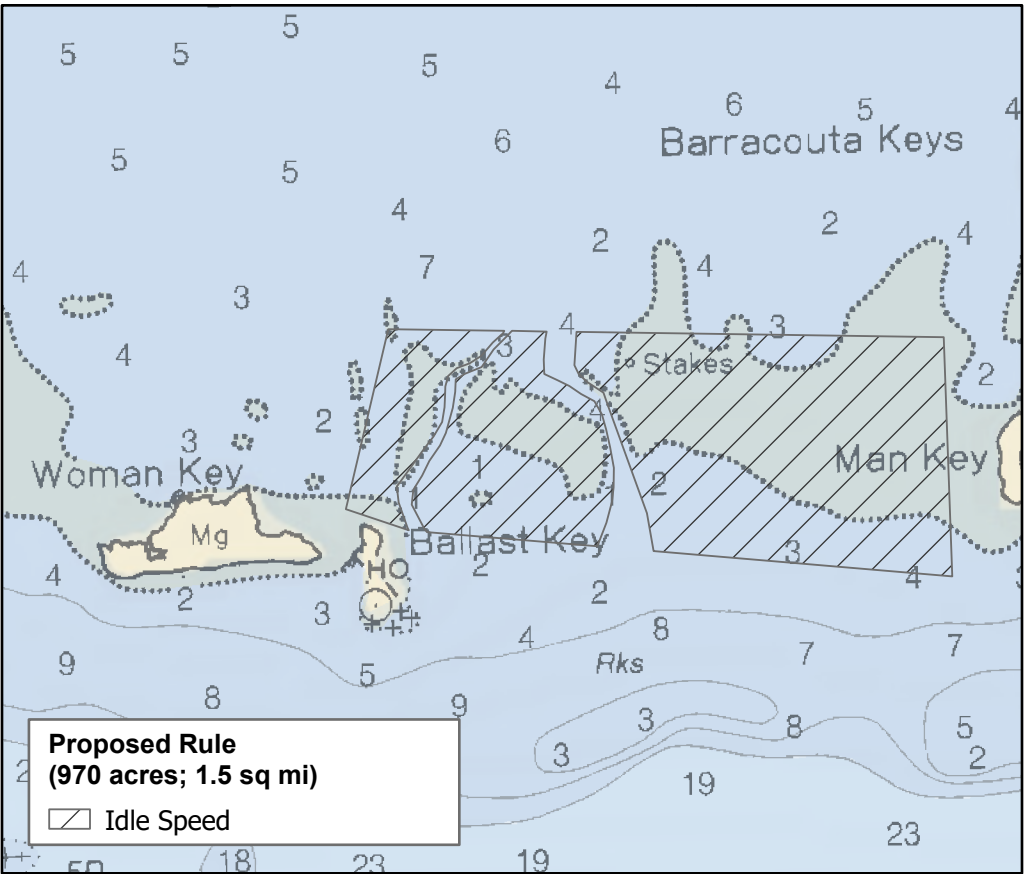
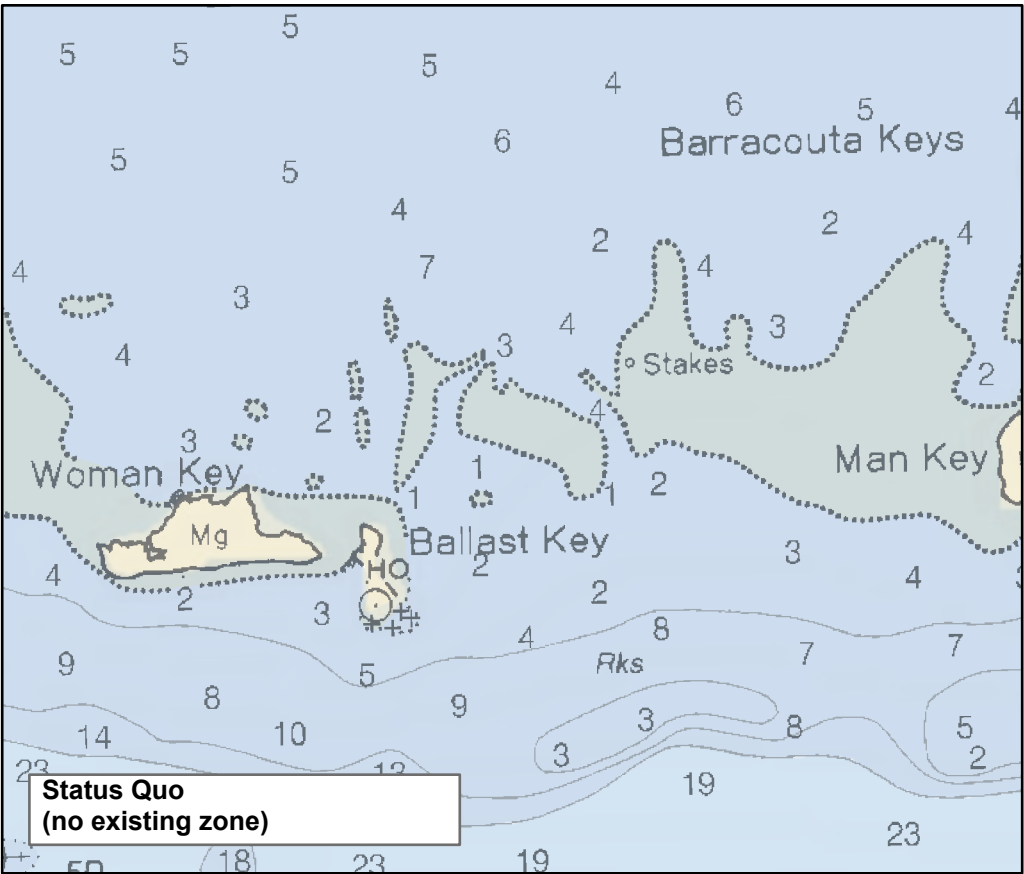
Cottrell Key WMA: Decrease disturbance of wading birds and mangrove terrapins. Cottrell Key has one of the highest annual counts of nesting great white herons in the lower Florida Keys, and serves as an important island for other nesting, roosting and foraging birds. Shallow seagrass flats around the island exhibit light prop scarring.

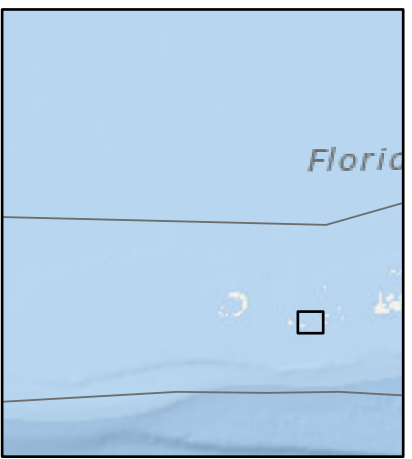
# Ballast and Man Key Flats Wildlife Management Area

Decreases disturbance to ESA-listed sea turtles and protects important hardbottom habitat. Shallow seagrass flats in the area exhibit light-to-severe prop scarring. Additional regulation in this area would better protect sensitive benthic habitat and reduce user conflict between flats fishers and recreational boaters. Maintain use of channels.

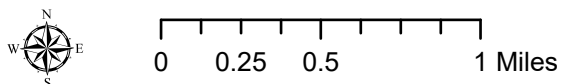
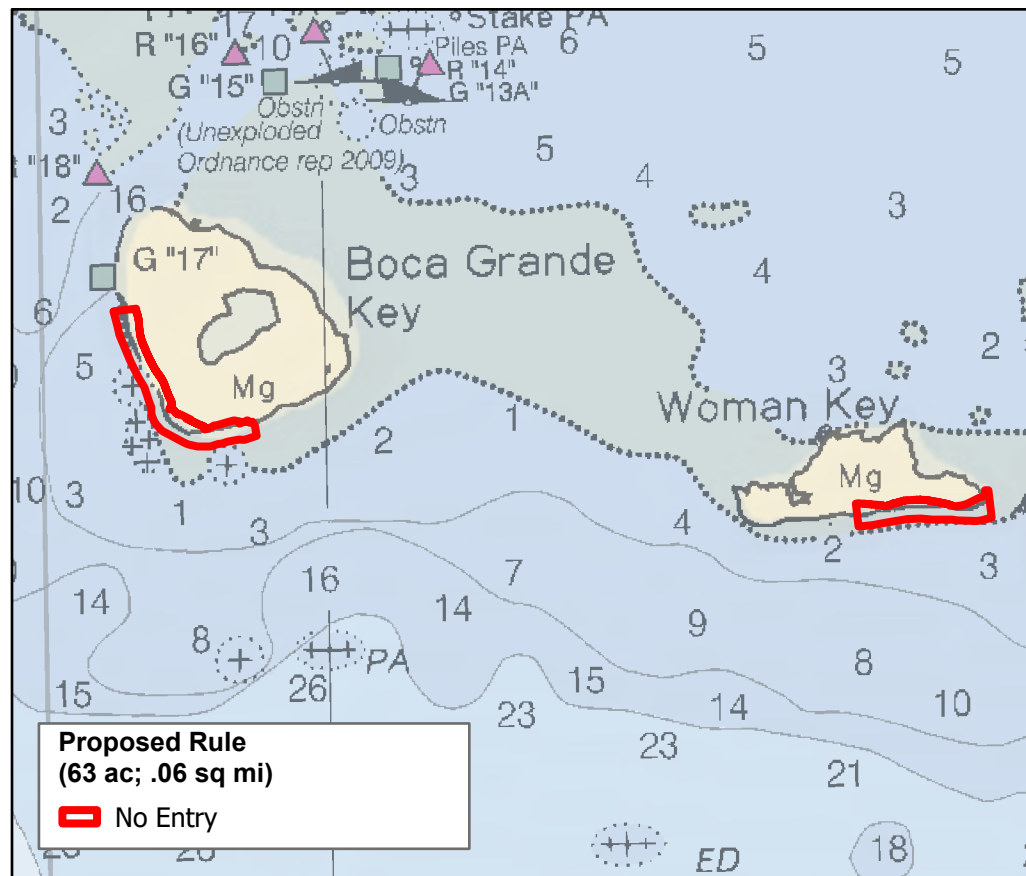
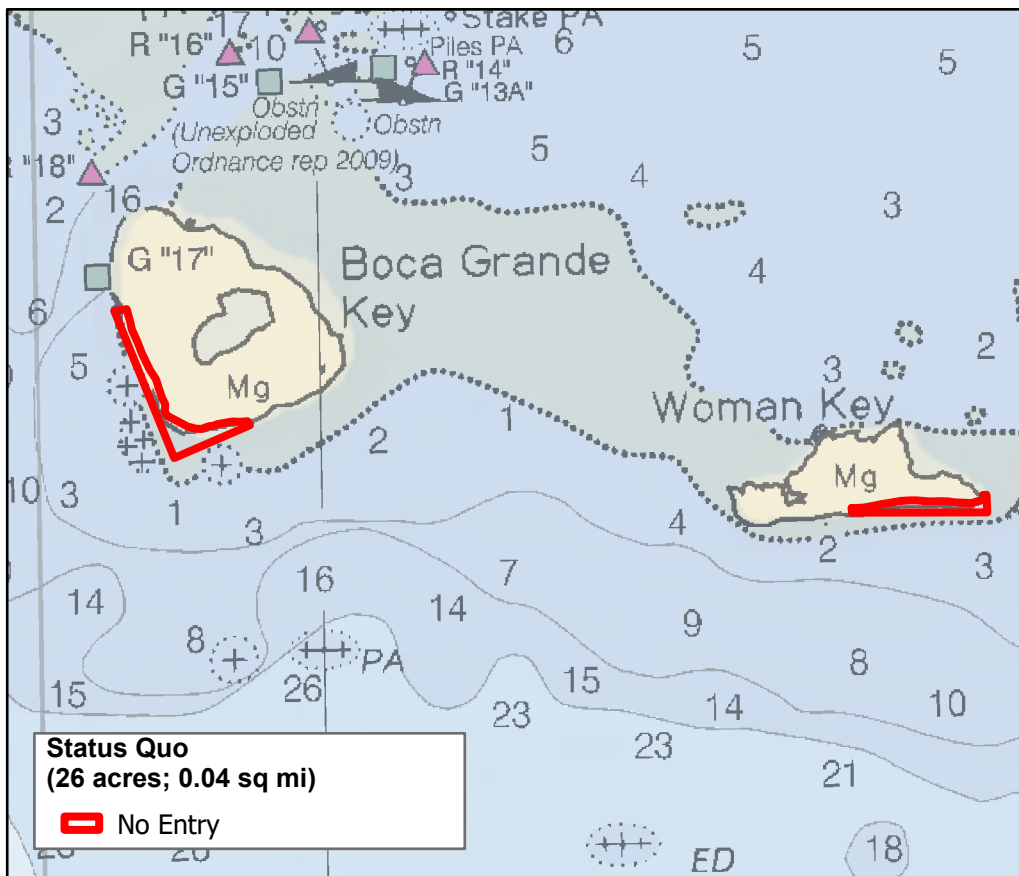

## Boca Grande Key and Woman Key Wildlife Management Areas

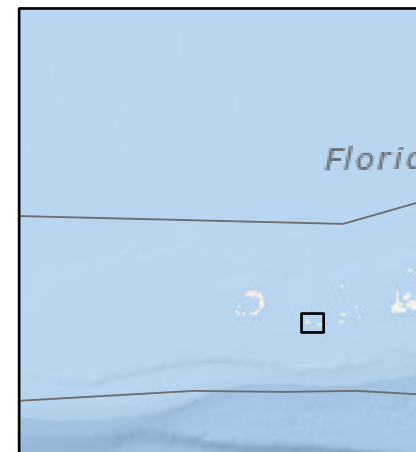
**Boca Grande Key WMA:** Decrease disturbance of nesting and roosting birds. The island closure protects ESA-listed nesting sea turtle beaches and sensitive habitat including for the ESA-listed Miami blue butterfly. Sea turtle nesting beaches may be impacted by high concentrations of visitors.

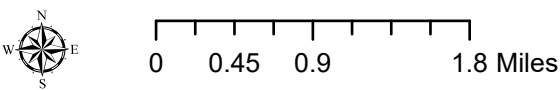
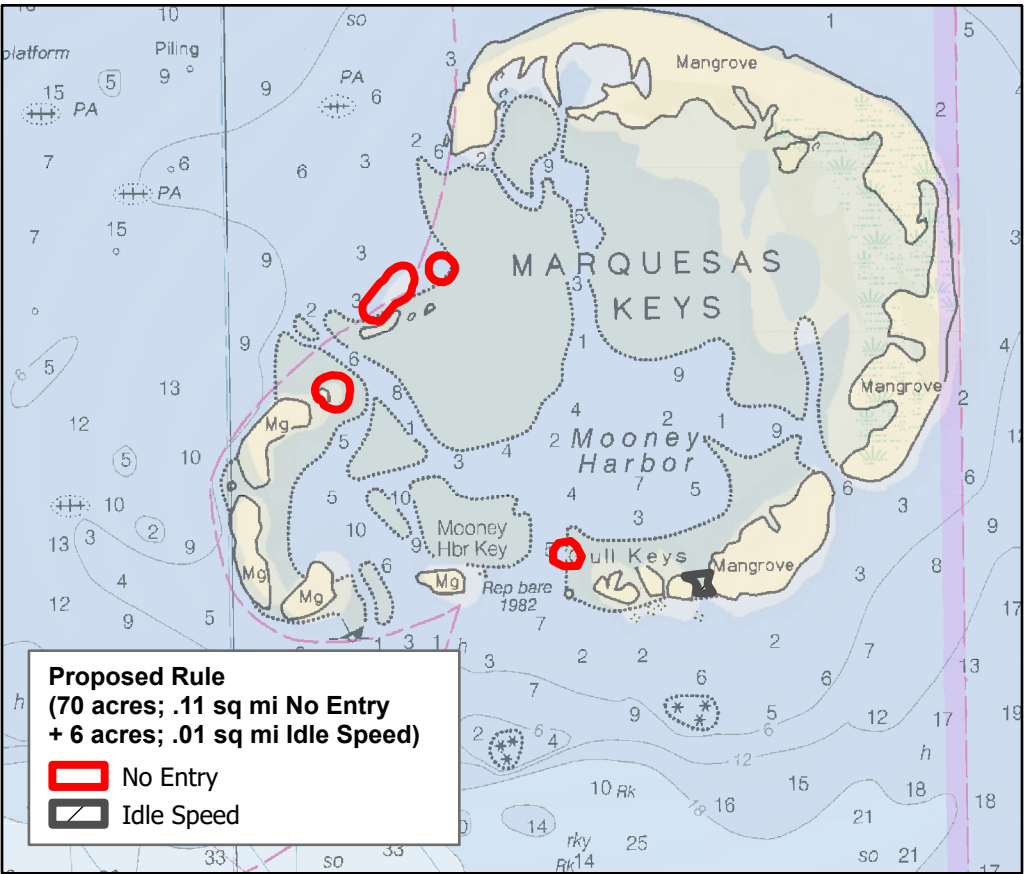
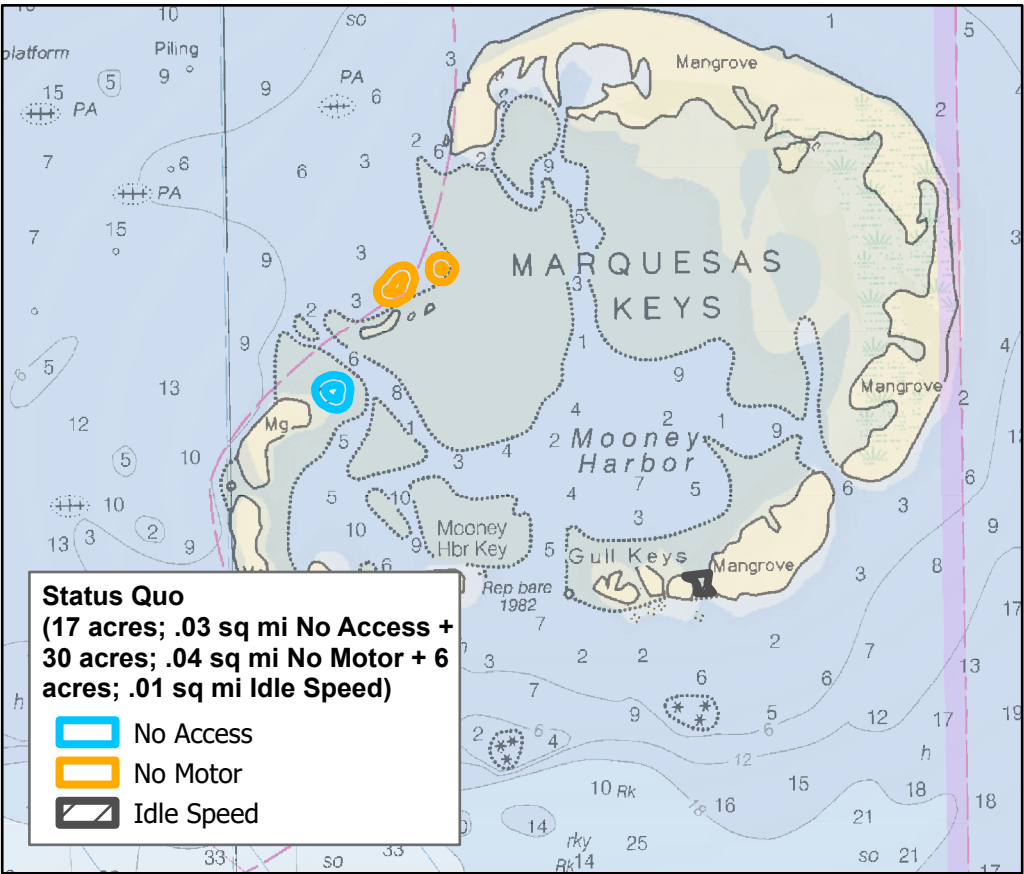
**Woman Key WMA:** Decrease disturbance of nesting and roosting birds. Decrease disturbance of ESA-listed nesting turtles, which may be impacted by high concentrations of visitors.

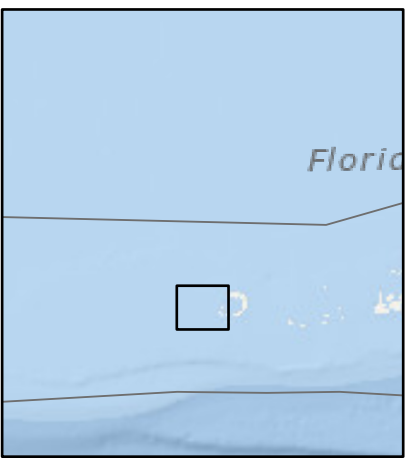
# Marquesas Keys Turtle Wildlife Management Area

Decrease disturbance to ESA-listed green sea turtles on a rare, internationally-important foraging ground and decrease disturbance to the benthic habitat of this internationally important foraging ground.
