WHEREAS, the CRA advertised a request for Proposals for ITB 22-004 - Stormwater Management Improvements - Boat House at Turtle Kraals, and one response was received on October 5, 2022. City staff reviewed and determined the sole proposal to be responsive, and that a minor inconsistency had no tangible impact on the bid; and; and

WHEREAS, at its meeting of October 12, 2022, the Key West Bight Management District Board made a recommendation to the CRA to award a contract in accordance with documents contained in the RFP to American Empire Builders, Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bid of American Empire Builders, Inc. in response to "ITB #22-004 Stormwater Management Improvements - Boat House at Turtle Kraals - Key West Historic Seaport," in an amount not to exceed \$98,040.64 is hereby awarded.

Section 2: That a minor inconsistency in the original submitted bid is waived (\$1.00 mathematical error).

Section 3: That the project is budgeted in account No. 405-7502-575-6200 (Buildings). Any necessary budget transfers or adjustments are hereby authorized.

Section 4: That the City Manager is authorized to execute a contract in substantial conformance with documents contained in the bid package on behalf of the City of Key West, upon advice and consent of the City Attorney.
