A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) 2023 FORD F-250 PICKUP TRUCK WITH ACCESSORIES AT A TOTAL AMOUNT NOT TO EXCEED \$72,102.30 FROM DUVAL FORD LLC, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION COUNTIES BID NO. FSA22-VEL30.0, PURSUIT, ADMINISTRATIVE AND OTHER VEHICLES CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST DEPARTMENT: AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA22-VEL30.0 - Pursuit, Administrative and Other Vehicles Contract, pursuant to section 2-797(3) of the Code of Ordinances; and

WHEREAS, in Resolution 21-236, the Key West Fire Department obtained approval to purchase a Ford F-250 to replace the frontline KWFD Command response vehicle, however, the purchase was unsuccessful due to lack of availability of the vehicle nationwide; and

WHEREAS, the KWFD budgeted again in FY 22/23 the acquisition of one Ford F-250 to replace the frontline KWFD Command response vehicle; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of One (1) 2023 Ford F250 Pickup Trucks with related accessories, as described in the attached proposal of Duval Ford LLC, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties Bid No. FSA22-VEL30.0 Contract, in a total amount not to exceed \$72,102.30, is hereby authorized for purchase and use by the Key West Fire Department.

Section 2: That funds for the purchase of one 2023 Ford F250 are budgeted in Fire Department Infrastructure Surtax/ /Machinery and Equipment 101-2201-522-6400 (\$60,000). A transfer of \$12,102.30 is hereby authorized from Infrastructure Surtax Fund operating reserves 101-1900-519-9803, to cover the balance of the vehicle's cost. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.
