A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE FROM MUNICIPAL EMERGENCY SERVICES OF TWO (2) HURST eDRAULIC 3.0 RESCUE TOOL SETS PLUS ACCESSORIES ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) FOR THE KEY WEST FIRE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$89,120.00; AUTHORIZING ANY NECESSARY BUDGET AMENDMENTS OR ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, Key West Fire Department is in process of acquiring new front line fire engine and aerial apparatus, which will be equipped with new battery-powered Hurst ("Jaws of Life") rescue tools to enhance public safety and welfare; and

WHEREAS, Municipal Emergency Services is the only source City staff has been able to identify to provide Hurst Jaws of Life equipment sales, service and installation in the State of Florida; and

WHEREAS, the purchase of Hurst eDraulic Systems pursuant to the brand name specifications provisions of Key West Code of Ordinances section 2-843 and 2-844 is also permitted and recommended to ensure interoperability among City rescue vehicles; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of two (2) Hurst eDraulic Systems and accessories from Municipal Emergency Services is hereby authorized pursuant to section 2-797(1) for the Key West Fire Department, in an amount not to exceed \$89,120.00.

Section 2: That funding for this procurement is allocated in Fire Department Infrastructure Surtax account 101-2201-522-6400. Any necessary budget transfers or adjustments to effectuate this purchase are hereby approved.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
