A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF THREE (3) 2023 FORD F-250 PICKUP TRUCKS WITH LIFTGATES (\$64,685.00 EACH) IN A TOTAL AMOUNT NOT TO EXCEED \$194,055.00 FROM DUVAL FORD LLC, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA22-VEL30.0 CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST COMMUNITY SERVICES DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA22-VEL30.0 Contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of Three (3) 2023 Ford F250 Pickup Trucks with liftgate and related accessories (\$64,685.00 each), as described in the attached proposal of Duval Ford LLC, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties

FSA22-VEL30.0 Contract, in a total amount not to exceed \$194,055.00, is hereby authorized for purchase and use by the Community Services Department.

Section 2: That funds for the purchase of two 2023 Ford F250s are budgeted under Infrastructure Surtax/Public Works/Machinery and Equipment Account 101-1905-519-6400 (\$100,000), and purchase of one 2023 Ford F250 is budgeted in Infrastructure/Parks and Recreation/Machinery and Equipment 101-7201-572-6400 (\$50,000). A transfer of \$44,055.00 is hereby authorized from Infrastructure Surtax Fund operating reserves 101-1900-519-9803, with \$29,370.00 of that amount to be allocated to 101-1905-519-6400 (Public Works), and \$14,685.00 to be allocated to 101-7201-572-6400 (Parks and Rec) to cover the balance of the vehicle's cost. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
