

After being let into the property by the property owner we observed and photographed workers of FL Keys Constructing LLC removing and installing new deck boards and wrapping the foundation with tape as well as an outdoor shower being dismantled. Our records do not show any permits since 2016. A stop work order was posted and we advised the qualifier (Anthony Galvan) of FL Keys Contracting LLC and property owners to apply for all after the fact permits.
