A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "COMBINED VOLUNTARY COOPERATION AND OPERATIONAL ASSISTANCE MUTUAL AID AGREEMENT BETWEEN THE KEY WEST POLICE DEPARTMENT (KWPD) AND THE MONROE COUNTY SHERIFF'S OFFICE (MCSO)", PURSUANT TO THE FLORIDA MUTUAL AID ACT, CHAPTER 23, PART I, FLORIDA STATUTES; AUTHORIZING THE CITY MANAGER AND THE POLICE TO CHIEF TO EXECUTE THE AGREEMENT UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Florida Statutes permit voluntary cooperation and assistance across jurisdictional lines, and the Key West Police Department (KWPD) and Monroe County Sheriff's Office have historically provided mutual aid for law enforcement services; and

WHEREAS, the attached Mutual Aid Agreement will grant the KWPD primary statutory jurisdiction and primary patrol responsibilities for all parts of College Road and areas of Stock Island situated north of U.S. 1, and to grant MCSO primary statutory jurisdiction and primary patrol responsibilities for Wisteria Island.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That pursuant to the Florida Mutual Aid Act, Chapter 23, Part I, Florida Statutes, the attached "Combined Voluntary Cooperation and Operational Assistance Mutual Aid Agreement Between the Key West Police Department and Monroe County Sheriff's Office" is hereby approved.

Section 2: That the City Manager and the Police Chief are authorized to execute necessary documents upon consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
