-- Mathew Tyler Wallace Arrest Narrative:

On September 30, 2022, at approximately 0022 hours, Ofc. Andrade was dispatched to a verbal altercation at 801 Virginia Street. The caller told Key West Dispatch his ex-girlfriend is threatening to kill his dog and hurt his current girlfriend. I, Ofc. Lopez responded to the above location to assist Ofc. Andrade as I responded to the above location, and I am familiar with this ongoing issue.

I conducted my investigation, and I later documented this incident, see case 22-5577. Towards the end of my investigation a male who resides at 801 Virginia Street arrived on scene. The male was identified earlier this evening with his Florida driver's license as Matthew Wallace, (dob:12/07/1986). Wallace walked upstairs to his apartment, and he opened the front door of his apartment for his friend. Wallace's friend was identified with her Florida driver's license as Stephanie Johnson, (dob:08/13/1992). Johnson needed to gather her belongings and she retrieved them shortly after. I walked back downstairs with Johnson towards her car. While I was walking with Johnson across the street towards the Church's parking lot, (1010 Windsor Lane), I heard Wallace obnoxiously screaming from the second-floor balcony of (801 Virginia Street). I was standing in the parking lot across the street, and I heard Wallace screaming, "I didn't do anything" and then Wallace screamed, "I'm in my fucking home". Wallace continued screaming saying, "My house and I have no idea what the fuck just happened". Wallace screamed, "I'm not drunk this is bullshit". Wallace walked inside his apartment, and he slammed the front door very hard to the point I heard it from where I was standing.

It should be noted that this event happened at approximately 0200 hours in a residential neighborhood.

I had several Law Enforcement encounters with Wallace in the past. Wallace has an antagonistic demeanor, and he becomes aggressive, and very argumentative when he is under the influence of an alcoholic beverage. Wallace has a tendency of instigating problems and disregarding the peace and quiet of the residents in this neighborhood in the past. Wallace said in the past this is his house and seems not to understand that his belligerent and obnoxious screams at this time of the night is disrupting the peace and quiet for his neighbors.

I then walked upstairs in an attempt to make contact with Wallace.

I was standing on the second-floor balcony near second apartment located next door to Wallace's apartment. Wallace opened the door shortly after. I began walking towards him as he opened the door. Wallace tried to get back inside as soon as he saw me. I grabbed his right wrist, and I attempted to pull him outside the apartment as he was actively pulling away from me. Wallace was actively resisting when I was attempting to pull him outside of the apartment and I escorted Wallace to the ground. While Wallace was laying down on the floor, I attempted to place handcuffs on him, and he actively pulled away his hands away from me. Ofc. Adorno and Ofc. Andrade were assisting me as I was trying to place handcuffs on Wallace. Ofc. Andrade instructed Wallace to place his hands behind his back. However, Wallace continued resisting by not complying with Ofc. Andrade's verbal instructions. I was able to place handcuffs on Wallace shortly after. Wallace yelled several times, "I did nothing wrong this is bullshit". The dogs in this neighborhood started barking. Wallace continued screaming extremely loud, "I did nothing fucking wrong". I told Wallace it's 2 o'clock in the morning and to stop yelling. I walked Wallace downstairs towards my patrol vehicle. Wallace continued screaming and reminded Wallace his neighbors are sleeping, and they have had enough. Wallace replied, "I don't care".

During this encounter, I smelled a strong odor of an alcoholic beverage on his body. Wallace appeared to be under the influence of alcoholic beverage. Wallace screamed repetitive statements throughout this incident, and he appeared not to follow simple instructions.

I searched Wallace before I placed him in the rear passenger side of my patrol vehicle. I noticed Wallace had a small

cut above his left eyebrow. Sgt. D. Kouri responded on scene for the response to resistance incident.

The neighbor who resides in the rear apartment expressed her concerns about Wallace's apartment earlier in the evening. This neighbor was woken up by the noise Wallace was making. The neighbor was later identified as Cynthia Greenway, (06/04/1979). Cynthia said to Ofc. Ham that she woke up to the noise, banging noises, and the door slamming. Cynthia filled out a witness statement and the statement was later placed into the Key West Records Division.

This incident was recorded with my body worn camera, 3722.

I later transported Wallace to The Monroe County Detention Center. My In-car Axon camera was activated during the transportation.

Based on the facts and evidence, Matthew Wallace, did affect the peace and quiet of the residents in this residential neighborhood at approximately 0200 hours. Wallace displayed an antagonistic demeanor, and he became argumentative for no reason. Wallace appeared to be as if he was instigating a reaction from the Officers on scene to the extent, he began screaming extremely loud for no reason. I was standing in the parking lot across the street, and I heard Wallace screaming, "I didn't do anything" and then Wallace screamed, "I'm in my fucking home". Wallace continued screaming saying, "My house and I have no idea what the fuck just happened". Wallace screamed, "I'm not drunk this is bullshit". Wallace walked inside his apartment, and he slammed the front door very hard to the point I heard it from across the street. Wallace has no regards with disrupting the peace and quiet for his neighbors at this time of the night. Wallace's belligerent behavior is disrupting the peace and quiet for the residents in this area. Contrary to F.S.S. 877.03.

Based on the facts and evidence, Matthew Wallace, did resist and oppose to place his hands behind his back. I grabbed his right wrist, and I attempted to pull him outside the apartment while he was pulling away from me. Wallace was actively resisting when I was attempting to pull him outside of the apartment and I escorted Wallace to the ground. While Wallace was laying down on the floor, I attempted to place handcuffs on him, and he actively pulled away his hands away from me. Ofc. Adorno and Ofc. Andrade were assisting me as I was trying to place handcuffs on Wallace. Ofc. Andrade instructed Wallace to place his hands behind his back. However, Wallace continued resisting by not complying with Ofc. Andrade's verbal instructions. Contrary to F.S.S. 843.02.

On Friday, September 30, 2022, at approximately 0030 hours, I Ofc Andrade, responded to 801 Virginia Street, reference an alleged assault.

I arrived on scene and saw Ofc Ham speaking with the reporting party, Jose Guzman. Ofc Adorno and Ofc Lopez arrived moments later.

Ofc Lopez conducted his investigation into the alleged assault incident (see 22-5577). Concluding the investigation, it was decided that the other party involved in this incident, Stephanie Johnson, would leave the area with her two children. Johnson called herself a taxicab and it arrived shortly thereafter. I helped Johnson carry her things and son to the taxicab. At the taxicab Johnson said she locked her purse in the apartment and did not have a key. She called Matthew Wallace, the lease holder of the apartment, to come unlock it for her.

Shortly after Wallace arrived on scene and opened the apartment door for Johnson to collect her purse. I stayed with Johnson's children who were waiting in the taxicab. While I was waiting with the children, I could hear Wallace screaming and yelling obscenities from his balcony. I also heard a door slamming hard. I tried to keep the children distracted so they would not focus on the yelling.

Johnson returned to the taxicab with a car seat and her purse and left the scene in the taxicab. I looked up at the 2nd story balcony and saw that Ofc Ham, Ofc Adorno, and Ofc Lopez were up there. I walked up the stairs to the balcony. Ofc Ham was at the top of the stairs and Ofc Adorno and Ofc Lopez were standing between the two apartments on the balcony. Shortly after Wallace opened the door to his apartment. Ofc Lopez and Ofc Adorno immediately walked towards Wallace. Wallace tried to retreat into his apartment as soon as he saw Ofc Lopez and Ofc Adorno. Ofc Lopez and Ofc Adorno reached out to grab Wallace, preventing him from going back inside. Wallace immediately began pulling away from Ofc Lopez and Ofc Adorno. I then immediately made my way to them. Ofc Lopez and Ofc Adorno escorted Wallace to the ground. I put my right hand on the upper part of Wallace's back and held him down ordering him to place his hands behind his back. Wallace was not complying with my commands and was tensing his body and attempting to pull his arms free of Ofc Lopez's and Ofc Adorno's grasp.

Ofc Lopez was able to place handcuffs on Wallace and we walked him to Ofc Lopez's patrol vehicle where Ofc Lopez performed a search subsequent to arrest and placed Wallace in the back of his patrol car. Wallace continued shouting obscenities with no regard to Ofc Lopez asking him to be quiet, telling Wallace that it was late, and people are trying to sleep. Ofc Lopez then left the scene.

Ofc Ham spoke to a neighbor, Cindy Greenway, who told him she was awakened by all the noise. I had Greenway fill out a witness statement that was later placed into the Key West Records Division.

On September 30, 2022, at approximately 0022 hours, I (Ofc. Adorno) was dispatched to a verbal altercation at 801 Virginia Street. The notes indicated the reporting person's ex-girlfriend was threatening to kill his dog and hurt his current girlfriend. Ofc. Lopez arrived to the location due to his familiarity with the on going issue.

Ofc. Lopez finished his investigation, see case 22-5577 for more information. As Ofc. Lopez finished his encounter with the parties, a male individual who also resides at this location, identified as Matthew Wallace began to act belligerent as he referred the situation that was going on. I asked Matthew to go inside multiple times, as it was approximately 0200 hours in a residential neighborhood. Wallace continued to yell that he didn't do nothing at the top of his lungs along with "Fuck you cops". After screaming for approximately 10 minutes, Wallace walked into his house and slammed the front door. Ofc. Lopez, Ofc. Ham, Ofc. Andrade and I walked to the second floor of the balcony to advise he was disrupting the peace of the neighborhood. Ofc. Lopez approached the door as Wallace opened it. Wallace attempted to get back inside the house as quick as possible.

Ofc. Lopez grabbed his right wrist as I grabbed his left wrist as Wallace pulled away and actively resisted. Officers on scene escorted Wallace to the ground. Officers on scene attempted to place handcuffs on him, as he actively pulled away his hands away from us. I assisted Ofc. Lopez place handcuffs on Wallace. Wallace continued resisting by not complying with Ofc. Andrade's verbal instructions. Shortly after, we were able to place handcuffs on Wallace and place him in the rear of the patrol vehicle.
