-- Brian Prescott Blucher Arrest Narrative:

On 12/10/2022 at 0005 hours, I (Ofc. R. Owens) observed an altercation between an unidentified white male and a security personnel, identified as Bradley McBride and Allen Hicks, who were working at 501 Greene St., Rock House Live.

My vehicle was stopped at the red-light at Greene St. and Duval St. awaiting traffic, and I saw the male, later identified as Brian Blucher start throwing punches at two other white males. One of the males was wearing a yellow security shirt appearing to work at Rock House Live, later identified as Bradley McBride. I recognized the third male as Allan Hicks-Ebersole, Rock House Live night manager. Numerous other passerby and patrons of the bar attempted to intervein and separate the parties from the altercation.

I exited my vehicle and approached the altercation and tried to grab Blucher to pull him away to break up the altercation. Blucher continued to hold Hicks and push forward swinging his fist. In an attempt to control the suspect, I redirected him to the ground in a controlled manner, placed him in handcuffs, and detained him for my investigation. My body worn camera came off my vest during this time. My BWC was returned to me by a bar patron. I requested a supervisor on scene for a Response to Resistance Incident. I helped Blucher off the ground and asked if he had any other injuries and he said no. Blucher had a small amount of blood around his mouth, and I did not observe any other injuries.

I spoke with McBride, and he told me he was working the door security and saw Blucher smoking inside the bar. McBride told me the other door security person; Dirk Cancelosi, had removed Blucher from the bar area and told him to leave earlier in the night. McBride said he told Blucher to leave, and he would not. McBride said he started to physically remove Blucher and Blucher then swung his first at him. McBride told me he did not get hit by Blucher. McBride said Hicks then stepped in to try to stop Blucher and he continued to swing his firsts. McBride told me that's when he saw me approach. McBride said he did not want to press charges at this time.

I spoke with Hicks who told me he was working at the bar and getting ready to sing karaoke when he saw Blucher swing at McBride. Hicks said he stepped off the stage and went over to McBride and Blucher to separate them. Hicks said he was hit in the face and then fell into the door jam. Hicks had a small laceration on his top left side of his head from the door. Hicks said he swung at Blucher in self defense because Blucher could not be controlled and swung at him again. Hicks said he saw me attempt to control Blucher and he backed off. Hicks said his door security personnel, Brad already told Blucher to leave and not come back because he was talking to himself and smoking in the bar. Hicks told me he was not going to press charges but changed his mind and wished to pursue charges at this time. I took pictures of Hicks injury with AXON Capture and submitted them to evidence.com.

I spoke with Blucher and told him I had to read his Miranda Warning because he was detained in handcuffs. I could smell a very strong scent of an alcoholic beverage coming from Blucher's breath and person. Blucher said he just got out of jail and didn't want to go back. I read Blucher his Miranda Warnings and asked if he would speak to me about the incident and he said yes. I asked Blucher what happened, and he said he was going outside to smoke, and the door security grabbed his arm and started to tell him to go out of the bar. I asked Blucher if he was already smoking, and he said no. Blucher said before he exited the thresh-hold of the door he swung at McBride because McBride grabbed him. I asked if any other person had told him to leave the bar and not comeback and he said no.

I spoke to Dirk Cancelosi, and he told me that Blucher was told earlier to leave the bar because he was acting weird. Cancelosi said Blucher was already intoxicated, talking to himself, and attempting to smoke inside the bar. Cancelosi told me he told Blucher to leave and saw him walk down the street. Cancelosi said he did not know he came back to the bar to the other door.

I transported Blucher to MCDC. Due to the in-car cameras being inoperative, I activated my BWC for transport and held it facing the rear seat.

My BWC was activated for this incident.

Victim

Since Brian Blucher actually and intentionally touched Allan Hicks-Ebersole by swinging his fist and striking Hicks in the face while he was attempting to remove Blucher from the bar and break up an altercation, which caused Hicks to hit his head, Brian Blucher is in violation of F.S.S. 784.03-1A1.

Since Brian Blucher was intoxicated in public and started an altercation causing a law enforcement officer to intervein and also cause an undue safety hazard for bar patrons and other passerby constituting a breach of peace in a public and a moral outrage in the sense of decency, Brian Blucher is in violation of F.S.S 877.03.

I was informed by Allan Hicks, that the security camera facing the Green St. entrance door from inside the bar is inoperable. Hicks told me the owner of the building is the only person who has access to the two exterior surveillance cameras on the Greene St. side.
