4Q22 Equity Commentary

From a financial market perspective, we are all glad to see 2022 end. It was a year in which both stocks and bonds fell, and about the only place to make money was in cash, the US dollar and a handful of commodities. The aggressive rate hike trajectory of the Fed (7 hikes in 2022) ended the era of “free money” and compressed valuation multiples. At the markets low point in October the combined loss in value of equity and fixed income totaled \$17.4 trillion. Normally bonds provide a place of refuge when stocks are falling but not last year. The Bloomberg Aggregate US Bond Index was down 13.1%, marking its worst year since inception in 1976. Its previous worst year was 1994 when it dropped just 2.9%. The S&P 500 closed the year down 18.1%. It was even worse in technology as the Nasdaq 100 fell by 32% marking its worst year since 2008, and the most popular large tech stocks (Meta, Apple, Alphabet, Netflix, Amazon) were down 40%. A balanced portfolio of 60% S&P 500 and 40% Aggregate Bond declined almost 17% last year and would only have been eclipsed by 2008’s dismal return of 20.1%. However, the fourth quarter did see the market rebound with the S&P adding 7.5%. The market responded as inflation numbers declined indicating that the peak inflation of June at 9.1% appears to be behind us. Whether or not that trend can continue will have a major bearing on the direction of the market in 2023.

The Economy – It's All About the Inflation: The economy grew at a better than expected 3.2% rate in Q3, up from -0.6% in Q2. And while Q4 should also be up 1% or better, the focus is inflation. The current headline CPI is at 7.1%, with the Core ex Food and Energy at 6%. The Personal Consumption Expenditure Index ex Food and Energy (Fed's preferred inflation gauge) is at 4.7%, down from 5.0% in October. **The inflation numbers are trending in the right direction, coming down from the 9.1% June peak.** Housing, which makes up 40% of the CPI basket, has started to

moderate with October data indicating that rents grew at their slowest pace in a year. Energy and food prices are off their highs. The M2 money supply number has now contracted at a 1.3% rate over the past 3 months, the only time this has happened in 40 years. This draining of liquidity from the financial system should bring inflation down. The 10-year Treasury yield fell from a high of 4.22% in early November to 3.88% at quarter end, and the bond market seems to believe that the Fed will not be able to raise rates as high as they are indicating. This does not mean though that we will get back to the Fed's 2% goal anytime soon. In fact, we could be two years or more away from seeing inflation at that level. While goods inflation has declined as many of these components are interest sensitive areas such as autos and housing, (existing home sales down 7.7% in November), the services side of inflation has continued to ramp as consumers exit the Covid lockdown periods and are intent to travel and reengage in experiences. Positively, gasoline prices have moderated, and we are seeing improvements in the supply chain which should continue as China exits their zero Covid policy. While we expect near term supply chain improvements (these trends are evident in the ISM reports), the movement toward de-globalization and near shoring or “friend shoring” will likely lead to higher prices over the longer term as political and trade tensions rise. The Fed is not done raising rates (we expect 2-3 more rate hikes), but we are hopefully nearing the end of this tightening cycle. Normally tightening cycles end when the Fed Funds rate exceeds CPI. And while the labor market has remained shockingly strong, we suspect the Fed will want to see some deterioration in jobs numbers before they feel confident their work is complete. GDP projections for 2023 continue to decline, with most now expecting growth of just 0 – 0.5%, and for a recession to start by the middle of the year. **This will easily be the most anticipated recession in our careers, and it's hard not to think that both companies and consumers**

measures to soften the impacts of a coming slowdown. The consumer is always key in any recession discussions, and with a tight labor market (still 4 million people short and job openings at 10.3 million), it's hard to envision a deep recession if jobs remain solid. In fact, real wages should grow in 2023 (Average Hourly Earnings +5.0%) as wage growth outstrips inflation and provides a boost to consumption. Consumer Confidence bounced back in December after previous back-to-back declines, and now stands at its highest reading since April. Consumers are more positive on the jobs outlook as well as inflation expectations. This was evidenced by the Mastercard Spending Pulse data which showed holiday spending, ex autos, increasing 7.6% year over year. All of this leads us to believe that we will experience a recession beginning sometime in the second half of 2023, but that it will be short and shallow given the resilient jobs market. Is there a chance a recession can be avoided, and the Fed achieve the "soft landing"? Yes, but to do so the number of excess job openings must come down more than unemployment goes up, which is a tough needle to thread.

Fourth Quarter Market Recap: The market gained 7.5% in Q4 despite a weak December with the S&P dropping 5.7% in the month, as the Santa Claus rally failed to materialize. The Nasdaq 100 also experienced a tough month falling 9%. One catalyst for the weaker December was the Census Bureau estimate of retail and food sales which showed a 0.6% decline for November, serving to heighten recessionary fears. From a sector viewpoint, the results were also devoid of any type of trend. While we are possibly headed toward a recession, cyclical areas such as Energy (+22.8%), Industrials (+19.2%) and Materials (+15%) all had strong quarters. In the case of Energy, the sector rose even as crude oil fell by almost 2% in the quarter. Part of the strength in these sectors can be attributed to anticipation of China reopening and increasing demand for raw materials.

But at the same time defensive sectors such as Healthcare (+12.8%) and Consumer Staples (+12.7%) also continued their strong performance for the quarter and the year. Consumer Discretionary was the worst performing sector for Q4 (-10.2%) as the market looks ahead to a consumer that could be more limited as excess savings dwindle (now down to \$1.1 trillion from peak of \$2.1 trillion), unemployment rises, and spending patterns shift. Communications Services was the second weakest sector in Q4 returning -1.4% as Alphabet and Meta both posted negative returns for the quarter. For the full year Energy (+65.7%) and Utilities (+1.6%) were the only positive sectors. Communications Services (-39.9%) and Consumer Discretionary (-37%) were the poorest performing groups in 2022.

What to Expect Going Forward: Will 2023 see the markets rebound, or could we be in for something like what we experienced in 2022? **The answer will depend on the trajectory of inflation, when the Fed pivots, and the degree to which earnings decline in 2023.** While inflation will move lower, the rate of descent will be important. The Fed has been insistent on a "higher for longer" rate messaging, but if inflation falls faster, or if growth decelerates more, the Fed could be forced to abandon that messaging. Some forecasters are expecting the Fed to begin cutting rates by the end of 2023, but we would be hesitant to embrace that theory. For now, we will take the Fed at their word, and we expect them to avoid the stop and go Fed policies of the 1970's that resulted in multiple inflation spikes. We think the market will show a positive reaction once the Fed "pauses" hikes, which could come as soon as the end of Q1, or early in Q2. The decline in stock prices in 2022 was largely a result of valuation multiples contracting. We believe the worst of the valuation correction is past, but there could be more if inflation remains elevated. . The current market multiple of 17.3X (5 year average is 18.5X) is consistent with an inflation rate of 2-4%. Should inflation stay above that level for longer, then there is the chance that

multiples could compress further. **But earnings are where the bulk of our focus in 2023 will reside.** For 2023 earnings are expected to grow 5.3%, which would be slightly ahead of 2022's growth of 5.1%. Just to show how quickly earnings estimates can come down, the consensus at 9/30/22 was for 2023 eps to advance by 8.2%. Management teams have been reluctant to give earnings guidance with the broad economic uncertainties, but we expect to have a much better read on the '23 outlook when Q4 earnings reports begin in mid to late January. A 5% growth rate in earnings is optimistic, and with the inflationary pressure on expenses and compensation (profit margins heading lower), as well as higher corporate tax rates coming, we think earnings estimates will move lower. Historically in recessions earnings decline by 30%, but we would expect a less severe drop of 0-10%. The strength of the US dollar in 2022 was a headwind to earnings, but with the dollar seeming to have peaked, foreign exchange could become a tailwind to earnings in 2023. Market pessimism is rampant. As a contrarian indicator, the Consumer Sentiment Index December reading of 59.7 is off its low of 50, but still well below the average of 85.6. Market returns off sentiment troughs going back to 1971 have averaged +24.9% over the subsequent 12 months. All of this leads us to believe that the market will remain volatile in the first half of the year. **But history tells us that the market rallies when inflation declines, so if the Fed pauses at some point in the first half, and economic data shows moderating inflation, we should see better returns.** And at some point in the second half the market will begin to discount better GDP growth in 2024 coupled with a more realistic chance of Fed rate cuts.



Maintaining a relative defensive posture within the portfolios during the quarter led to the slight lag versus the benchmark, but was the leading attribute to the yearly outperformance. Looking at the first chart, it's clear that there was only one place to hide out in 2022 and our overweight positioning toward the energy sector for the year was successful.

Nonetheless, If the future rotation doesn't jump off the page at you from this same chart, then it's likely your process doesn't use "value" as determinant of future return. Looking forward to 2023, our modelling is likely to begin to signal a topping in Energy Sector prospects and we will respond accordingly by taking profits. Where might the opportunities emerge? It's likely that early recovery cyclicals will follow from the fed rate increase regime, whenever that nears an end. We highlight here when that may be using historical experience from previous rate hike periods.

So one could expect an end to the cycle sometime around late summer/fall if history is any guide. But we would expect the markets to anticipate this change in direction about six months prior to the actual end, which would put a potential bottom somewhere around June at the average, but perhaps February if the cycle is short. The looming question is if the tightening cycle results in a recession that may drive risk assets even lower than current levels regardless of the bottom date.


At the time of this writing, we are monitoring the macro-economic indicators like everyone else in an effort to anticipate the timing of policy reversal. Our modelling suggests few imminent opportunities with policy unknown, but as we detailed at the start, its likely that the crowded "Long energy/Short everything else" will likely change this year into something else.

Growth stocks ended 2022 on a disappointing note. Despite an initial rally for the growth index in Q4, up as much as 11.5% intra-quarter, the December sell off drove a return of 2.19%. This resulted in a -29.14% return for Russell 1000 Growth Index. The Federal Reserve's aggressive interest policy path, which saw the Fed Funds rate rise to 4.5% in just 9 months, drove a significant decrease in valuations multiples. Most metrics were down over 30% during the year. Stretched valuations in the Information Technology, Consumer Discretionary, and Communication Services sectors bore the brunt of the impact down -30.6%, -40.8%, -50.9% respectively.

Factor Trends

The fourth quarter saw a continuation of the dominant factor trends this year. The value factor remained the strongest performer within the Russell 1000 Growth Index. Among the major factor categories we track, Value had by far the best year. A long/short Value composite factor returned over +60% for 2022. Our largest active factor exposure, Growth, continued to underperform Q4 and had a significant decline for the year. Positively, our second largest active exposure, Momentum, had a strong finish to the quarter and year, returning +33% in 2022.

Highland Large Cap Growth

Our Large Cap Growth strategy outperformed the Russell 1000 Growth Index for the 2022, although we slightly lagged the Index in the fourth quarter. For most of the year and quarter, the strategy has remained at the low end of its tracking error range. We have been actively neutralizing our value factor exposure since 2021, as our quantitative process typically underweights Value. This tactical move continues to be successful and has protected relative returns in an environment where Value factors have been performing well. Our largest active exposures, Growth and Momentum, largely offset each other throughout the year. In Q4, we were able to capitalize on November's sharp decline in the Momentum factor by tactically adding exposure within our quantitative process. This benefitted strategy performance throughout the remainder of the year. At the end of December, we returned our Momentum exposure to more typical levels, while increasing our tracking error and active Growth exposure. From a sector perspective, we performed best in Health Care and Consumer Discretionary. In Health Care, our quantitative model had strong security selection within the Pharmaceuticals industry group and its underweight allocation to Health Care Equipment added value. In Consumer Discretionary, both allocation and selection were positive. Energy was also a positive for the year, with our process identifying it as the strongest ranked sector after the Index rebalance in June. For the year, we had our worst performance in Communication Services and Consumer Staples.

Outlook

We believe this correction in the growth index will prove to be an excellent buying opportunity. While we still anticipate the Federal Reserve will continue to raise rates in 2023, there is no doubt the bulk of the heavy lifting has likely been accomplished. Many components of inflation have started to ease and M2 money supply growth has stalled. What does that mean for growth stocks? Valuation multiple compression should be significantly less of a concern this year. We do believe fundamentals will play a more significant role in driving stock performance in 2023, and while there may be some weakness; multiple sectors and industries within the growth index are still in early innings of long term secular growth. We remain convicted that our quantitative process will systematically put us in the best position to capture opportunities.

4Q22 Fixed Income Portfolio Manager Commentary

Total returns in the investment grade bond market were historically negative for 2022. The vast majority of the decline has been driven by the spike in interest rates. In 2022, continued upside surprises related to inflation led to a higher policy path for the Federal Reserve. The 10-year Treasury started the year yielding only 1.52% and increased over 230 basis points to finish at 3.88%. Interest rates were hiked seven times during the year starting in March with the smallest increase (25 basis points). All major bond indices produced negative returns with even the "safest" part of the market realizing losses over -3.75%. The broad bond market (Bloomberg Aggregate) lost -13% and it was the worst year for corporate bonds since at least 1974. Not helping matters, mutual funds saw sustained redemptions throughout 2022. Long-term bond funds and ETFs lost more than \$296 billion in assets under management which contributed to poor liquidity conditions for the majority of 2022. Municipal bond mutual funds experienced redemptions for seventeen consecutive weeks, bringing total outflows to more than \$90 billion (a twenty year record). Municipal bond issuance was down over 20% this year driven by a 50% drop in refinancing's as interest rates increased.

In December, the Federal Reserve raised its policy rate by 50 basis points to 4.25-4.5% and signaled their intent to lift its policy rate to 5.0-5.25% in early 2023. Both decisions were in line with market expectations. It was the seventh consecutive interest rate hike and pushed the federal funds rate to the highest level since December 2007. Changes to the FOMC statement were minimal and the Fed chose to signal its forthcoming policy stance through the Summary of Economic Projections. The Fed made wholesale changes to the summary of economic projections. Beginning with the dots (interest rate projections), the median 2023 dot increased to 5.125%. With the median 2023 dot rising by 50 basis points, the Fed's dot plot now projects 100 basis points of cuts in 2024. ***Chair Powell made it***

clear that the path forward remains data dependent. The Fed will continue to seek out a sufficiently restrictive policy stance while reiterating their commitment to bringing inflation back to 2%. A 50 basis point hike in February is still in play, particularly if we get another solid jobs report for December. The FOMC's median real GDP projections for 2022 were revised higher, a reflection of the economic rebound in the second-half of this year. However, at 0.5%, the median projection for 2023 suggests tepid expectations for economic growth next year.

The one central bank, Bank of Japan, which has remained dovish capitulated on December 20th. Bank of Japan was the last developed world holdout with a policy focused on rock-bottom interest rates. The Bank of Japan raised its cap on benchmark 10-year yield to around 0.5% from 0.25%, surprising the majority of fixed income investors. The policy change came after an increase in Japan's core inflation to a four-decade high reinforcing the case that the central bank needed to reduce monetary accommodation. Japan, the largest foreign owner of US Treasuries, generally was a net seller of foreign bonds over much of 2022 as the cost of hedging has turned the trade unprofitable. Japan sold \$162 billion of foreign debt, the vast majority being Treasuries, instead deciding to increase their purchases of Japanese government bonds by 20% year-over-year. In light of the aggressive global central bank tightening, the amount of negative yielding debt is only \$686 billion. Sharply down from a peak of \$18.4 trillion reached in 2020.

Higher interest rates have quickly filtered into the housing and consumer finance space. Mortgage rates are up over 300 basis points in the past twelve months causing housing affordability to deteriorate at the fastest clip in history. Affordability is 59% worse year-over-year, more than twice the affordability deterioration during the Global Financial Crisis. The average

dollar price of an agency mortgage was ~\$102 at the end of 2021 and dropped to \$83 in November, uncharted territory for a historically low volatility market. As mortgage rates hit their highest levels since 2001, thousands of mortgage employees have already been laid off at lenders including JPMorgan and Wells Fargo. Interest rates on credit cards increased approximately 300 basis points to 19% this year, according to Bankrate.com, the highest level in data going back to 1985. American consumers will end the year with about \$110 billion more in credit card debt compared to the end of 2021.

After the dramatic sell-off in 2022, the investment landscape offers many appealing options for fixed income investors. In years past, the opportunity set was narrowly defined within a few areas of the market. That is not the case as we enter 2023. Opportunities exist in every market. The general consensus views for 2023 are: the US will experience a recession in the next 12 months, the Fed is close to a policy “pivot”, inflation will quickly move back to 2% in the year and interest rates are fairly valued across the curve. ***Broad market consensus views rarely play out as intended.*** We believe the Federal Reserve will have a harder time pivoting, due to sticky areas of inflation mostly related to wage inflation.




Asset Allocation








Domestic Equity Sector Allocation vs. R1000



Domestic Equity Quarterly Sector Returns vs. R1000







Fixed Income Portfolio








