A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TEMPORARY EXEMPTION TO CERTAIN PROVISIONS OF THE SOUND CONTROL ORDINANCE, PURSUANT TO SECTION 26-199 OF THE CODE OF ORDINANCES, FOR DIGNEY YORK ASSOCIATES, LLC (FOR OWNERS OF THE CASA MARINA RESORT RENOVATIONS) FOR THE INTERIOR AND EXTERIOR IMPROVEMENTS PROJECT LOCATED AT CASA MARINA RESORT - 1500 REYNOLDS STREET FROM MAY 15, 2023, TO DECEMBER 1, 2023; PROVIDING CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the owners of the Casa Marina Resort (Casa Marina Owner, LLC are requesting an exemption to provisions of the sound control ordinance to allow certain licensed contractors, including Digney York Associates, LLC, to perform after-hours construction for the Casa Marina Resort Renovation project for the following day and hours:

Interior Work - Monday - Sunday, 24 hours per day

Exterior non-noise producing work - Monday - Sunday, 24 hours per day.

Exterior demolition & construction: Monday - Saturday, 8:00 a.m. to 7:00 p.m.

Sunday - 9:00 a.m. - 5:00 p.m.

WHEREAS, pursuant to Section 26-199 of the Code of Ordinances, notices were sent to property owners located within a 100-foot radius of the proposed waiver, and properly advertised at least five days prior to the date of the city commission decision to grant this temporary waiver of the sound control ordinance; and

WHEREAS, pursuant to section 26-199 of the Code of Ordinances the City Commission considered (1) the character and degree of injury to, or interference with the health, welfare and reasonable use of adjacent properties, (2) the social and economic value of the activity for which the temporary waiver is sought, and (3) the ability of the applicant to apply best practical noise control measures; and

WHEREAS, the Casa Marina Owner, LLC, will work with the contractor(s) and surrounding businesses to minimize noise disruptions during regular business hours; and

WHEREAS, the City Commission finds that authorizing a temporary waiver of certain sound control regulations will mitigate disruptions to local businesses, and thereby benefit residents and visitors to the City of Key West.

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That pursuant to section 26-199, a temporary waiver of certain sound control regulations contained in Section 26-193(3) of the code of ordinances, is hereby granted to Digney York Associates, LLC for the Casa Marina Resort improvements project.

Section 2: That the after-hours work to be conducted primarily includes, but is not limited to, demolition and construction of pavement, irrigation and utilities and landscaping, that may include the use of impact drills, welding devices, saws and heaving equipment with back-up alarms.

Section 3: That pursuant to Section 26-199, this temporary waiver may be revoked by the city manager or designee if there is (1) violation of one or more conditions of the temporary waiver; (2) material misrepresentation of fact in the temporary waiver application; or (3) material change in any of the circumstances relied upon by the city commission in granting the temporary waiver.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication

by the signature of the Presiding Officer and the Clerk of the Commission.
