-- Corey Genard Baker Jr Arrest Narrative:

On February 23, 2023, at approximately 1810 hours, an Off-duty Key West Police Officer contacted Key West Dispatch in reference a male who has an active arrest warrant. The male was identified as Corey Baker Jr., (dob:07/10/1995). Baker was near The Publix Supermarket, (3200 N. Roosevelt Boulevard). Baker was seen getting inside a vehicle bearing Florida registration Z216AC.

Sgt. A. Rodriguez, Ofc. Hesse, and I, Ofc. Lopez responded to the above-mentioned area. The vehicle Baker was in was traveling near the intersection of Kennedy Drive and Northside Drive. A felony stop was conducted on the vehicle Baker was in near the above-mentioned intersection.

Sgt. A. Rodriguez was standing on the front passenger side door of the vehicle. Sgt. A. Rodriguez instructed Baker to step out of the vehicle numerous times and Baker refused to follow his verbal commands. I went around Sgt. A. Rodriguez, and I grabbed Baker's left arm. I noticed Baker had the seat belt laying on top of his front body. However, the seat belt was unbuckled and there was nothing preventing Baker from stepping out of the vehicle on his own will. I pulled Baker out of the vehicle with the assistance of Sgt. A. Rodriguez.

Once Baker was standing out of the vehicle, Sgt. A. Rodriguez instructed Baker to lay on the ground several times. Baker refused to follow his verbal commands and started walking towards the sidewalk, willfully refusing and ignoring verbal commands to stop. I placed my right leg in front of Baker's leg, and I escorted him to the ground. While I was escorting Baker to the ground, Baker was tensing up his body and not complying with the instructions given by Sgt. A. Rodriguez. Baker continued moving his body as if he was attempting to turn his body around, (Facing us).

Once Baker was laying down on the ground on his stomach. Ofc. Hesse and Sgt. A. Rodriguez placed handcuffs on Baker. I searched Baker and then I placed him in the rear passenger side of my patrol vehicle.

This incident was recorded with my body worn camera, 3722.

I later transported Baker to The Monroe County Detention Center. My In-car Coban camera was activated during the transportation, 3722.

I noticed Baker had the seat belt laying on top of his front body. However, the seat belt was unbuckled and there was nothing preventing Baker from stepping out of the vehicle on his own will. I pulled Baker out of the vehicle with the assistance of Sgt. A. Rodriguez. Contrary to F.S.S. 843.02.

On Thursday, February 23, 2023 at approximately 1816 hours I, Ofc. J. Hesse, was dispatched to the area 3200 N Roosevelt Blvd. I, along with several other officers, was responding to the report of a male subject, Corey Baker, who was known to law enforcement to have an active felony warrant for his arrest. Per an off-duty officer at the location, Baker was observed walking out of the grocery store and heading eastbound through the lot on foot.

While en route, officers were notified Baker had gotten into an older gold colored sedan with black wheels, which was quickly found to be exiting the lot onto Northside Dr, heading westbound. At the intersection of Northside Dr and Kennedy Dr, a traffic stop was initiated on the vehicle that was occupied by two people. Axon BWC was activated at this time.

As I approached the driver's side of the vehicle with Ofc. Hernandez, the female driver was ordered to show her hands. After initially raising her hands, I observed the female, later identified as Mariah Lopez (8/12/2005) place her right hand back into the area of the center console of the vehicle. Lopez was order to again raise her hands and she complied. She was ordered to remove her seatbelt, which she did, and exit the vehicle however she did not comply. Lopez was removed from the vehicle by officers, relocated to a nearby patrol vehicle, searched with consent, and detained in handcuffs that were checked for proper fit and double locked.

Lopez was secured into my patrol vehicle, advised of her rights per Miranda, and advised of Axon recording in the car. Lopez was questioned about the incident and indicated she did not know Baker was wanted by police and did not know who the vehicle she was operating belonged to. Lopez told me the vehicle was lent to her and Baker to run to the grocery store by a "friend" with an unknown name on Stock Island.

Lopez was found not to have committed any crime and was released from custody a short time after detainment. Lopez contacted her mother, Jackie Lopez (11/27/1978) who arrived at the location to pick up her minor child. Jackie Lopez was informed of the events that had occurred and I provided her my contact information should she have any questions. I then completed the tow form for the vehicle to which I was unable to locate any responsible party in the local area. The vehicle was towed to Arnold's Towing yard.

This concluded my involvement in the investigation.
