

#### Safety & Vision Zero

- Free rechargeable lights are available to those in need and can be picked up from City Hall, the Police Station, and the Library. We are running low on headlights and bells but are expecting delivery shortly.
- Beginning the grant process for our City Wide Comprehensive Safety Action Plan. Once a contract is created, the plan is expected to take about one year to create.

- "Key West Rides" On-Demand Transit (ODT): soft launch since Nov 30. Hard launch date to be determined (once we discontinue the North and South Line service). Currently we are providing both services.
  - Average 112 riders a day
  - 4,018 App Installs
  - 22,542 received ride proposals; 13,490 Completed Rides



- Flagler Pedestrian Upgrades awaiting part order expecting completion after First & Bertha project
- Whitehead St target completion: Summer 2023
- S Roosevelt Blvd target completion date Spring 2025
- Keys COAST CV project target completion Summer 2023, configuration to state intersection traffic controllers being installed
