A RESOLUTION OF THE CITY COMMISSION OF THE WEST, CITY OF KEY FLORIDA, AUTHORIZING ON Α SOLE SOURCE PURSUANT TO SECTION 2-797(1) FOR BRAND NAME ITEMS IN ACCORDANCE WITH 2-844 OF THE CODE OF ORDINANCES AND SECTION 2-797(4)(B) OF THE CODE OF ORDINANCES THE ATTACHED PROPOSAL OF ALLIGATOR ALLEY HARLEY DAVIDSON IN THE TOTAL AMOUNT OF \$62,696.20 (\$31,348.10 PER UNIT) FOR PURCHASE OF TWO 2023 DAVIDSON POLICE ROAD KING MOTORCYCLES KEY FOR USE BY THE WEST POLICE DEPARTMENT TRAFFIC UNIT; **AUTHORIZING** TRADE-IN TWO USED OF UP TO HARLEY DAVIDSON ROAD KING TO MOTORCYCLES PURSUANT SECTION CODE 2-771(c) OF THE OF ORDINANCES, UPON NEGOTIATION, RECEIPT AND ACCEPTANCE OF Α **FAIR** AND **EQUITABLE** TRADE-IN DETERMINATION ON DAY OF TRADE, THE BY CITY/KWPD PROVIDING STAFF; FOR AN EFFECTIVE DATE

WHEREAS, the Police Department finds that Harley Davidson Road King Police motorcycles best meet department needs based on performance, rider training, maintenance and service history and, in conjunction with the purchasing agent, has determined that a name brand specification is necessary, pursuant to Section 2-844 of the Code of Ordinances; and

WHEREAS, City staff obtained price quotes from the three vendors, and determined that the quote provided by Alligator Alley Harley Davidson of Sunrise was the lowest price; and

WHEREAS, Alligator Alley will provide a trade-in offer on up to two 2019 motorcycles currently in use by the KWPD only on the day of trade. Accordingly, KWPD staff is requesting approval of up to two motorcycle trade-ins only upon receipt and acceptance of a fair and equitable offer, as determined by City staff; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached proposal for purchase from Alligator Alley Harley Davidson of Sunrise for two Harley Davidson Police Road King motorcycles, with accessories, in the total amount of up to \$62,696.20 (\$31,348.10 per unit), is hereby approved pursuant to Sections 2-797(1), 2-797(4)(b) and 2-844 of the Code of Ordinances.

Section 2: That the disposal (trade-in) of up to two obsolete City-owned 2019 Harley Davidson Road King motorcycles, is authorized pursuant to Section 2-771(c) of the Code of Ordinances. City/KWPD staff is authorized to negotiate, receive and accept (or refuse) a trade offer upon fair and equitable terms on the day of trade.

Section 3: That funding for this purchase is budgeted in account #101-2101-521-6400 for police department machinery and equipment for FY 22-23.

Section 4: That the City Manager or designee is authorized to execute any necessary paperwork, upon consent of the City Attorney.
