A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RENEWING FOR TWO YEARS THECONSTRUCTION **ENGINEERING** INSPECTION (CEI) SERVICES CONTRACTS WITH THREE (3) VENDORS, ORIGINALLY AWARDED IN RESOLUTION 20-057 RESPONSE TO REQUEST IN QUALIFICATIONS NO. 20-003; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 20-057 the City Commission approved three (3) firms to provide Construction Engineering and Inspection Services (CEI) for the City of Key West, and authorized the City Manager to negotiate three-year contracts with the option of a two-year renewal at the option of the City; and

WHEREAS, City staff recommends exercising the two-year renewal option for each firm; and

WHEREAS, one vendor, Cardno, Inc. has been acquired by Stantec, Inc., and City Commission approval of a corporate name change for that vendor has been approved in concurrent resolution on this April 18, 2023 agenda;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That contracts for CEI services are hereby renewed for a term of additional two years, upon mutually agreed terms for the following three (3) firms:

- (1) HDR Construction Control Corporation
- (2) RS&H, Inc.
- (3) Stantec, Inc. (formerly Cardno, Inc.)

Section 2: That the City Manager is hereby authorized to execute a two-year renewal upon agreed terms for each of the above-described contracts, upon the advice and consent of the City Attorney.

Section 3: Specific task orders issued pursuant to the contracts shall continue to comply with the City's procurement guidelines.
