A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(3) THE PURCHASE OF A S770 BOBCAT SKID-STEER LOADER IN AN AMOUNT NOT TO EXCEED \$86,983.18, FROM CLARK EQUIPMENT CO. THROUGH THE SOURCEWELL COOPERATIVE PURCHASING CONTRACT (SOURCEWELL) #040319-CEC, CITY OF KEY WEST MEMBER NUMBER 58115; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

WHEREAS, City staff recommends procurement of a S770 Bobcat Skid-Steer Loader through the Sourcewell Cooperative Purchasing Contract #040319-CEC; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a S770 T4 Bobcat Skid-Steer Loader, in an amount not to exceed \$86,983.18, from Clark Equipment Co. dba Bobcat Company is hereby approved, through Sourcewell competitive bid contract 040319-CEC, City Member Number 58115, pursuant to Section 2-797(3) of the Code of Ordinances.

Section 2: That funds of up to \$85,000.00 for this purchase are budgeted in FY 22-23 in General Fund/Public Works/Machinery and Equipment Account 001-1905-519-6400. The overage of \$1,983.18 will be covered by surplus from other purchased items coming in under budget within this fund. Any related budget adjustments and transfers are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents associated with this purchase, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage, adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
