## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE KEY WEST, CITY OF FLORIDA, AUTHORIZING AN INCREASE TO PURCHASING EXCEPTION PURSUANT TO SECTIONS 2-797(3) AND 2-797(4)(b) OF THE CODE OF ORDINANCES, TO ALLOW AN INCREASE NOT TO EXCEED \$30,000.00 IN CUMULATIVE ADDITIONAL EXPENDITURES DURING FY 22-23 TO TEN-8 FIRE AND SAFETY (FROM \$60,000.00 то \$90,000.00); AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$50,000.00; and

WHEREAS, in Resolution 22-224, the City Commission approved purchasing exceptions for a number of sole source and/or blanket purchase orders in excess of \$50,000.00, including Ten-8 Fire and Safety; and

WHEREAS, Ten-8 provides essential repairs and equipment for fire rescue apparatus; and

WHEREAS, to date the fire department has exceeded the budgeted \$60,000.00 for repairs, and staff advises that based on trends and equipment evaluations, additional funding in an amount of up to \$30,000.00 is necessary; and WHEREAS, the City Manager finds that pursuant to code of ordinances section 2-797(4)(b) best interest of the City, it is appropriate to adjust the amount of authorized expenditures previously approved, by increasing the purchasing exception for Ten-8 Fire and Safety by \$30,000.00, to a total of \$90,000.00 during FY 22-23.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>: That an increase to expenditures in the amount of \$30,000.00 is hereby authorized for Ten-8 Fire and Safety pursuant to Key West City Code of Ordinances sections 2-797(3) and 2-797(4)(b).

Section 2: That funds are budgeted in account 001-2201-522-4600. Any necessary budget transfers and adjustments to fund the increase are hereby authorized. <u>Section 3</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
