A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RANKING THE RESPONSIVE AND RESPONSIBLE RESPONSE TO THE REQUEST FOR PROPOSALS (RFP) NO. 23-001 FOR TRANSIT BUS ADVERTISING SERVICES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A CONTRACT WITH THE HIGHEST RANKED FIRM, FUEL MEDIA HOLDINGS, LLC, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY: AUTHORIZING **NECESSARY** ANY BUDGET ADJUSTMENTS OR TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS the City issued RFP 23-001 on March 17, 2023, requesting proposals for bus advertising services and on April 26, 2023, the City Clerk opened two responses to the RFP; and

WHEREAS, a Selection Committee of City staff, reviewed the proposals at a public meeting on May 3, 2023, and found that only one proposal was responsive and responsible. The Committee recommends award of the Proposal to Fuel Media Holdings, LLC; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That based upon the criteria set forth in RFP 23-001 for Transit Bus Advertising, the proposal of Fuel Media Holdings, LLC, is hereby highest ranked, as the responsible and responsive bid received.

Section 2: That the City Manager is authorized to negotiate and execute a contract with Fuel Media Holdings, LLC, in substantial conformance with the RFP, and as legally permissible pursuant to the City Charter, upon advice and consent of the City Attorney.

Section 3: Revenues from the Transit Bus Advertising program will be recorded in 411 Transit Cost Center Enterprise Fund. Any necessary budget adjustments or transfers are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
