On Thursday, December 8, 2022, at approximately 0748 hours, I (Detective Sergeant J. HAMMERS) was driving to the Key West Police Department when I heard Officer. R. HARTLE call out a traffic stop at 1816 Flagler Avenue. Officer R. HARTLE aired over Key West Communications Channel I that he was in need of assistance with an unruly driver. I responded to Officer R. HARTLE's location to assist.

Prior to my arrival, I overheard Officers note that the operator of the vehicle, later identified as BRAYAN CABRERA-PEREZ, was calling the 911 Emergency number while Officers were on scene. Key West Communications confirmed that CABRERA was calling 911 without a said emergency.

Upon my arrival, I observed CABRERA being verbally argumentative, threatening, and defiant towards Officers on scene. I retrieved K9 MANGO from my unmarked vehicle and affixed my six-foot nylon lead to the one and a half inch nylon collar K9 MANGO was wearing. I retrieved K9 MANGO from the rear of my patrol vehicle and approached the passenger's side front bumper of the stopped BMW. I gave K9 MANGO the command to sniff for narcotics and moved counter clockwise around the exterior of the stopped vehicle. I observed a noticeable change in K9 MANGO's normal behavior as we approached the driver's side door. K9 MANGO's body became rigid and his respiratory effort increased as he began scanning his nose along seam of the drivers side door. K9 MANGO took in several deep breaths and sat in front of the driver's side door. I secured K9 MANGO in the rear of my vehicle and I relayed the results of the K9 sniff to Officers on scene.

I began searching the interior of the vehicle while Officers continued to focus their attention on CABRERA's uncooperative behavior. I saw CABRERA repeatedly make evasive movements towards Officers M. ANDRUZZI and A. GAULFILLET. Officers M. ANDRUZZI and A. GAULFILLET attempted to place CABRERA into handcuffs due to his physical resistance to remain still while I conducted a search of his vehicle. Officers M. ANDRUZZI and A. GAULFILLET said CABRERA physically pulled away from their efforts to place him into handcuffs.

During my search of CABRERA's vehicle, I located a white round cigarette-like item in the center console (burnt). I recognized the item to be a "joint" commonly used to consume marijuana. I collected the item and field tested it. The contents of the "joint" field tested positive for marijuana (0.3 grams). I also located trace amounts of a white powdery substance on the passenger side seat. I field tested the substance which tested positive for cocaine. I continued my search and located several pieces of a dense white substance in the under sleeve of a compartment in the center console. I collected the substance and it field tested positive for cocaine. My body worn camera was not activated during this incident due to it charging at my office. All other Officers on scene were recording the interaction.

Detective Sergeant B. VAZQUEZ arrived on scene and conducted a check on CABRERA's medical marijuana status. Sergeant B. VAZQUEZ said CABRERA's Medical status was expired and had not been active since March of 2022.

I notified Officer R. HARTLE of our findings and left the scene. Officer R. HARTLE issued CABRERA a traffic citation for an equipment violation. After leaving the scene, CABRERA reportedly continued to demean Officers and complain about the stop.

I returned to the scene and noticed the collectable amounts of cocaine were still inside of the vehicle. Officer N. HOWELL and I placed CABRERA into handcuffs. I collected the FTP cocaine (0.01 grams), FTP marijuana (0.3

grams), and the drug paraphernalia (joint paper containing the marijuana. Officer N. HOWELL transported CABRERA to MCDC and Officer A. GAUFILLET towed the vehicle due to its use during the commission of a felony (possession of cocaine).

I processed, packaged and submitted all the evidence from this case into the Key West Police Department Property and evidence section. I completed an FDLE lab request form for the FTP cocaine to be analyzed.

Based on the fact that BRAYAN CABRERA-PEREZ did knowingly and intentionally physically resist Officers while performing their duties, probable cause exists he was in violation of Florida State Statue 843.02 - Resisting an Officer without violence.

Based on the fact that BRAYAN CABRERA-PEREZ was in sole possession of his own vehicle, he did knowingly and intentionally possess marijuana therein and without having a valid medical marijuana license, probable cause exists he was in violation of Florida State Statue 893.13(6)(b) - Possession of under 20 grams of marijuana.

Based on the fact that BRAYAN CABRERA-PEREZ did knowingly and intentionally possess a marijuana delivery device (drug paraphernalia), probable cause exists he was in violation of Florida State Statue 893.147(1)

Based on the fact that BRAYAN CABRERA-PEREZ was in sole possession of his own vehicle, he did knowingly and intentionally possess cocaine therein, probable cause exists he was in violation of Florida State Statue 893.13(6)(a).

Based on the fact that BRAYAN CABRERA-PEREZ did knowingly and intentionally call an emergency only communications number "911" while multiple Officers were on scene, probable cause exists he was in violation of Florida State Statue 365.172-14 - misuse of emergency communication services.

Andruzzi assisted me with the handcuffing. I placed a cuff on his right hand and Cabera-Perez would not let go of the items in both of his hands (cell phone & drink). Both items had to be pulled from his hands. Once the items were removed he began to resist being cuffed with his left hand. As we were handcuffing him he dropped to his knees and was handcuffed.

My AXON body cam as activated during the encounter and has been downloaded to the server.
