The City of Key West is requesting estimate:

To purchase and replant trees in existing planters on Caroline Street between Elizabeth and Grinnell Streets (see attached map and photos of planters). There are a total of 26 tree locations. The preferred tree species for each location is listed below. Substitutes will be accepted but must be included in the estimate.

All trees must be 45 to 65 gallon size (minimum 2 inches diameter each tree). Palms must be at least 8 ft of wood (trunk). Most of the planters have green island fiscus therefore, some plants will have to be removed in order to plant the trees but care must be taken to minimize the damage to the adjacent plants (or replace them).


