WHEREAS, in Resolution No. 17-207, the City

Commission approved a three-year contract with CH2M HILL,

Inc. for General and Utility Engineering Services, and in

Resolution No. 20-142 the contract was extended for twoyears; and

WHEREAS, CH2M Hill Companies, Ltd., the parent company of CH2M Hill Engineers, Inc., merged with Jacobs Engineering Group, Inc., and accordingly all subsidiaries of CH2M Hill Companies will be using the Jacobs logos and branding on work products; and

WHEREAS, CH2M Hill, now known as Jacobs Key West, will continue to provide engineering services to the City, including the same professional staff and equipment necessary to complete task orders in process and to be issued during the remaining term of the current General and Utility Engineering Services Contract.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby recognizes the merger of CH2M Hill Companies Ltd. with Jacobs Engineering Group Inc. and consents that the City's General and Utility Engineering Services Contract with CH2M HILL Engineers, Inc. shall be accepted under the name of Jacobs for the remaining term of the contract.

Section 2: That the City Manager is hereby authorized to execute any necessary documents, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.

### **ACTION STATEMENT**

Formally recognize the merger of CH2M Hill Companies Ltd. (CH2M) with Jacobs Engineering Group Inc. (Jacobs) and acknowledge CH2M's status as a wholly owned subsidiary and continue to execute task orders under existing contracts with CH2M.

### BACKGROUND

Per Resolution 17-207, the City of Key West City Commission approved the staff ranking for General Engineering Services. The city subsequently entered into a Professional Services Contract with CH2M on a task order basis.

On December 15, 2017; CH2M merged into and became a wholly owned subsidiary of Jacobs. After the merger, CH2M is fully operational and their existing contracts are unaffected by the merger and remain in full force. As a subsidiary of Jacobs, CH2M will be utilizing Jacobs logos and branding on their work.

The General Engineering Services contract with CH2M was extended for a two-year period per Resolution 20-142.

## **PURPOSE AND JUSTIFICATION**

With respect to the existing contract that the city has with CH2M, the corporate names Jacobs and CH2M are often used interchangeably within communication material (email, formal letters, etc.); however, CH2M is used on task orders to be consistent with the contract.

# MEMORANDUM

There has been some confusion internally as to which entity holds the contract. This action is intended to resolve any confusion on the subject and recognize the merger between Jacobs and CH2M but acknowledge that CH2M's contracts with the city remain in full force.

# **FINANCIAL ISSUES**

This action is administrative in nature and the existing contract with CH2M Hill, Inc. will remain in effect. All financial transactions related to the contract will continue to be processed with CH2M.

## RECOMMENDATION

Staff recommends formally recognizing the merger of CH2M Hill Companies Ltd. with Jacobs Engineering Group Inc. and acknowledge CH2M's status as a wholly owned subsidiary and continue to execute task orders under existing contracts with CH2M.
