On October 23, 2023, at approximately 1728 hours, I, Ofc. Lopez was dispatched to 934 Truman Avenue. The caller told Key West Dispatch her young daughter was approached by an adult male in a City bus.

I met with the caller, and she later identified herself as Zoila Ferrufino, (dob:10/05/1978). Zoila stated she has a 14-year-old daughter. Zoila's daughter is

Zoila stated her daughter has been attending the . Zoila indicated she has been taking advance classes at the college. Zoila stated her daughter informed her that a male has been talking to her while she is in the bus. Zoila's daughter said the male attempted to give her money a couple times. Zoila's daughter said she did not accept the money the unknown male tried to give her.

Zoila was told by her daughter the male left approximately \$5.00 in cash on the seat before leaving the bus one occasion. Zoila was told by her daughter the male left approximately \$3.00 to \$5.00 in cash the second occasion. Zoila was told by her daughter that she grabbed the money from the seat after the male exited the bus.

Zoila was informed by her daughter on October 19, 2023, (Last Thursday) the following. Zoila's daughter said she the same male began talking to her while they were riding the bus if she has said anything to her parents. Zoila's daughter told the male that she informed her parents about him talking to her. Zoila's daughter said the male then began asking her about her parents names and where do they live. Zoila's daughter said she became uncomfortable. and she began crying.

Zoila's daughter said that the female driver noticed her crying and she was asked if she was fine. Zoila's daughter said she told the female driver she was not fine. Zoila's daughter said the female told the male to stop what he was doing.

Zoila's daughter then sat close to the driver, and she began spoke with the driver for the remaining time until her final destination to School.

Zoila stated she was unable to report it Thursday. Zoila said she was able to make contact with an employee by the name of Rogelio at the Transit Department. Zoila stated that she informed Rogelio and Rogelio advised he was aware of the incident. Rogelio informed Zoila that the driver told him what happened. Zoila was told that male that tried to talk to his daughter is someone who is known to cause issues in the City bus. Zoila told me she asked Rogelio who the male is, and she was advised to to call the Police.

I asked Zoila when the male first initially began talking to her daughter and she said about two months ago. I asked Zoila how many occasions her daughter exchanged words with the male, and she said three different occasions. I asked Zoila at what bus station her daughter gets picked up, and she said on the 1000 block of Truman Avenue. I asked Zoila which bus station does the male normally gets picked up and she said she was unsure. However, it was somewhere in the downtown area. Zoila did not know where was the final destination for the male.

I asked Zoila if her daughter had a cellphone to call for help last Thursday and she said yes. I asked Zoila if she had a conversation with her daughter about calling the Police when she is in fear of a stranger talking to her, and she said she did have a conversation with her daughter. Zoila stated her daughter was nervous and emotional.

Zoila told me that during this week her daughter is not taking the City bus. Zoila stated she is paying someone to drive her daughter.
