ORDINANCE NO. ____24-04

AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AMENDING CHAPTER 14 OF THE CODE OF ORDINANCES ENTITLED "BUILDINGS AND BUILDING REGULATIONS", ARTICLE I ENTITLED "IN GENERAL", SECTION 14-2 *``APPLICABLE* FEES" ENTITLED TO AMEND ADMINISTRATIVE SERVICE, BUILDING, MECHANICAL, ELECTRICAL, PLUMBING, AND AFTER THE FACT PROVIDING PERMIT FEES; FOR SEVERABILITY; PROVIDING FOR REPEAL OF INCONSISTENT PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Key West promotes the health, safety, and welfare of citizens and visitors through building permit review and inspection of permitted construction as provided by the Florida Building Code; and

WHEREAS, administrative building services such as plan review and inspection provided by the City are engaged at the discretion of applicants and for the benefit of the applicant; and

WHEREAS, fees collected from the Building Department's administrative services and building permit fees are utilized to enforce the Florida Building Code; and

WHEREAS, the City Commission finds that it is in the best interest of the public to increase costs for building services, placing the burden of such costs directly upon those parties deriving the benefit from such services; and WHEREAS, the proposed amendments to Chapter 14 will promote the health, safety, and welfare of the citizens and visitors of the City of Key West by increasing revenue allocated for the enforcement of the Florida Building Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA:

<u>Section 1</u>: That Section 14-2 entitled "Applicable Fees" of the City of Key West Code of Ordinances is hereby amended as follows*:

Sec. 14-2. - Applicable fees.

Certain fees are applicable to all articles of Chapter 14 or otherwise have broad application. Accordingly, the office of the chief building official shall charge and collect for the following services at the following rates:

Administrative Fees

 (a) Inspection after normal business hours, with three-hour minimum and a partial hour shall be rounded up, per hour..... \$100.00 70.00

- (b) Time-specific inspections schedule during normal working hours, per inspection\$70.00

 - (2) Second re-inspection\$50.00
 - (3) Three or more re-inspections, each\$100.00
- (d) Requested courtesy inspection, each\$70.00
- (e) Permit extension of an active permit only for 180-days without inspection approval\$150.00 70.00
- (f) Reinstatement of expired permit for purpose of final inspection, each\$250.00 100.00
- (g) Replacement permit card\$25.00 residential

\$50.00 commercial

- (h) Change of contractor\$100.00
- (i) Permit application review/processing fee: 0.1% of contract price with a minimum fee of \$10.00 per application.

Florida DBPR surcharge is 1.5% of total permitting fee, minimum\$2.00.

Florida DEO surcharge is 1.5% of total permitting fee, minimum\$2.00.

- (j) City education fee for the training and recertification of building department staff pursuant to Florida Statutes, per permit\$2.00
- (k) Certificate of Completion\$100.00
- (1) Certificate of Occupancy:

- (m) Conditional Certificate of Occupancy, per any portion of90-day period\$250.00

After-the-Fact Penalty

In the event that any work for which a permit is required is commenced or is in process prior to the issuance of a permit by the building department, then the fees specified for such work shall be increased.

The payment of a penalty fee shall not relieve any person from fully complying with the requirements of any applicable code.

Penalty fees:

- (a) First \$5,000.00 contract price: \$250.00
- (b) > \$5,000.00 contract price: Double the permit normal fee

Section 2: If any section, provision, clause, phrase, or application of this Ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, the remaining provisions of this Ordinance shall be deemed severable therefrom and shall be construed as reasonable and necessary to achieve the lawful purposes of this Ordinance.

<u>Section 3</u>: All Ordinances or parts of Ordinances of said City in conflict with the provisions of this Ordinance are hereby superseded to the extent of such conflict.

Section 4: This Ordinance shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
