

**RESOLUTION NO. 24-017**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING “USA ENDURANCE EVENTS OF S.D.” TO CONDUCT A ‘USA WOMEN’S HALF MARATHON KEY WEST’ STARTING AND ENDING AT MALLORY SQUARE ON SATURDAY, FEBRUARY 24, 2024, FROM 6:00 A.M. TO 1:00 P.M; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 6:00 A.M. TO 8:00 A.M; AUTHORIZING THE SALE AND/OR CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PURSUANT TO TERMS AND CONDITIONS SET FOR BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** The USA Endurance Events of S.D. is hereby given permission to conduct the “USA Women’s Half Marathon Key West” on Saturday, February 24, 2024.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida.

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law.”

**SECTION 2.** That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/lessee/licensee/contractor therefore commits to refrain from the use of distribution of single-use polystyrene/plastic items, including but not

limited to single-use polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City.”

**SECTION 3.** That permission is hereby granted to conduct the “USA Women’s Half Marathon Key West” on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That the “USA Women’s Half Marathon Key West” is hereby granted permission for the closure of certain streets throughout the city for the Half Marathon on the date and during the hours stated above. That the “USA Women’s Half Marathon Key West” will depart from Mallory Square and return on Saturday, February 24, 2024.

**SECTION 5.** That the “USA Women’s Half Marathon Key West” will be coordinating with the Key West Police Department for the event.

**SECTION 6.** That the Event organizers will adhere to the recycling plan of the city of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 7.** That the event organizer shall use spray chalk or another readily removable substance for all course markings placed on public property.

**SECTION 8.** That “USA Women’s Half Marathon Key West” is hereby granted a Special Event Permit under Section 6-86 of the Code of Ordinances for an event that will take place and herein described.

**SECTION 9.** Pursuant to Section 18-86 of the Key West Code of Ordinances, the “USA Women’s Half Marathon Key West” is hereby granted permission allowing the consumption of

alcohol beverages within the enclosed area.

**SECTION 10.** That the “USA Women’s Half Marathon Key West” must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

**SECTION 11.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
