RE: Written Reprimand

Sergeant Rodriguez, on December 27, 2023, you had an adversarial citizen contact when dealing with a parking violation. You failed to call out the parking violation on the radio and you also failed to call out that you were dealing with an adversarial citizen. Other than the parking tickets, there was no documentation that this violation occurred. This is both dangerous and goes against General Order 02.01.04.06 paragraph A – Performance Standards.

Additionally, you failed to activate your BWC in violation of General Order 06.28.01.02 paragraph A and C – Body Worn Camera. The reason for this is you were unable to utilize your BWC was because the battery had died over a week before this incident. You also did not charge your BWC for almost a week after this incident when you were told to do so.

Any further violation of KWPD policies or procedures could result in progressive discipline.
