A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RENEWING FOR TWO YEARS THE ENVIRONMENTAL ENGINEERING SERVICES CONTRACTS WITH FOUR (4) VENDORS, ORIGINALLY AWARDED IN RESOLUTION 20-039 IN RESPONSE TO REQUEST FOR QUALIFICATIONS NO. 20-002 FOR CITY OF KEY WEST ENVIRONMENTAL ENGINEERING SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 20-039 the City Commission approved four (4) firms to provide Environmental Engineering Services for the City of Key West, and authorized the City Manager to negotiate three-year contracts with the option of a two-year renewal at the option of the City; and

WHEREAS, City staff recommends exercising the two-year renewal option for each engineering firm; and

WHEREAS, one vendor, E Services, Inc. has been acquired by Resource Environmental Solutions (RES), and City Commission approval of a corporate name change for that vendor has been approved in concurrent resolution 23-051 on this March 7, 2023 agenda;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That contracts for environmental engineering services are hereby renewed for a term of additional two years, upon mutually agreed terms for the following four (4) firms:

- (2) Atkins North America, Inc.
- (3) GHD Services, Inc.
- (4) Resource Environmental Solutions, LLC (RES) (formerly E Sciences, Inc.)

Section 2: That the City Manager is hereby authorized to execute a two-year renewal upon agreed terms for each of the above-described contracts, upon the advice and consent of the City Attorney.

Section 3: Specific task orders issued pursuant to the contracts shall continue to comply with the City's procurement guidelines.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
