A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF FIVE (5) 2024 FORD F-250S AND ONE (1) 2024 FORD MAVERICK CREW CAB WITH RELATED ACCESSORIES IN AN AMOUNT NOT TO EXCEED \$373,160.44 FROM DUVAL FORD LLC, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA23-VEL31.0, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE COMMUNITY SERVICES **DEPARTMENT**; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contracts; and

WHEREAS, this purchase will be made under the Florida Sheriffs Association Contract No. FSA23 - VEL31.0, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of five (5) 2024 Ford F-250s and one (1) 2024 Ford Maverick Crew Cab with related accessories as described in the attached proposal of Duval Ford LLC, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association Contract No. FSA23-VEL31.0, in an amount not to exceed \$373,160.44, is hereby authorized for use by the Community Services Department.

<u>Section 2</u>: That funds for the purchase of this equipment are budgeted FY23-24 in General Fund/Public Works/Machinery and Equipment account 001-1909-519-6400, General Fund/Parks and Recreation/Machinery and Equipment 001-7201-572-6400, and Truman Waterfront/Park Operations/Machinery and Equipment 105-7202-572-6400. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
